The East Goshen Township Conservancy Board met for their regularly scheduled meeting on Wednesday, October 14, 2009, at the East Goshen Township Building. Board members present were: Chairman Jane Fava, Bryan Delmonte, Mark Kawecki, Sandy Snyder, Walter Wujcik, Ginnie Newlin and Scott Sanders. Also in attendance were Mike Merwin, Bob Huebner (Park & Recreation), and Joe Zug (Historical Commission).

1. CALL TO ORDER

Jane called the meeting to order at 7:00pm and led the Pledge of Allegiance to the Flag.

2. REVIEW & APPROVAL OF MINUTES

Ginnie moved to accept the minutes of September 9, 2009 as corrected. Walter seconded the motion. There was no discussion or public comment. The motion passed.

3. EXPENSES

4. OLD BUSINESS

- A. Buffer Ginnie wrote letters to the Planning Commission and Board of supervisors proposing that the riparian buffer be increased to 100 feet. Ginnie, Jane and Bryan attended the Board of Supervisors workshop last night. Rick Smith distributed maps that showed the areas where this would apply. However, it was pointed out that this would also impact re-development. Marty asked that the Planning Commission review the proposal.

 B. "Y" Trees The Board of Supervisors asked for a report. Jane provided a report that listed the concerns the Conservancy Board had with the contractor.
- C. East Boot Road & Township Building Landscape projects At the Board of Supervisors Workshop last night, Ginnie, Jane and Bryan attended the meeting and got approval from the Board of Supervisors to get the \$300 plan from Tony DuFour of Wm. D. Wells Landscaping.
- D. Pavilions at the "Y" Board members made a site visit and took pictures. The amphitheater is in a clearing near the water. It is not a "structure" and can easily be removed and put back in place. Mark Gordon is checking the land development plan regarding this. Rick stated that the wood chips provide stability. The Board of Supervisors asked for recommendations from the Conservancy Board. Ginnie will write a letter stating that the Board wants the understudy replaced using native plants.
- E. Newsletter Ginnie complimented Bryan on his article.
- F. Grasses at Reservoir Road Board members did a site visit with Brian O'Niel of Weeds, Inc. This is clump grass, which will fill in all spaces in 2 to 5 years. Brian gave the Board recommendations for cutting the grasses.

5. **NEW BUSINESS**

- A. Budget There will be no budget for 2010. Jane and the Board started to make a list of items that will need to be paid.
- B. Thorncroft Drive A resident from Hunt Country called Rick. The Civic Association maintains the entrance and is not satisfied with the trees and ground cover. They would like recommendations from the Conservancy Board. Scott is familiar with this entrance a recommends that they remove the flowering crabapple trees and replace them with conifers and mulch. He will get in touch with the resident.
- C. Natural Lands Trust Bryan reported that Thom Clapper is the township representative on COG (Council of Governments). The NLT wants to work with municipalities to manage invasives. There will be a meeting at the East Goshen Township Building at 10:00 am on October 21, 2009 to discuss potential grant opportunities. Bryan and Ginnie will attend.





Dear Rick:

It was nice to meet you and the members of various East Goshen boards and committees yesterday. As I mentioned during our meeting, Natural Lands Trust recently received funding from the Pennsylvania Department of Environmental Protection Environmental Education Grants Program to offer Stewardship Assessments <u>free of charge</u> to a select group of municipal landowners to encourage ecologically sound stewardship practices in regionally important natural corridors. We are pleased that you are interested in a Stewardship Assessment for Applebrook Park in East Goshen Township and we will be contacting you shortly to schedule a site visit.

A Stewardship Assessment serves as a guide to the natural areas on a site: what plants and animals live there, how the soils, water, geology, and land use history shape what you see, what issues may be impacting the natural integrity of the site, and how to address these impacts. The Assessment offers stewardship recommendations that are based on best management practices and our experience in the stewardship of Natural Lands Trust preserves. Our recommendations highlight approaches and techniques that will enhance the landowner's conservation priorities – whether they include improving the water quality of a creek, installing a walking trail, enriching songbird habitat, advancing educational opportunities, reducing maintenance costs, or simply providing a sanctuary that can be shared by wildlife and people.

On-site information for the Stewardship Assessment will be collected during a 2-3 hour visit by David Steckel and me. We encourage you and other representatives from the municipality to join us during this visit to discuss the conservation priorities for the property. We will prepare a 5-10 page report with photographs of pertinent natural features on your land and a description of key stewardship issues and opportunities. One copy of Natural Lands Trust's *Stewardship Handbook for Natural Lands in Southeastern Pennsylvania* (2008) will be included with the final report. We also offer municipalities either a final presentation or walk through the site once the Stewardship Assessment has been completed to review our recommendations and address any questions.

If this is agreeable to you, please sign in the space below and return this letter to me at your earliest convenience. We look forward to working with you in advancing your conservation priorities for Applebrook Park.

On October 7, 2009 I inspected the referenced project site. This inspection was conducted in a similar manner to previous inspections, i.e. by walking along all installed plantings to observe their condition. Members of the East Goshen Conservancy Board were in attendance.

The following describes my The weather on this date was sunny and warm. observation and findings categorized by general site area:

- Trees around the detention pond. A.
 - The basin bottom continues to be maintained as a mowed "lawn" area. 1.
 - Several white pines are exhibiting partial yellowing with brown needle tips. 2.
 - Guy wires were observed on several white pine trees and should be 3. removed.
 - Two white pine trees were dead found along north side adjacent to lot 4.
 - All other observed pine trees are alive and appear to be in acceptable 5. growing condition.

- B. Screen planting on constructed graded berms, along Route 352 to and along Forest Lane.
 - The mix of trees and shrubs along the berms are growing vigorously and are achieving significant size. Numerous deciduous trees have achieved caliper sizes to circa 14" to 16". A few trees were observed with vines or poison ivy following up the trunks and thru branches.

Specifically, two dead trees were found. One dead Maple tree (between lots 31 and 32 and one dead Spruce tree behind lot 29. Replacement trees should be located in open areas and not at their current locations due to the density of existing plantings.

Guy wires should be removed from any and all trees. I found one additional tree at the intersection of Rt. 352 and Forest Lane with wires. At this same location I found one dead White Pine tree.

C. Northern End

1. As stated in our previous letter, plantings are not observable because most if not all areas are becoming overgrown and unwalkable. This area is reverting back to a natural wooded area buffer. No attempt to walk through this area was made for this inspection.

D. General Comments

1. The walking trail has not been maintained as a viable community resource, especially in locations where the trail passes through existing wooded areas. In some areas the trail is completely non-passable. (Statement continued from prior letter.)

2. With the few exceptions noted above, all plantings appear to be growing in horticulturally acceptable condition. This is especially true along the Route 352 and Forest Lane graded berms where trees and shrubs have achieved fairly large sizes.

I am herewith noting that the large size of trees in these areas will begin to have a negative effect on species requiring sunny locations. These conditions are already observable. The homeowners association may want to consider selective thinning to maintain a healthy screen planting.

- E. Comments noted by Conservancy Board Members:
 - 1. Invasive vines and vegetation are not being controlled especially within the conservation area.
 - 2. The walking path should be kept in a walkable and maintained condition.
 - 3. The detention basin bottom should be maintained as a wetland meadow, i.e. mowing should occur bi-annually to support the growth of the various seeded species unique to this habitat. (Note: To create the originally intended wetland meadow would now require seedbed preparation and seeding.)

Note: These statements, continued from prior letter were again noted by the Board during this annual inspection.

At their meeting on February 20, 2007 the Board of Supervisors authorized the Chairman to execute the 36 month maintenance bond for the landscaping at The Reserve at Spring Meadows and the release of the balance of the funds currently being held in escrow with the following conditions:

- 1. An annual inspection shall be made during each year of the bond period by the Township Engineer, in conjunction with the Township's Conservancy Board, a representative from the Homeowner's Association and a representative from Gambone Brothers.
- 2. This inspection shall occur after the trees have had a chance to "leaf-out" (on or about June 1st of each year).
- 3. A list of deficiencies shall be prepared by the Township Engineer.
- 4. This list shall be forwarded to all parties.
- 5. Gambone Brothers shall install the replacement planting during the next favorable planting time in that particular year.
- 6. Since the bond will expire on February 20, 2010 a semi-final inspection shall be made on or about September 15, 2009 in anticipation of the bond period expiration.
- 7. Gambone Brothers shall install any replacement plantings by October 30, 2009.
- 8. A final inspection shall be made on or about February 10, 2010 and any required replacement plantings shall be installed by May 31, 2010.

At the meeting the solicitor for the Gambone Brothers indicted that these conditions where acceptable.

At your last meeting, you requested the Conservancy Board to recommend measures and species for the restoration of the woodlands cleared by the YMCA in the area between their wall and the Chester Creek. We are happy to do so.

The woodchips spread in this area to prevent re-growth of the cleared woodland should first be removed, the ground then prepared for planting and understory trees and bushes installed. A list of some suitable species follows:

Birches, including river birch

Hornbeam

Shadbush

Dogwoods, gray and flowering

Common Spicebush

Arrowwood;

Ninebark

Bayberry

Nannyberry

Highbush Cranberry

Chokeberry

Winterberry
