The Delaware Riverkeeper Network's Environmental Excellence Awards

To celebrate our first 25 years, the Delaware Riverkeeper Network (DRN) is recognizing exceptional environmental efforts undertaken by local governments throughout the Delaware River Watershed.

Since 1988, the Delaware Riverkeeper Network (DRN) has championed the rights of the River to be free-flowing, clean and healthy. From the Highlands to the Bay, DRN gives voice, strength and protection to the communities and waterways of the Delaware River. Through independent advocacy, and the use of accurate facts, science and law, DRN works to ensure the rich and healthy future that can only exist with a clean, healthy and free flowing river system.

To mark 25 years of working locally, DRN is looking to recognize the work that communities have undertaken to protect and restore the environment. We will be showcasing projects from each of the four Delaware River Watersheds states: New York, New Jersey, Pennsylvania and Delaware.

Local governments are invited to nominate their work for consideration. Has your community undertaken an effort to protect and restore the environment about which you and your neighbors are proud? If so, consider working with your municipality to nominate that effort. Possible efforts may include (but are not limited to):

- Environmental Advocacy and Leadership
- Protecting Communities from Energy Extraction and/or its Infrastructure
- Model Ordinance Adoption
- Green Infrastructure
- Stormwater Management
- Erosion and Sediment Control
- Streambank Buffer Protection and Restoration
- Stream Restoration or Daylighting
- Floodplain Restoration
- Dam Removal or Fish Passage
- Open Space Protection
- Low Impact Development
- Alternative Wastewater Systems
- Outreach & Engagement
- Studies and Planning
- Water Quality or Quantity Modeling
- Mapping and Geographical Information Systems

Nominations will be evaluated by the DRN staff, Board and Advisory Board. Awards will be presented locally. The special recognition that selected municipalities will receive includes: A framed Certificate of Commendation; a letter from the Delaware Riverkeeper; and Acknowledgement in DRN's Environmental Excellence Awards publicity. Certificates will be presented personally by the Delaware Riverkeeper.
