6 7 8 9	<u>Present:</u> Chairman Al Zuccarello, Vice Chairman Donald Zembruski, and members Jon Altshul, Elena Coarse, Vincent Lord, Daniel Callahan, John Stipe, Supervisor Marty Shane and Zoning Officer Mark Gordon. Member Bob Madonna was absent.
10 11 12 13	Call to Order/ Pledge of Allegiance/Moment of Silence Al Zuccarello called the meeting to order at 7:00pm. He also led the Pledge of Allegiance and called for a moment of silence for our military troops.
14 15 16 17	Minutes of February 8, 2012 There were no changes proposed to the draft minutes. Al Zuccarello announced the minutes would stand approved as submitted.
18 19 20 21	General Discussion Marty Shane announced the Township has extended an offer and it has been accepted. Mr. Jon Altshul will be the new Chief Financial Officer for the Township.
22 23 24	Al informed the commission of the resignation of Noel Hedgecock from the CDC; Noel and Megan are moving out of East Goshen.
25 26 27 28 29	Marty also discussed a topic he learned of at the most recent Chester County Planning Commission meeting: The SEPTA RT. 92 Bus will be going through some changes shortly. SEPTA has scheduled a public hearing to discuss these changes on April 17, 2012 at 3:00 PM. The public hearing will be held at Main Hall at West Chester University.
30 31 32 33 34 35 36	Iron Hill Criterium Al Zuccarello provided an update on his discussions with Mark Yoder of the Greater West Chester Chamber of Commerce with regard to the request to use Enterprise Drive within the Goshen Corporate Park (GCP) to hold the Iron Hill Criterium time trial races. Al has communicated the commissions' concerns with the request to Mr. Yoder. The commission had a general discussion regarding these concerns and Vince made the following motion:
37 38 39 40 41	Mr. Chairman, I move that we recommend that the Board of Supervisor deny the request by the West Chester Chamber of Commerce to use Enterprise Drive on July 7, 2012 to hold the Iron Hill Criterium bicycle race time trials. This recommendation is primarily based on the number of unresolved issues and logistical challenges surrounding vehicle access to the business park during these races and the parking needs for the event.
42 43 44 45 46	The motion was seconded by Jon Altshul. The Commission discussed the motion. The motion was voted on and passed unanimously. Mark Gordon will write a recommendation letter to the Board of Supervisors to that effect. The commission is supportive of the idea and may be better prepared to help in upcoming years.
