Present

On March 25, 2014 was the first meeting of the Futurist Committee. Rogers Vaughn, Luann Petrellis and Thomas Kilburn who are the committee members attended. Also in attendance were Board of Supervisors Chairman, Marty Shane and Vice Chairman, Senya Isayeff.

Call to Order

The meeting was called to order at 7:00 p.m. by Marty Shane. The meeting began with the Pledge of Allegiance and there was a moment of silence for our military troops.

Welcome to Futurist Committee

Chairman, Marty Shane welcomed members Rogers Vaughn, Luann Petrellis and Thomas Kilburn who will serve on the Futurist Committee.
