There are a few areas such as the Goshen Fire Company grounds and the 18 corporate park that may add additional money to the Township financial base. Current retail space can 19 be redesigned to allow additional retail businesses in the Township 20 Housing Requirements: Most of the Township is built out. The Township will have older homes since 21 the Township is now built out. What type of building codes should be adopted that addresses the 22 handling of older homes? Mr. Kilburn went into the Township's website and noticed that the 23 demographic age for the Township residents will be increasing. Mr. Vaughn mentioned that Chester 24 County has very good schools and that is very helpful for prospective home buyer who would like to 25 move into East Goshen Township. West Chester Area Schools District has very good schools. Young 26 working people should be encouraged to move into East Goshen Township which has wonderful 27 recreational areas, good school system and excellent neighborhoods. 28 Recreation and Community Facilities: People are looking forward to a community style living with bike 29 paths, parks, restaurants, and gathering places.
