THE TIME HAS COME TODAY

In the summer of 2012, I wrote an article for the East Goshen Township Newsletter that was titled *Something Wicked This Way Comes*. To many readers, that may have reminded them of the title of one of the novels by science fiction writer, Ray Bradbury. The intended use that I had in mind was the invasive insects that we have been plagued with as part and parcel of international trade with China and other ports of call.

We have had serious issues with the 'Stink' bug, the Asian long-horned beetle and the Emerald Ash Borer (EAB). The EAB was first discovered in the upper portion of Michigan where it is believed that the larval stage insect came to the Great Lakes in wooden packing crates. It spread northwards into Canada and south into the mid section of our country. This was 2002, but the insect had probably been present for some time before it was identified by entomologists. To date, it is estimated that we have lost nearly 50,000 trees. The insect was first discovered in Western Pennsylvania in 2007 (Allegheny and Butler Counties). By June of 2008 it had reached Mercer County. In 2009 it was in Mifflin and Westmoreland Counties. This year it is in Chester County!

Homeowners can utilize a 'soil drench' for their Ash trees. This type of pesticide uses the tree's systemic nature to absorb the chemicals through the root system and carries it through the 'pipeline' just under the bark of the tree and up into the canopy. Some of these chemicals have a protective time table of two years. Bayer (yes, they make more than Aspirin) is the manufacturer of one popular brand with their Bayer Advanced Tree and Shrub Insect Control. The active ingredient is Imidacloprid, and this ingredient is commonly found in many of the injectable types of control. The good part of using a soil drench is that you do not need to go through a contractor to treat your trees. If you have an arborist who cares for your trees, I think that an excellent product would be Tree-Age (Emamectin benzoate) which is a controlled substance and needs to be administered by a professional arborist.

The classic signs might be found in trees that are already stressed. Stress can be produced by spells of severe cold weather droughts, 'girdling' roots (roots that cross over the base of a tree and decrease the flow of nutrients to the uppermost portions of a tree) and a number of other factors. A few signs that I have mentioned in a previous article would be an influx of woodpeckers in your Ash trees, 'dieback' of the top and end branches that result in epicormic growth (sucker growth) in the central areas of the trees. Also, in the first areas of the tree's trunk, you can look for the exit holes that the insects make as they leave. The EAB has a distinct 'D' shaped exit hole. Most other borers that I am familiar with have a circular exit hole.

Whether you choose to treat the trees yourself or have a professional perform the task, you need to know that NOW is the time for effective application!! The Chamber's Brothers said it quite well "The time has come today."

Commerce Commission

The Commerce Commission (CC) has been actively soliciting input from the owners and principals of retail stores and professional offices within the Commercial zone shopping districts, as well as the corporations residing in the Industrial and Business Park zones for the CC's fall Business Forums. East Goshen Township's Board of Supervisors (BOS) created the CC in January 2012. Its mission is to be the advocate of the businesses residing within the Township, and to advise the BOS on issues pertaining to the help or services that can be provided to these key constituencies of East Goshen Township.

To that end, after all of the inaugural year's organization and fact finding pertinent to these enterprises, we held forums in the fall of 2012 from which Township was able to act on a number of suggestions and requests of the business entities. This also resulted in the compilation of a Business Directory on the Township's website (www.eastgoshen.org) an easy guide to locating our Township businesses. Their success is the Township's success.

The Township Comprehensive Plan 2015 is underway, and a Task Force was created earlier in the year to aid and assist in the formidable undertaking of updating the 10 year Comp Plan, as mandated by PA law. The Planning Commission usually guides the process with the Board of Supervisors and with input from the Authorities, Boards, and Commission members. This year, Brandywine Conservancy, with the assistance of Triad Associates is guiding the process, with input and oversight from the Board of Supervisors, Township staff, and Authority, Board and Commission members. The Commerce Commission's input for the Comp Plan will be heavily weighted by our businesses: their voices, opinions, and visions of how they can remain viable, active, and thriving for the next 10, 15, even 20 years are critical for the Township's continued success.

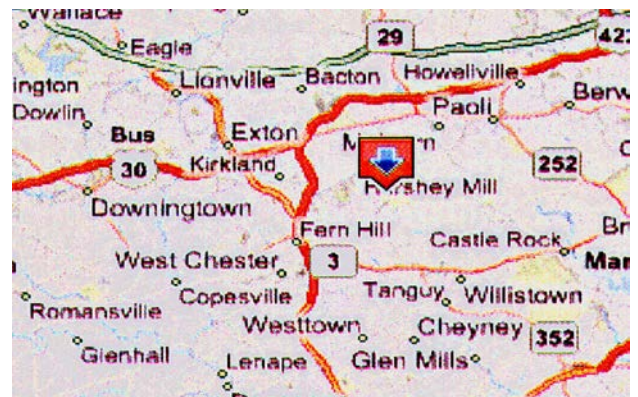
Cloud (East Goshen Township incorporated in 1817) Jan 20 1881 to Aug 15 1899 & Oct 18 1899 to Dec 30 1899

Cloud Post Office was located at Rocky Hill and a map shows the Post Office on the SW corner of the road known then as Route #160. Rocky Hill was listed with a population of only 30 people in 1890 but the surrounding East Goshen Township area was shown with 150 persons. On January 20, 1881 Thomas H. Smedley became its first Postmaster.

The other Postmasters during the 18 years of existence were: Millard F. Smedley, appointed September 16, 1884; Bernard Hawley, appointed March 27, 1886; John H. Davis, appointed April 16, 1890; and finally Lizzie G. Davis, appointed April 25, 1890.

The P. O. was discontinued in 1899 and then briefly opened again in 1899 with Postmaster M. Fillmore Smedley. After December, 1899 the mail was handled by the West Chester Post Office.

Located east of West Chester borough, East Goshen Township is a 10-square mile area that was part of a larger tract purchased from William Penn in Wales in September 1681. Settlers named the area Goshenville, or "Land of Goshen." Many of the first settlers were Swedes and Dutch. These settlers created a fully self-sufficient agricultural community with the establishment of grist mills in the area of the village of Goshenville to grind their grain and the development of the Chester Road to take their produce to sell or trade. The first Quaker Meeting was built at the crossroads of Paoli Pike and Chester Road in 1702, which later became known as the village of Goshenville. The adjacent communities of Milltown, Rocky Hill, Hershey's Mill and Dutton Mill were established around the grist mill operations in the township. *By 1883, the township had three post offices in Goshenville, Milltown and Cloud (at Rocky Hill).*

The Citizens Police Academy is a program that is designed to give citizens a better understanding of the operations of the police department, the services that it offers, and its officers. The twelve week program covers topics such as patrol, criminal investigations, the court system, traffic enforcement, accident investigation and reconstruction, CPR and first aid, community policing, and the 911 Operations Center. The Citizens Police Academy, which had not been offered by the department since 2007, gives residents an “insider’s view” of the department through hands-on demonstrations of the investigative techniques and procedures, weapons, vehicles, and equipment utilized by the officers. The Citizens Police Academy class will graduate on November 20, 2013. We hope that the class participants enjoyed the class as much as the police officers did!

Odds & Ends from Rick Smith, Township Manager

On July 2, 2013, the Pennsylvania Department of Environmental Protection (DEP) approved the County Wide Stormwater Management Plan for Chester County. As a result, each municipality in Chester County will have to update its stormwater management regulations to bring them into compliance with the requirements set forth in the plan. The new requirements will reduce the adverse effects of stormwater runoff from new impervious surfaces such as driveways, roof, and deck. The Board of Supervisors must adopt the new requirements prior to January 2, 2014.

The Township is installing two new LED signs that will replace our exiting changeable letter signs. One sign will be at the intersection of Boot Road and Paoli Pike and the second at the Township Park. The new signs will be controlled from the Township Building and they will allow us to provide timely notice of meetings and events.

We frequently receive calls at the Township from residents asking for a recommendation for a contractor to make some type of home improvement. While it would be inappropriate for us recommend a specific contractor we do recommend: 1) that you obtain more than one proposal, 2) that you ask for references, and 3) that you contact the references. Remember, **“It’s your money”**.
