The East Goshen Township Historical Commission held its regularly scheduled meeting on Thursday, October 8, 2009 at 7:00pm at the East Goshen Township Building. In attendance were: Chairman Kathryn Yahraes, Vice Chairman Ellen Carmody, and members Ben Rohrbeck, Sue Ciorletti, and Dolores Higgins, Joe and Jason were not in attendance. Also in attendance were: Gary Althouse (Township Building Inspector), Al Zuccarello (PC member), and Vicki Wooters (Parks and Recreation Member).

1 & 2. CALL TO ORDER AND PLEDGE OF ALLEGIANCE

The Chairman called the meeting to order at 7:13pm and led those present in the Pledge of Allegiance. Other than the recording secretary, no one was going to be recording the meeting.

3. MINUTES

Ben moved to approve the September 10, 2009 minutes as written. Sue seconded the motion. No further discussion or comments were made. The vote was unanimous to accept the minutes as corrected. Please note that the minutes were approved by a 4-0 vote, Joe and Jason were not in attendance and Ellen was not present during the approval of the minutes.

4. ACTIVITY CALENDAR and ANNOUNCEMENTS

Kathryn noted that there were no changes to the calendar at this time. A commission clean up day has been scheduled for November 7, 2009 at 9am.

5. CHAIRMAN'S REPORT

Kathryn updated the Commission on the continued improvement of Mary Powell, who is recovering from knee replacement surgery. The 6th PA presentation for tonight's meeting has been postponed to the November 12 meeting. Theorem Painting was rescheduled but only three people have indicated an interesting in taking the class.

6. BUDGET

The Commission discussed having one to two Living History Days in 2010. It was decided to include line items for both events for next year's budget. Discussion moved to specific line items to be added to the budget.

7. SUBDIVISION / LAND DEVELOPMENT

Gary Althouse talked about plans for 1422 Paoli Pike. There are many zoning issues and struggles. Al Zuccarello added that this is a non-conforming structure, non-conforming lot and that a variance and conditional use will be needed. It was added that the Planning Commission, Board of Supervisors, as well as the HC all want the potential buyer to succeed in this matter. The Historical Commission then viewed the plans for the property.

8. OLD BUSINESS

<u>Images of America Book</u> -- To date, we have sold 165 books. Books will be sold at the Paoli Illumination Event. A special page will be added to the Township web site to promote purchase of the book for holiday gifts.

<u>Hershey's Mill Dam</u> - a possible request for dam reclassification will be hand delivered by Senator Dinniman to the DEP after the Board of Supervisors receives the recommendation from the engineering firm of Gannet Fleming.

<u>Living History Day Evaluation</u> – The Commission discussed the very successful Living History Day that was held September 19. Approximately 500 people attended. It was the largest event so far. All of the activities that were held this time should be kept. Activities included: candle making, Making Betsy Ross Stars, Quill Pen Writing, Making Butter, Colonial Dancing and Instruction, Musket Drills, Fence Building, and Photographing visitors in Colonial Garb.

 Demonstration activities to be kept are: Camp Kitchen, Spilling, Blacksmith Activities, Wheelwright Activities, and Colonial Store. To be looked into are Tinsmithing and a Cooper. The Commission needs to "re-think" cooking on the hearth and maybe doing more demonstrating of the actual skills that were undertaking and concentrate on activities that visitors can try their hand at.

Exhibits in the meeting room worked well. The Battle of the Clouds (Battle of Goshenville) display was well received. Keep Norm Glass's antique tools and also the display from CCHS. A handout that could be stamped for each activity attended by visitors was discussed again along with a prize to be awarded to each person who completed all of the activities. The PA System needs to be moved to the other side of the parking lot so that people on the other side of the path can hear announcements and music. The concept of a "town crier" who would walk around and announce specific activities should be looked into.

Education Center- discussions of signage and school programs were the main topic. Ben has observed that southbound traffic can't see the banner until they are right on top of it and the northbound traffic doesn't see it at all. The idea is to move and post another. All suggested that members/representatives from the HC should attend a Planning Commission meeting in the future to inquire about special exception for posting signs at the Education Center. This would benefit residents as well. Kathryn suggested that the Commission members come up with some ideas for the next meeting including wording for two bigger size signs and for rider signs and low-to-the-ground information signs about the structures and building. The members were asked to work in the phrases "historic buildings", free tours" and open weekends".

<u>Visit to the Colonial Plantation</u> — Commission members and Plank House Volunteers visited the Colonial Plantation September 30 for a private tour. The Commission unanimously voted to send a \$50 donation along with a Thank You letter to the Plantation. Since the number of attendees was small because of schedule conflicts, another tour will be set up for next April or May. The staff from the Plantation visited the Plank House and Blacksmith Shop June 18.

9. NEW BUSINESS

<u>Township Newsletter</u> – Information was submitted. It was noted that full articles and Notes and News will be posted on the Township website since the information that was submitted was drastically shortened.

Museum Room in the Plank House -- Dolores said the Museum Room on the second floor in the Plank House should be redesigned. Kathryn suggested a static display. Dolores suggested a rotating clothing display. Dolores will work on this with help from Commission members and Plank House volunteers. Linda Gordon will be asked for a list of items; who donated the items and when; and what items were purchased along with the purchase date and the amount.

10. LIAISON REPORTS – All reports for meetings held to date have been emailed. Municipal Authority and the Conservancy Board do not meet until next week.

RESOLUTION NO. 94-21

A RESOLUTION ESTABLISHING THE EAST GOSHEN TOWNSHIP HISTORICAL COMMISSION, SETTING FORTH THE DUTIES AND RESPONSIBILITIES THEREOF, ESTABLISHING THE MEMBERSHIP THEREOF, AND PROVIDING FOR THE ORGANIZATION AND MEETINGS OF THE COMMISSION AND FOR THE FINANCIAL SUPPORT THEREOF

WHEREAS, the Township of East Goshen in Chester County, Pennsylvania, contains many resources of historic and architectural significance which are of importance to the Township; and

WHEREAS, the said significant historical and architectural resources are of inestimable value to the community and are generally irreplaceable and may be unnecessarily damaged or destroyed without appropriate planning by East Goshen Township; and

WHEREAS, the 1992 East Goshen Township Comprehensive Plan states that the preservation of historic resources within the Township is warranted; and

WHEREAS, for the foregoing reasons, the Board of Supervisors of East Goshen Township has determined it to be appropriate to establish a Historical Commission for the Township of East Goshen to give aid and guidance to the Board of Supervisors.

NOW THEREFORE, the Board of Supervisors of East Goshen Township hereby resolves as follows:

BE IT HEREBY RESOLVED that the Township of East Goshen, acting by and through its Board of Supervisors, hereby establishes a Historical Commission, which shall be governed by the rules and regulations set forth, setting forth the duties and responsibilities of the Commission, establishing its composition and otherwise setting forth provisions for the establishment, regulation and guidance of said Commission.

Section 1. Name

The name of the body hereby established shall be the "East Goshen Township Historical Commission".

Section 2. Duties and Responsibilities

The East, Goshen Township Historical Commission (hereinafter referred to as "Commission") shall have the following duties and responsibilities:

- a. To conduct a survey of historic resources for the purpose of determining those of historic and/or architectural significance and the pertinent facts about such resources; to act in collaboration with the Planning Commission of East Goshen Township and other groups with respect to such survey; to maintain and periodically revise a detailed inventory and map or maps of such historically and/or architecturally significant resources and the data collected concerning the said resources, appropriately classified.
- b. To research and record the history of East Goshen Township.
- c. To research significant historic objects, sites, structures, buildings and districts, and to recommend to the Board of Supervisors the nomination of same to the National Historic Register of Historic Places.
- d. To propose from time to time to the Board of Supervisors the establishment of historic districts in accordance with the then applicable statutes and rules and regulations of the Commonwealth of Pennsylvania.
- e. To formulate regulations for the establishment of an appropriate system of markers for selected historic and/or architectural resources, including proposals for the installation and care of such historic markers and to recommend adoption of the same to the Board of Supervisors.
- f. To prepare and publish books, maps, brochures, and descriptive materials about the Township's history and historic and/or architectural resources.
- g. To cooperate with and advise the Board of Supervisors via the Planning Commission in matters involving historically and/or architecturally significant resources, during the review of zoning and/or subdivision and land development proposals, and to determine the extent to which the same have the likelihood of impacting upon historic and/or architectural resources.
- h. To cooperate with and enlist assistance from the National Park Service, the National Trust for Historic Preservation, the Pennsylvania Historical Museum Commission and other local, state and national historic societies, conservancies and other agencies, public and private, concerned with historic and/or architectural preservation.
- i. To advise owners of historic and/or architectural buildings and resources on problems in connection therewith and methods of preservation thereof.

- j. To keep abreast of technical literature reports and documents relevant to historic and/or architectural preservation in East Goshen Township.
- k. To promote public interest in the work of the Commission, by carrying on a public relations program by other appropriate means.
- 1. To advise the Board of Supervisors on the acquisition, whether by gift, purchase, grant, bequest, easement, devise, lease, or otherwise, and/or restoration of historic and/or architecturally significant properties and other resources, historical records and other data and material within the purview of the Commission.
- m. To make plans for the establishment of a permanent archive of Township records and documents, and to make recommendations to the Board of Supervisors concerning the same.
- n. To perform such other duties and undertake such other responsibilities as may be delegated to the Commission from time to time by the Board of Supervisors.

Section 3. Membership and Terms of Office

The Commission shall be composed of five (5) persons, each of whom shall be a resident of East Goshen Township, and each of whom shall be appointed by the Board of Supervisors. Duly appointed Commission Members shall serve at the pleasure of the Board of Supervisors but, unless otherwise removed by the Board of Supervisors, shall serve for terms of five (5) years each, or until their successors are appointed; except that of the five (5) persons initially appointed, one shall be appointed for a five year term, one shall be appointed for a one year term. All persons appointed shall serve their full terms unless voluntarily resigned or removed by the Board of Supervisors, at the pleasure of the Board. Vacancies in this Commission occurring otherwise than by expiration of the term shall be for the unexpired term, and shall be filled by appointment by the Board of Supervisors.

Section 4. Compensation

Members of the Commission shall receive no compensation for their services, but may be reimbursed for the expenses actually and necessarily incurred by them in the performance of their duties and in the conduct of the Commission business, when such reimbursement is authorized by the Chairman of the Commission and approved by the Board of Supervisors.

Section 5. Organization

The person appointed for the initial five year term shall serve as the first Chairman of the Commission and shall serve for a period

of one year. The members of the Commission shall annually elect their own secretary and other such officers as they shall deem appropriate and, after the initial term of the initial Chairman, shall elect their own Chairman, and all officers shall serve for a period of one year. Vacancies in any office created by resignation or otherwise, including a vacancy in the office of the Chairman, even if occurring during the first year, shall be filled for the unexpired term by election by the members of the Commission. The Commission shall adopt rules and regulations for the conduct of all business within its jurisdiction.

Section 6. Meetings

Regular public meetings shall be held to conduct the business of the Commission. The Commission shall keep records of its meetings and activities and shall make an annual report and other such periodic reports to the Board of Supervisors as the Board may require or the Commission may deem appropriate.

Section 7. Funding

The Commission may, with the consent of the Board of Supervisors, utilize any funds, personnel or other assistance made available by Chester County, the Commonwealth of Pennsylvania, or federal government or any of its or their agencies, or from any other private or public sources. Accounting for the receipt of such funds and for the expenditure thereof shall be pursuant to such regulations as the Board of Supervisor may adopt. specifically authorized by the Board of Supervisors, the Commission shall not establish any separate bank or other account for the deposit or accumulation of funds. The Board of Supervisors may enter into agreements or contracts regarding the acceptance or utilization of such funds or other assistance as may be available. The Commission shall submit a plan of activities and a proposed budget to the Board of Supervisors during the regular Township budget process. Funds for the expenses to be incurred by the Commission shall, at the discretion of the Board of Supervisors, be appropriated by the Board of Supervisors. The Commission may expend monies for such administrative, clerical, printing and legal services as may from time to time be required to, but its expenditures shall be limited to the amount of funds appropriated to it by the Board of Supervisors or otherwise obtained from other sources as set forth above and, at all times, expenditures of the Commission shall be subject to the approval of and regulation by the Board of Supervisors.

Section 8

This resolution shall take effect five (5) days after adoption and upon appointment by the Board of Supervisors of at least three (3) members of the Commission.

I am in receipt of your of letter that Liberty Towers, LLC intends to file an application to construct a 150 foot monopole facility immediately behind the existing WAWA, at 1594 Paoli Pike and that you are presently gathering comments on the potential effect on historic properties.

I would note that the proposed monopole would be located immediately west of the Goshenville Historic District and as a result it would essentially tower over the District. I have forwarded a copy of your letter and supporting information to the Township Historic Commission for their review and comment. In accordance with Township policy I have also sent a copy of your notice to all property owners within 1,000 feet of 1594 Paoli Pike.

I would add that 1594 Paoli Pike is located in the C-2 Zoning District and that monopole telecommunications facilities are not a permitted use in that district.



The Township shall decide whether to impose a tax, under the Local Tax Enabling Act, 53 P.S. §5 6910, 6913, 6924.101 et seq, for general revenue purposes in the annual amount of one hundred dollars (\$100.00) on every person engaging in business, as defined in the Ordinance, in the Township. The effective date of the tax is January 1, 2010. The reason necessitating the imposition of the tax, in the judgment of the Board of Supervisors, is to serve as an alternative to a substantial increase in real estate property tax, and to continue existing Township operations and services valuable to the community. The amount of revenue estimated to be derived from the tax is approximately \$40,000 dollars.

At the same public action meting, the Board of Supervisors will conduct a public hearing to consider and immediately thereafter during its meeting act upon the following Ordinance. The title of the Ordinance is as follows:

The Township shall decide whether to impose a tax, under the Local Tax Enabling Act, 53 P.S. §§ 5910, 5913, 6924.101 et seq, for general revenue purposes in the annual amount of \$10.00 on all occupations of all employed residents in the Township. The effective date of the tax is January 1, 2010. The reasons necessitating the imposition of the tax, in judgment of the Board of Supervisors, is to serve as an alternative to a substantial increase in real estate property tax, and to continue existing Township operations and services valuable to the community. The amounts of the community the amounts of the town the tax is approximately \$33,000 dollars.

At the same public action meeting, the Board of Supervisors will conduct a public hearing to consider and immediately thereafter during its meeting act upon the following Ordinance. The title of the Ordinance is as follows:

The Township shall decide whether to impose a per capita tax, under the Local Tax Enabling Act, 53 P.S. §§ 6910, 6913, 6924.101 et seq, for general revenue purposes in the annual amount of \$10.00 on all adult residents in the Township. The effective date of the tax is January 1, 2010. The reasons necessitating the imposition of the tax, injudgment of the Board of Supervisors, is to serve as an alternative to a substantial increase in real estate property tax, and to continue existing Township operations and services valuable to the community. The amount of revenue estimated to be derived from the tax is approximately \$56,000 dollars.

At the same public action meeting, the Board of Supervisors will conduct a public hearing to consider and immediately thereafter during its meeting act upon the following Ordinance. The title of the Ordinance is as follows:

The Township shall decide whether to impose a tax, under the Local Tax Enabling Act, 53 P.S. §§ 6910, 6913, 6924.101 et seq, for general revenue purposes at the rate of live (5%) percent of the admission price to each and every amusement, as defined in the Ordinance, within the Township for which the individual price of admission is \$0.10 or greater. The effective date of the tax is January 1, 2010, The reasons necessitating the imposition of the tax, in judgment of the Board of Supervisors, is to serve as an alternative to a substantial increase in real estate property tax, and to continue existing Township operations and services valuable to the community. The amount of revenue estimated to be derived from the tax is approximately \$22,500 dollars.

The purpose of this letter is to inform you that mark and Helen McGinley, 77 Dilworthtown Rd., Thornton, PA 19373, have submitted an application for a variance to the Township. The applicant would like to construct a single-family detached dwelling unit on his property at 19 School Lane.

The applicant is requesting a variance from the 20-foot minimum side yard requirement for the dwelling. The existing lot is only 50 feet wide so the variance, if granted would result in only a fifteen foot side yards.

The Zoning Hearing Board will hold a public hearing to consider the variance application and decide whether or not to grant the requested variance.

Signage for Historic Adaptive reuses

Dear Board Members:

At our meeting on October 7, 2009 the Planning Commission discussed a proposed addition "Amendment" to the Historic Preservation Ordinance related to signage for historic properties which receive approval for an adaptive reuse or and have multiple principal uses. Right now the ordinance allows each adaptive reuse approved to have a 32 SF sign. This amendment proposes to limit the total sign area to 32 SF for the property as a whole.

The commission voted unanimously in favor recommend amending the zoning ordinance as outlined below:

§240-38.5.

E. Where approved by the Board of Supervisors as a conditional use, a property on which a historic resource is located and adaptively reused shall be permitted one freestanding sign with a maximum area of 32 square feet for the entire property regardless of the number of uses conducted within the historic resource.

This proposed amendment has been forwarded to the Historic Commission for their review and recommendation.
