6. OLD BUSINESS

- A. 501(c)3 Update The committee is going to be restructured and new members will be recruited. Because of additional demands on her time, Ellen had to resign as did Ruth Scadding. The township is looking for volunteers.
- B. Philadelphia Campaign The Commission members reviewed their participation at this event held on September 25 & 26. The spot East Goshen had was near the entrance to the Colonial camp so it was good exposure to the re-enactors as they passed by. Ellen reported that they made contacts with re-enactors from both N. & S. Carolina. This was an opportunity to talk to re-enactors in the area especially British. Some units are booked through 2012. A small event can only attract them by combining with another group to make it a 2 day event. The cost to the organizing group for this event was \$9,000. They wanted 5,000 people but Ben said the estimate was 1,500 on Saturday and half that on Sunday due to the rain. The PHMC had restrictions at Brandywine Battlefield but not in Delaware and other venues. Ben feels Chadds Ford will have control of the Battlefield

by the end of the year. Ben talked to people from Mass. to S. Carolina to Ohio. No one knew about the Battle of the Clouds or Paoli Battlefield.

Kathryn said people were impressed by the information the East Goshen team had and some said they would like to participate in ongoing Living History Days and other events in EGT. She made sure they knew it is a free event so they wouldn't be paid for coming. Next time Kathryn suggested putting together a display with photos of the Plank House and Blacksmith Shop area at this Delaware event. This year there were pictures of the Paoli Battlefield Illumination which had just taken place the weekend prior. Ben also put story boards together for the Battle of the Clouds. Ben reminded everyone that next year is the Civil War 150th anniversary and also that Chester County Day would take place in our quadrant. The Images of America book got good exposure and all the volunteers talked to people who weren't aware of East Goshen's historic area.

- C. <u>Building and Grounds</u> Ben is waiting to make arrangements with Mark Miller to install the new sign. He feels it will be installed after mowing and before snow.
- D. <u>Comprehensive Plan</u> Kathryn will be getting this in another electronic format in order to sort it. Discussion was tabled until the next meeting.
- E. <u>National History Day</u> This will be held on March 5, 2011. Ellen attended a planning meeting. This event needs more advertising and the group discussed how to get schools to promote the event. An Educators Day in the Fall where parents and teachers could learn more about it may be held in 2011 probably at the Chester Co. Historical Society. Other ideas like working with the Intermediate Unit and additional CCHPN promotion with the county municipalities can help foster more participation. The Historical Society of PA along with CCHPN made a list of all historic sites in Chester County. Now that Delaware County has the equivalent of CCHPN and National History Day is for both counties, there should be more participation.
- F. <u>Contacts</u> Kathryn Cloutman, a teacher at East Goshen Elementary School, is interested in working with the Commission. Putting information on the WCASD and East Goshen Elementary School websites would make it easier to get it to parents.
- G. <u>Family Research</u> Kathryn distributed information sheets that Ed provided on George W. Roberts and Charles W. Roberts who were locally involved with the Civil War.
- H. Other Projects Kathryn ordered a CD about the Civil War which is a good resource and contains art work. Benn talked to some people from Montgomery County and they are going to have a recruitment camp.
- I. <u>CCSPA</u> -- On September 22, the Chester County Society for Paranormal Activities visited the Plank House and Blacksmith Shop and saw some orbs in some photos and heard some things in recordings.

7. NEW BUSINESS

- A. <u>Expenses</u> Kathryn had prices for the yellow lawn signs for Living History Day. Ten signs will cost \$250, 15 will cost \$275 and 20 will cost \$300. Also it will cost \$160 for 20 sets of date decals for the next 5 years. The Commission approved the purchase of 20 signs for \$300 and decals for \$160.
- B. Officers for 2011 Kathryn said new officers need to be discussed at the November meeting.
- C. <u>East Goshen Bicentennial</u> -- will be celebrated in 2017. Senya asked the Commission for some preliminary ideas for events. The members gave the following: a parade, lectures, a time capsule, family fun fest at the park, a video of the township history,

- contests for young people and adults on historical topics, fireworks, historic home tour, photography contest, now and then display, list of who's who of East Goshen and historic markers for historic properties, writing contests, colonial and civil war events, activities for historic homeowners and a carriage parade.
- D. <u>Barn</u> Gary reported that the barn at 1532 E. Strasburg Road is an associated resource. There are parts of the International Property Maintenance Code that has standards it might fall under. The Codes Department is still investigating.
- E. Network Fall Lecture Last week Kathryn attended a lecture given by Jim Garrison of Frens & Frens (who worked on the Blacksmith Shop renovation and the Plank House relocation) about maintaining a historic house. Dale Frens was in the audience. She met with both of them and asked if they would come to a meeting for East Goshen historic homeowners next Spring. Both said yes and at no charge. There are 96 resources in East Goshen. Sue feels that a letter should be sent to owners stating that research has been done on their property and ask if they are interested in seeing it. Kathryn will contact Ed and have a sample letter for the November meeting. Ellen will update the list of sites.
- F. The Spring Workshop for CCHPN will be held March 12, 2011. The topic will be protecting historic properties. Sec. 106 Review will be discussed. Some members of the President's Council on Historic Preservation will do this presentation. Since some government officials will be here, the guest list will be expanded to include township officials.
- H. Keep East Goshen Beautiful Day -- will be April 2 or 9, 2011.

8. LIAISON REPORTS

- A. Park & Recreation The Pumpkin Festival will be this Saturday, October 16. If anyone can help, please come to the East Goshen Park at 9:15 am.
- B. Board of Supervisors Kathryn reported that Bert Deninstien, IT for the Township,made a presentation about the website and email archiving. The upgrade to the website is supposed to be done by mid-November. The Park & Recreation Boards' request to ban pets at events in the park was denied. Hershey's Mill Dam was appraised and went to bid. No bids were received. Senya and Don met with the Save the Dam Committee to review engineering and fundraising. TAG made a presentation of their final report. The report is on the website. The 2011 preliminary budget was submitted. Kathryn feels the Historic Commission will receive the same amount as last year.
- C. Other reports were emailed.

9. SUB-DIVISION/LAND DEVELOPMENT

- A. <u>Liberty Towers LLC</u> The Board of Supervisors is looking at other areas in the township to install a cell tower, possibly in the East Goshen Park. This would help generate revenue for the township.
- B. Regal Arms Apartments -- withdrew their application.
- C. 947 Cornwallis Drive Application was withdrawn.
- D. <u>1422 Paoli Pike</u> Sale is pending and will be used as doctor's offices. The same doctor who appeared before the Commission earlier in the year is the potential buyer.
- E. <u>Tory Inne</u> Gary reported that a permit for parking was issued. They still need to move the propane tanks and make the bathroom handicapped accessible. It may be ready to occupy by the end of November.
