1.	CALL TO ORDER The Chairman called the meeting to order at 7:00 p.m.

8. NEW BUSINESS

A. **Historic Resource Atlas** – Karen Marshall

Karen presented a detailed review of the construction, use, and output of the Historic Resource project. She helped the HC understand where we currently stand, and described what we need to do to complete the project. The HC agreed with the necessity of completing the project prior to the Thanksgiving period this year and has committed to moving the project into the number two spot in our focus... after the Historic East Goshen Day planning.

- B. Advertising for June 4th Civil War Program Ellen mentioned that we need to begin the advertising for the program right away. The HC members agreed and a motion was made (Judy/Ben) to allow for spending not more than \$200 for such advertising. Ellen has agreed to ask Don Beideman if he will help with the promotion.
- C. Blackpowder Guidelines A new ordinance has been added that will allow the firing of non-projectile blackpowder blanks in both passive and active parks with the preapproval of the BOS. The HC made a motion (Chris/Ben) to also use the East Goshen Historic Weapons Guidelines at events we sponsor. Copies of the Guidelines will be kept in the Plank House. All participating groups of individuals will sign a form that they have read and will follow these guidelines. The forms will be retained and need not be repeated.

9. SUBDIVISION/LAND DEVELOPMENT

A. 1422 Paoli Pike – The applicants appeared and presented their plans for the adaptive reuse of the historic building located on the site. There were a number of questions from the Historical Commission (HC) members regarding the applicants intention to retain as much of the historic nature and architecture as possible. The Applicants agreed that this was their intention, and that they would allow the HC a pre-construction photo and measuring opportunity, along with a presentation of the building plans for the new office to be attached.

Based on these statements the HC made an amendment (Chris/Ben) to be given to the Planning Commission (George was in attendance for this vote) and to the BOS recommending that the Adaptive reuse be allowed and that the need for a Historic Resource Review be waived. The amendment was written by Chris Reardon (Mark Gordon's copy plus additions by the HC) and forwarded to Mark Gordon for inclusion in the BOS packet on the 15th of April.

The East Goshen Township Historical Commission held a scheduled meeting on Thursday, March 10, 2011 at 7:00 p.m. at the East Goshen Township Building. In attendance were: Chairman Ellen Carmody, Co-Vice Chairman Ben Rohrbeck , Sue Ciorletti, Kathryn Yahraes, Judy Schafer, Joe Zug and non-voting members Monica Close and Ed Lendrat. Also in attendance was Gary Althouse (Township Building Inspector and Staff Liaison to the HC), George Martynick (Planning Commission), Dolores Higgins, Erich Meyer, and Don Beideman.

1. CALL TO ORDER

The Chairman called the meeting to order at 7:00 p.m.

2. PLEDGE OF ALLEGIANCE & MOMENT OF SILENCE

Monica led those present in the Pledge of Allegiance and in a moment of silence for our troops.

3. MINUTES

Kathryn moved to approve the minutes of February 10, 2011 as corrected. Ben seconded the motion. The motion passed.

The minutes of February 16, 2011 will be reviewed at the next meeting.

4. ANNOUNCEMENTS

A. The Activity Calendar was reviewed.

5. CHAIRPERSON'S REPORT

- A. Ellen reported that National History Day at Immaculatta did have over 400 students participate. Ben did a talk on indentured servants. A student from East Goshen won 1st place in the documentary category.
- B. Ellen reported that the bellows have been installed at the Blacksmith Shop. Also, the barrel was picked up by Sue and <u>Ben</u>. Dolores worked on patterns from the 1800's. Judy cleaned out the garden and researched gardens in the 1800s. She wants to meet with Kathryn to work on a plan for plants. An anonymous donor has given paint for the meeting room. Ellen thanked everyone for their help.

Ben commented that they need shot glasses and glass beer mugs. Ben and Chris are working on the bar for the tavern. Judy has some shelves for behind the bar.

Ellen reported that the curtains for the kitchen are done.

C. Ellen said she couldn't wear all the hats that Kathryn did when Kathryn was Chairman, but Ellen gave Kathryn a tall, green and white Dr. Seuss hat. In the white rows, Ellen wrote all the "hats" that Kathryn wore. Then she read a poem she wrote for Kathryn. Kathryn wore the hat for the meeting.

6. TREASURER'S REPORT

A. Monica gave out copies of the monthly and year to date expenses. Dolores asked about royalties from the book. Kathryn will check this out. Kathryn moved to accept the Treasurer's Report. Ben seconded the motion. There was no further discussion. The motion passed unanimously.

7. OLD BUSINESS

- A. Master List Ellen is working on the archive program. The Maker's Mark is showing up in photos if there is one on an object. Ben suggested marking lines on a board to use when taking photos to show the size of the object. Ellen would like to put a value to the objects if possible.
- B. Car Tour Ed reported that he and Judy met to discuss this tour for the Township's anniversary. Judy has a map of the Township with dots indicating Ben's tour. First they will locate all resources. Then they will assign a color to each separate area. Ed went through his files of samples of walking tours. Las Vegas, New Mexico has the most similar situation with 900 structures on their list. Their list is broken down into areas. Judy will draft a letter to the owners of historic properties in the Township explaining about the Township's celebration and the tours that are being planned. This letter must be reviewed by the Township Solicitor. This will give residents an opportunity to say that they don't want to be on the tour. Ed asked about the 12 resources missing from the original list. Gary reported that Rick Smith said there weren't any.
- C. George Clymer Judy gave out an information sheet about George Clymer, who was Ben's suggestion for a name to use in Applebrook. If anyone has any other suggestions, please let Judy know.
- D. Applebrook Park Kathryn voiced concern about the area around the historic structure near the new bridge. There is the rest station a scout made, a picnic table and trashcan. This is an historic area and needs to be maintained as such. Can the picnic table and trashcan be relocated? Ellen will email BOS, P&R, and Mark Miller. George explained how an Eagle Scout project operates and suggested that restraints such as future maintenance be required.
- E. Ben distributed copies of Harper's Weekly from April to October during the Civil War with information about people and events in the area for each month. He suggested using these at the Saturday tours. There will be no competition from Sugartown this year.
- F. Section 106 Kathryn reminded everyone about the seminar this Saturday, March 12 on Section 106.
- G. Kathryn asked which wall the barn board should go on, in the Blacksmith Shop meeting room. It was decided to put it on the window side, not past ceiling height, with white around the windows and the window sills need to be refreshed.
- H. Toys Judy passed around information about toys of the Civil War era. She asked Commission members to make suggestions. \$200 was approved for this.

8. NEW BUSINESS

- A. Living History Day Lou Stafford (PA 11th regiment re-enactors) called Kathryn. He was at a conference and spoke to Charlie Zahm about the Living History Day. Charlie sings and plays Revolutionary and Civil War era music. Lou asked if he would like to participate in our Living History Day. Dolores suggested having scheduled times for him in the yard between the garden and the front porch of the Plank House. Kathryn will follow up and forward the website link.
- B. Cell Tower Ellen and Kathryn attended the Zoning Hearing Board meeting about Liberty Towers, who wants to put a 150 foot tower behind the WAWA on Paoli Pike. She explained what it will look like and that it can be expanded. It will affect the viewscape from Historic Goshenville. The Board of Supervisors approved an RFP to open up the possibility of putting a tower in East Goshen Park or at the Township Complex. John Snook, who helped write the Historic Ordinance, will be the Township's expert witness. George commented that the engineers for Liberty Towers were evasive.
- C. Civil War clothing Judy, Ellen and Dolores are working on patterns for the men's shirts. Material for the men's shirts was purchased. They are working on acquiring material for the women's clothing. If they can get fabric at \$2/yd, the basic cost for 10-12 yards and buttons, etc., will be \$35 to \$40 per dress. Give Dolores the name of any fabric

stores you know about. Dolores had patterns for shawls and socks and some recipes. Ruth volunteered to crochet some shawls. Kathryn put a request in the Township Newsletter for donations from the Civil War. Jack's great grandfather was in the Civil War and Jack has several items that could be used. Ellen will order the book and CD about baseball in 1861. The cost is \$49.

- C. 628 Beaumont Circle has been sold. It was known as the Meredith House and is on the historic register. Ellen showed everyone a photo of the original house before the additions. D. There will be a lecture on March 24, 2011 at 7:30 pm at the Concord Twp. Community Center. The topic is "Re-evaluating the Role of US Colored Troops in the American Civil War".
- E. Sue said that Channel 20, Hershey's Mill, wants to do a program on the Civil War. Sue would like Kathryn to be the moderator.

A. Conservancy Board – Judy reported that the Conservancy Board was very receptive to the idea of naming an area in Applebrook for George Clymer.

She gave Ellen the grant information for the Paoli Battlefield.

- B. Board of Supervisors Kathryn reported that they denied Liberty Towers. They will not be going to PSATS in Hershey PA this year. They are revising the township map. Park & Rec Board was increased from 5 members to 7.
- C. 501c3 Joe reported that the committee has been busy getting organized. There are 10 members. Several have fundraising experience. Joe is the Vice President.
