Project Manager's July 2011 Report

Executive Summary

The RCSTP project moved closer to final closeout during July. Efforts focused on working with both contractors towards providing the remaining documentation and training required as part of project closeout as well as resolving equipment warranty issues.

On July 19, 2011, Clinger Corporation and their vendor, General Electric (GE), provided training for the operation and maintenance of the variable speed drives (vfds). There are a total eleven GE vfds employed throughout the treatment facility. These drives control the operation of key equipment including the influent pumps, disc filter feed pumps and Siemens SBR blowers. In addition, GE provided programming and training for the power quality meter (PQM) located on the main electric service for the facility. The PQM continuously monitors and records incoming electric data such as line voltage, amperage and hertz.

Clinger Corporation submitted request for final payment dated July 19, 2011 on the transmittal letter. On August 2, 2001 a final review of punch-list items for Clinger revealed a few outstanding items identified as:

- As built record drawing for the 35KW electric connection.
- Missing label
- Missing Arc Flash set back distance indicators installed on the floor.
- Acceptance of spare conduit caps by Owner.

Coordination with Clinger Corporation to resolve these issues immediately is in progress. Approval of final close-out is recommended contingent upon successful completion of the items identified.

Worth & Company continues to resolve identified equipment malfunctions considered as warranty items. During the month, the following issues were resolved:

- Distribution conveyor motor problem corrected. Re-installed a disconnected lead wire on the load side of the motor starter.
- Centrifuge sludge dewatering system polymer system malfunction. Replaced the "B" controller for the polymer system.
- Alum feed pump MP-32. Reprogrammed the pump. The pump operates in automatic mode through the Siemens SBR control panel.

The remaining issues remain outstanding. With the exception of the influent flow meter and SBR number 2 motive pump, the remaining items are planned to be completed during September when conditions are suitable for establishing ground cover.

- Influent flow meter
- Repair of SBR number 2 motive pump
- Top soil, final grading and seed are required around the sludge holding tanks.

- Touch up paint is required on sludge holding tank hand rails
- Touch up paint on aeration tank piping on the sludge holding tanks.
- Screen building seam at cast-in-place concrete and block water requires water proofing on exterior of building.
- Removal of the silt fence

On July 19, 2011, Chris Candy from Flygt (ITT Corporation) issued a revised price in the sum of \$2,509.00 for the repair to SBR number 2 motive pump. Flygt does not consider the impeller failure a warranty item; however, the local office was able to reduce the price. The repair cost will be paid by Worth & Company.

On July 25, 2011, a meeting was held to discuss the pending mediation meeting with Clinger Corporation. The mediation meeting is scheduled for August 8, 2011 at 10:00 AM located at the East Goshen Township building.

The wastewater treatment remains in compliance with the NPDES permit. The plant operator has included the use of magnesium hydroxide, as slurry, for use in maintaining the pH and alkalinity within the SBRs. Sodium hypochlorite was briefly applied to the scum on the SBRs for a few days. Aluminum sulfate is presently added at a rate of 25% pump which is equivalent to around 1.25 gallons. Daily usage is estimated at 75 gallons per day.

During July, the addition of aluminum sulfate to the SBRs during the pre-settle phase was intermittent. The aluminum sulfate system was return to continuous operation during mid-July to assist with settleability and establish a baseline of effluent phosphorus concentrations for comparison against the new phosphorus discharge limit. The treatment facility remains in compliance with the NPDES permit dated September 1, 2006.

The SBR treatment process is functioning on a 6 hour and 20 minute treatment cycle as opposed to the design of 6 hours. The settleability has improved allowing for a decrease in settle time from of 100 minutes to 80 minutes. Restoring the design time for 60 minutes of settle is progressing. The influent fill time was decreased from 140 minutes to 120 minutes and the fill rate was restored to the design rate of 520 gpm. On site process control monitoring has been useful towards adjusting the treatment process and restoring the original design set points.

The 14-day SBR performance test and demonstration, summarized as a sampling event, has been postponed indefinitely.

The current NPDES permit expires on September 30, 2011. Telephone calls to PADEP to allow the plant operator to demonstrate a minimum of two consecutive months of compliance with the phosphorus discharge limits is being pursued. Coordination of an inspection of the facility by PADEP prior to implementation of new discharge limits is recommended.

The project remains substantially complete with final closeout pending.

SUBJECT: Engineer's Report

RCSTP Upgrade and Expansion

- Construction phase services continue with punchlist monitoring, review of operations and maintenance submittals and as-built plans, troubleshooting, and coordination with the Project Manager and the Township.
- A breakdown of effort expended over the past month by Pennoni is provided with the invoice detail under separate cover.
- Worth and Company and Clinger Corporation have completed their punchlist with the exception of a few minor items. Paper and CAD as-builts, and electronic copies of O&M manuals were received from Worth Clinger submitted O&Ms and as builts in early July. Pennoni reviewed the Clinger documents and found them to be responsive to the contract requirements.
- A final punchlist review and verification is in progress.

I/I Metering Project

- The Township continues to meter flows at selected locations. A new program for monitoring meter data is starting up. Meters are in operation in at locations as recommended and two meters will be moved to new locations. Significant progress is being made to reduce infiltration and inflow.

Ridley Creek Consent Order

- The next report is due in September. No comments were received from DEP on the March report.

LCSTP Elimination

- DEP believes that sludge can be left in the ponds if properly handled and deemed non-hazardous. DEP will obtain confirmation from their Waste Management Division to confirm this determination. Pennoni is developing a closure plan for DEP review and comment. Elverson Borough abandoned a relatively similar lagoon in the past in was allowed to leave sludge in place. Samples of the sludge in both ponds will be collected and analyzed for TCLP parameters (hazardous characteristics).
- The proposed sewer route was staked and the Authority met with the affected property owners. Minor adjustments were made to the alignment. Easement documents are in progress.
- Utility research is complete and known utilities are being added to the design plans.

Hershey Mill PS Diversion, Reserve PS Elimination Planning

- DEP approved the pump station diversions on June 6. The Reserve pump station conveys sewage to Hershey Mill, which pumps to West Goshen. Both pump stations will be decommissioned and sewage diverted into the East Goshen Ridley Creek gravity sewer system.
- Base plan development is in progress.

Marydell PS Elimination Planning

- The report for the Act 537 Plan Revision was submitted to DEP in April. No comments have been received from DEP at the time of this report.
- The required 60-day public notice for the project was posted on June 24.

Applebrook Spray Irrigation NPDES Permit Renewal

- The NPDES discharge permit was submitted to DEP on June 15. DEP sent a letter confirming that the application is administratively complete and is undergoing technical review.

Chapter 94 Reports

- DEP provided several comments on the Ridley Creek Chapter 94 Report. Pennoni responded to the comments and we are awaiting confirmation from DEP that the response satisfies their inquiry.

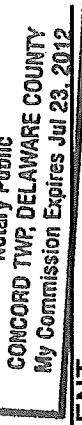

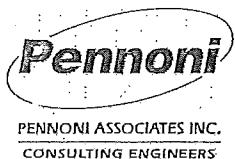

42 outstanding. As requested, on July 8, 2011, Pennoni Associates provided Clinger
43 Corporation with information contained within the contract specifications for the
44 termination of this wire within the Siemens SBR control panel. Lastly, training for the
45 general electric variable speed drives (vfds) has been scheduled for July 19, 2011 at 8:00
46 am.

47
48 Representatives from Dutchland were on site during the weeks of June 27th and July 5th to
49 remove and replace the defective CIM liner and repair the corbels adjacent to the walkway.
50 In addition, repairs to the lifting pins within the walkway were completed. On July 1st, the
51 telescopic valve for sludge holding tank No. 1 was repaired. The final effluent flow signal
52 wire to the final effluent was terminated. A representative from Hach will be on site during

1 the week of July 18th to program the sampler to function in flow proportioned mode.
2 Remaining warranty issues for Worth & Company include:

- 3 • Distribution conveyor motor
- 4 • Influent flow meter
- 5 • Top soil, final grading and seed are required around the sludge holding
6 tanks.
- 7 • Touch up paint is required on sludge holding tank hand rails
- 8 • Touch up paint on aeration tank piping on the sludge holding tanks
- 9 • Screen building seam at cast-in-place concrete and block water requires
10 water proofing on exterior of the building

11 The wastewater treatment operation and maintenance service provider discontinued the
12 addition of sodium hypochlorite to the SBRs. Addition of sodium hydroxide solution was
13 initiated during June to assist with improving settleability as well as providing supplemental
14 alkalinity for the nitrification process. Beginning the week of July 5th, the addition of
15 aluminum sulfate to the SBRs during the pre-settle phase was initiated to assist with
16 improving settleability. The treatment facility remains in compliance with the NPDES
17 permit.

18 The treatment system experienced a loss of nitrification resulting in elevated ammonia as
19 nitrogen concentrations in the final effluent. Measures to restore nitrification were
20 implemented and nitrification was restored during the week of May 31st. Measures to
21 improve the settleability of the SBR activated sludge have been implemented to reduce
22 solids loss through the effluent.

23 The Pennsylvania Department of Environmental Protection Water Quality
24 Specialist/Inspector continues to routinely visit the facility and maintain communication
25 with wastewater treatment operation and maintenance service provider. The SBR treatment
26 process is functioning on a 7 hour treatment cycle as opposed to the design of 6 hours. As a
27 result of poor settleability, a settle time of 100 minutes as compares to the design time of 60
28 minutes has been implemented to prevent excessive solids loss through the effluent. In
29 addition, the influent fill time has been increased from 120 minutes to 140 minutes to offset
30 the extended settle time. The influent fill rate has been decreased from 520 gpm to 440 gpm
31 to assist in reducing organic loading to the SBRs as a result of the extended influent fill
32 time. In consideration of the poor settleability, planned 14-day SBR performance test and
33 demonstration of a minimum of two consecutive months of compliance with the new
34 NPDES permit, the new wastewater treatment permit discharge limitations are anticipated to
35 be delayed until November 2011.

36 The project remains substantially complete with final closeout pending.

37 **B. Pennoni** – Dan Barbato, reported the following:

38 RCSTP Upgrade and Expansion

- 39 • Construction phase services continue with punch list monitoring, review of operations
40 and maintenance submittals and as-built plans, troubleshooting, and coordination with
41 the Project Manager and the Township.
- 42 • A breakdown of effort expended over the past month by Pennoni is provided with the
43 invoice detail under separate cover.

- 1 • Worth and Company and Clinger Corporation have completed their punch list with the
2 exception of a few minor items. Paper and CAD as-builts, and electronic copies of
3 O&M manuals were received from Worth. Clinger has not submitted O&Ms or as
4 builts. The Project Manager sent a second letter of notice to Clinger on June 22
5 regarding lack of progress toward closeout documents. Pennoni provided clarification
6 to Clinger's comments on the letter and provided confirmation that Clinger has received
7 paper copies of plans for markup.

- 9 • Matt McAloon of Pennoni was present to observe the liner repairs to the interior of
10 SBR#2 on June 29.

12 I / I Metering Project

- 13 • The Township continues to meter flows at selected locations. A new program for
14 monitoring meter data is starting up. Meters are in operation in locations as
15 recommended and two meters will be moved to new locations. Significant progress
16 is being made to reduce infiltration and inflow.

18 Ridley Creek Consent Order

- 19 • The next report is due in September. No comments were received from DEP on the
20 March report.

22 LCSTP Elimination, Hershey Mill PS Diversion, Reserve PS Elimination Planning

- 23 • DEP believes that sludge can be left in the ponds if properly handled and deemed
24 non-hazardous. DEP will obtain confirmation from their Waste Management
25 Division to confirm this determination. Pennoni is developing a closure plan for
26 DEP review and comment.
- 27
- 28 • Public Works probed the aeration pond and provided sludge depth measurements.
- 29
- 30 • The proposed sewer route was staked and the Authority met with the affected
31 property owners. Minor adjustments were made to the alignment.
- 32
- 33 • Existing conditions plans are complete and grading design is in progress.
- 34

35 Hershey Mill PS Diversion, Reserve PS Elimination Planning

- 36 • DEP approved the pump station diversions on June 6. The Reserve pump station
37 conveys sewage to Hershey Mill, which pumps to West Goshen. Both pump stations
38 will be decommissioned and sewage diverted into the East Goshen Ridley Creek
39 gravity sewer system. A proposal for engineering services is provided under
40 separate cover.

42 Marydell PS Elimination Planning

- 43 • The report for the Act 537 Plan Revision was submitted to the DEP in April. No
44 comments have been received from DEP at the time of this report.
- 45 • The 60-day review period for agency reviews (CCHD, Planning Commissions,
46 Sewer Authorities) expired on June 18. After this date, the plan can proceed without
47 these reviews.

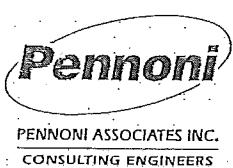

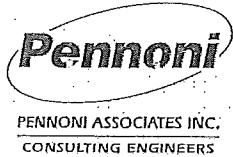

SEWER CONNECTION AGREEMENT

THIS AGREEMENT, made the _____ day of _____, 2011, by and between **EAST GOSHEN MUNICIPAL AUTHORITY** (hereinafter "Authority") and George F. Bevin Jr. (hereinafter "Owner"),

WITNESSETH:

WHEREAS, Owner is the record owner of real property located in East Goshen Township, Chester County, Pennsylvania, located at 1401 Pine Rock Road, being the above-identified tax parcel, having been acquired by deed recorded in the office of the Recorder of Deeds in and for Chester County, Pennsylvania, in Book _____, page _____ (hereinafter called "Property"); and

WHEREAS, Authority has installed in the neighborhood in which the Property is a part a sewage collection system referred to as the Pine Rock Sewer Project (hereinafter "Project"), which Project has been made part of the East Goshen Township sewer system which is owned by Authority and leased to East Goshen Township (hereinafter "Township"); and

WHEREAS, Authority has made available to Owner the option of paying for the connection cost of Four Thousand Four Hundred Eighty-Five Dollars (\$4,885) in quarterly installments over a period of twenty (20) years upon the terms and conditions set forth in the Installment Note attached hereto and made a part hereof; and

WHEREAS, Owner is entering into this Agreement to indicate Owner's legal obligation to make connection of the Property to the sewer system when directed to do so by the Authority and to pay the required connection fee, tapping fee and inspection fee for the Property upon the terms and conditions which follow.

NOW, THEREFORE, in consideration of the premises and the undertakings and promises hereinafter set forth, Owner agrees and declares that the Property shall be held, transferred, leased, sold, conveyed and occupied subject to the covenants, conditions, restrictions, charges and liens hereinafter set forth.

1. **Property Subject to Agreement.** The Property that is subject to the provisions of this Agreement and which, therefore, may be held, transferred, sold, conveyed and occupied subject to the obligations, covenants and restrictions hereinafter set forth, consists of the Property identified above.
2. **Number of Sewer Connections.** For all purposes under this Agreement, the term "sewer connection" shall be meant and intended to refer to the connection of the existing home on the Property which Owner agrees to connect to the sewer system when directed to do so by the Authority. Owner further agrees to pay all fees associated with the connection of the Property to the sewer system.
3. **Required Payments.** Owner agrees to pay to the Authority the connection fee of Four Thousand Four Hundred Eighty-Five Dollars (\$4,885) and the tapping fee of Two Thousand Dollars (\$2,000). In addition, the Owner agrees to pay East Goshen Township an inspection fee in the amount of Sixty Dollars (\$60). Owner has elected to sign the Installment Note attached hereto and marked Exhibit "A" in lieu of full payment of the connection fee. Owner agrees to sign the Note and return the checks in the respective amounts of Two Thousand Dollars (\$2,000) to the Authority and Sixty Dollars (\$60) to the Township prior to the connection to the sewer system.
4. **Future Connections by Owner.** It is agreed and understood by the Owner that the cost per connection payable hereunder is offered only for a single sewer connection for the Property. If the Owner requires a future sewer connection for which payment has not been made as provided for herein, a sewer connection fee, as calculated at that time, shall be payable.
5. **Remedies of Authority and Township.** Owner agrees and acknowledges that in the event Owner has not paid to the Authority the required sewer connection fee within sixty (60) days of notification, in accordance with terms of this Agreement, or defaults in the payment of any installment payable or balance due in accordance with the terms of this Agreement and the Installment Note attached hereto, the Authority and/or the Township shall have all rights under the Municipal Claim and Tax Lien Law, the Second Class Township Code and the Municipality Authorities Act to file and recover a municipal claim against the Property for each sewer connection fee or remainder thereof agreed to be paid by the Owner, together with allowed interest, penalties and costs upon the unpaid connection fee due, irrespective of the distance of the Property from the sewer system. The Owner hereby waives all applicable statutory time limits for the filing of municipal claims upon the Property.
6. **Recording.** The parties agree that this Agreement shall be recorded in the office of the Recorder of Deeds of Chester County, Pennsylvania.

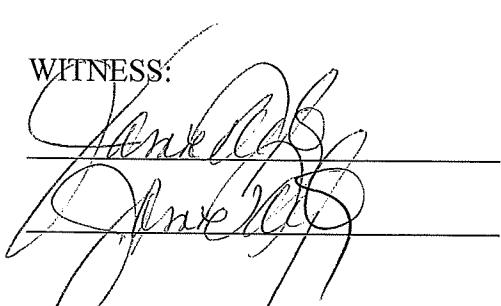
7. **Binding Effect.** This Agreement shall bind and inure to the benefit of the parties hereto, their heirs, executors, successors and assigns.

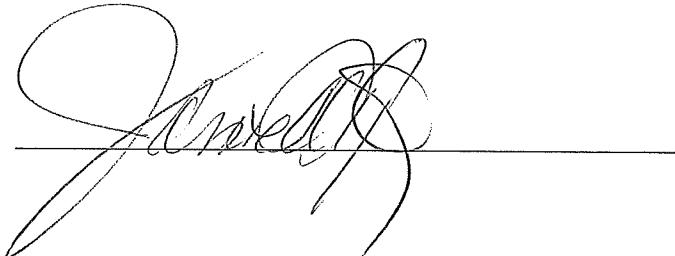
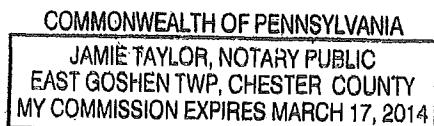

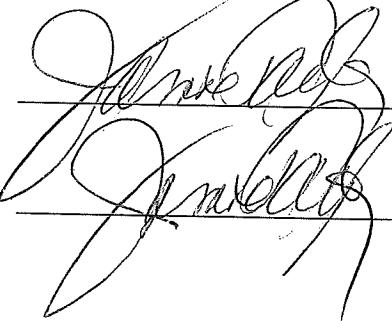
INSTALLMENT NOTE

FOR VALUE RECEIVED, Owner, jointly and severally, promises to pay to the order of **EAST GOSHEN MUNICIPAL AUTHORITY**, the sum of Four Thousand Eight Hundred Eighty-Five Dollars (\$4,885), together with interest at the annual rate of six percent (6%), as payment of the balance of the connection fee for the real property located in East Goshen Township at _____ (hereinafter "Property").

The principal and interest shall each be payable together in eighty (80) equal successive quarterly installments of combined principal and interest in the aggregate amount of One Hundred Five Dollars (\$105) each, plus an administrative fee of Three Dollars (\$3.00) each quarter. The first installment shall be paid on _____, and subsequent installments shall be paid on the same day of each succeeding calendar quarter until all payments have been made. Each payment shall be credited first to the interest then due. The remainder of each payment shall then be credited to the outstanding principal and interest. A late payment fee of Twenty-Five Dollars (\$25) shall be imposed for each quarterly payment not paid when due. Owner shall have the right to pay the entire balance due at any time without penalty. Meters: The meters were calibrated in July. The portable flow meters were read on a bi-weekly basis with no problems to report.

C.C. Collection: The Pumping stations were visited on a daily basis with no problems to report. When we had the problems last month at the Marydell station, we found the collection line on Wilson Drive has deteriorated, we will be televising the lines next week.

Lochwood Plant: Minor repairs were done to the grinder. We did some work with the engineer to gather sludge for testing.

R.C. Collection: The pumping station was checked on a daily basis with no problems to report.

Ridley Plant: The public works department assisted the plant operator with spraying the foam on the tanks. Two weeks ago Scott Towler and I met with the plant operator to discuss the operation of the SBR. Scott reviewed the data and recommended that the operator consider changing aeration time on each SBR. Once agreed that there would not be any changes to the operation

unless all three agreed. I'm happy to report that the changes have made a significant difference in the effluent.

Alarms: We responded to 25 alarms during the month of July.

PA One Calls: The Public Works Dept. responded to 130 PA One Calls.

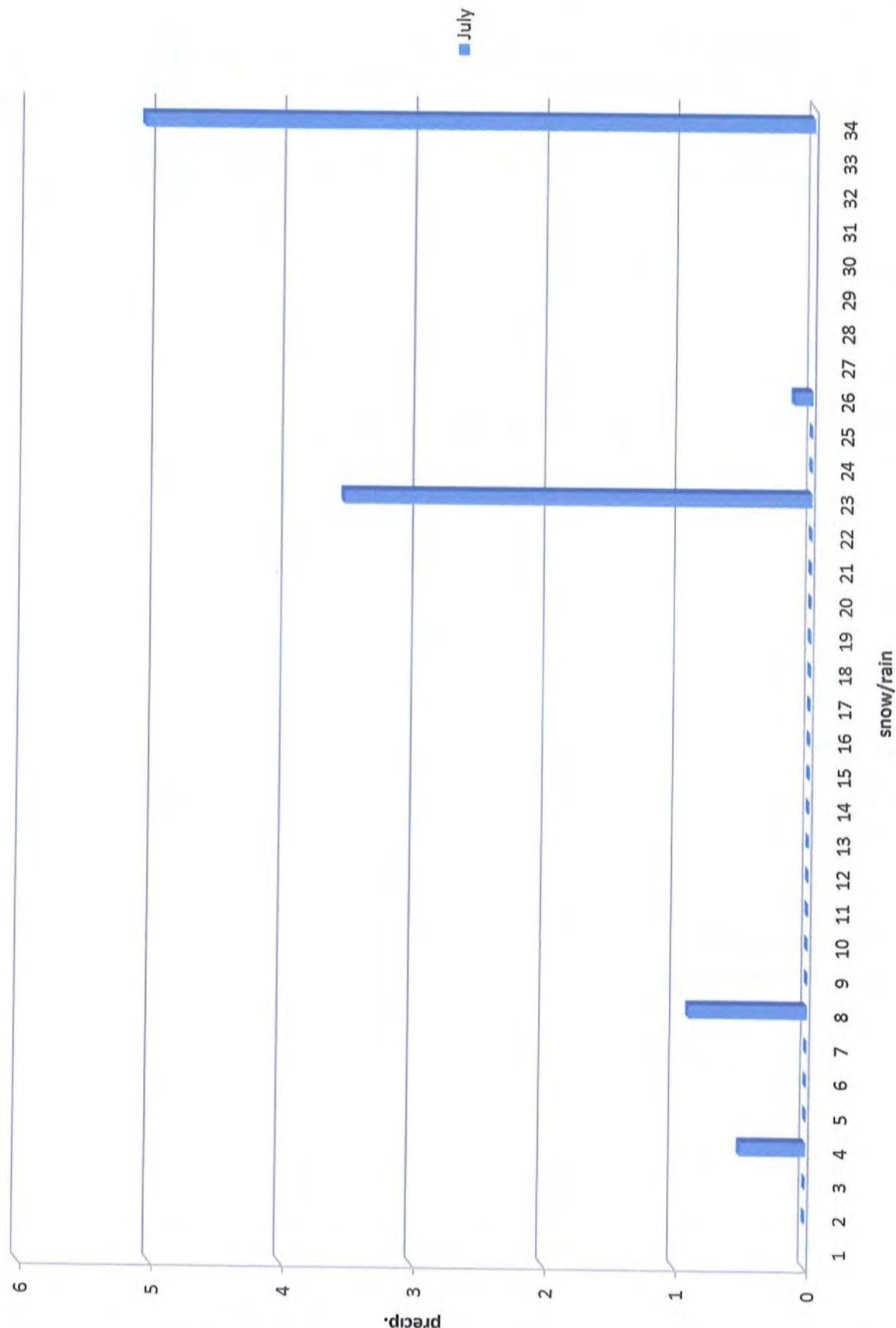

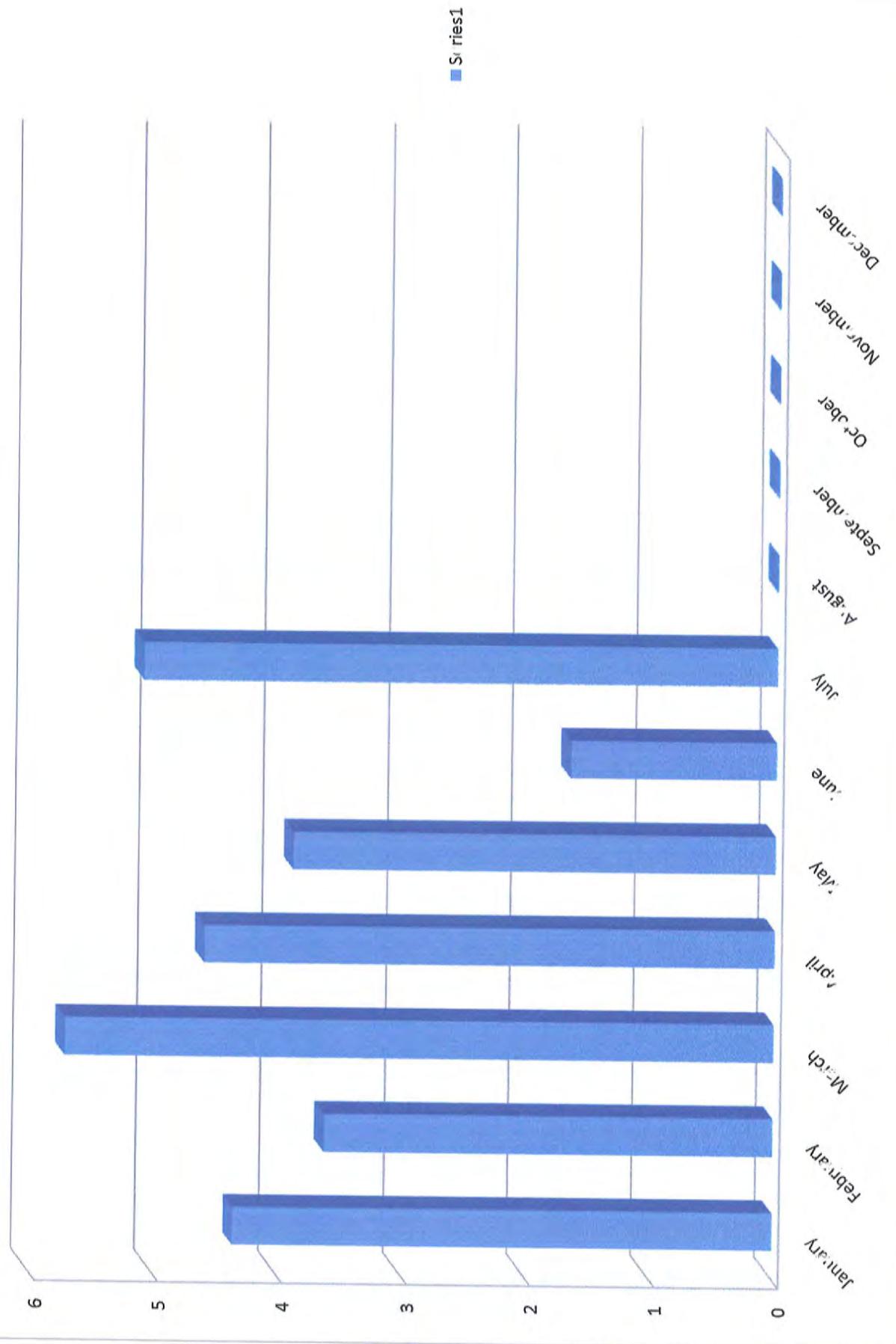

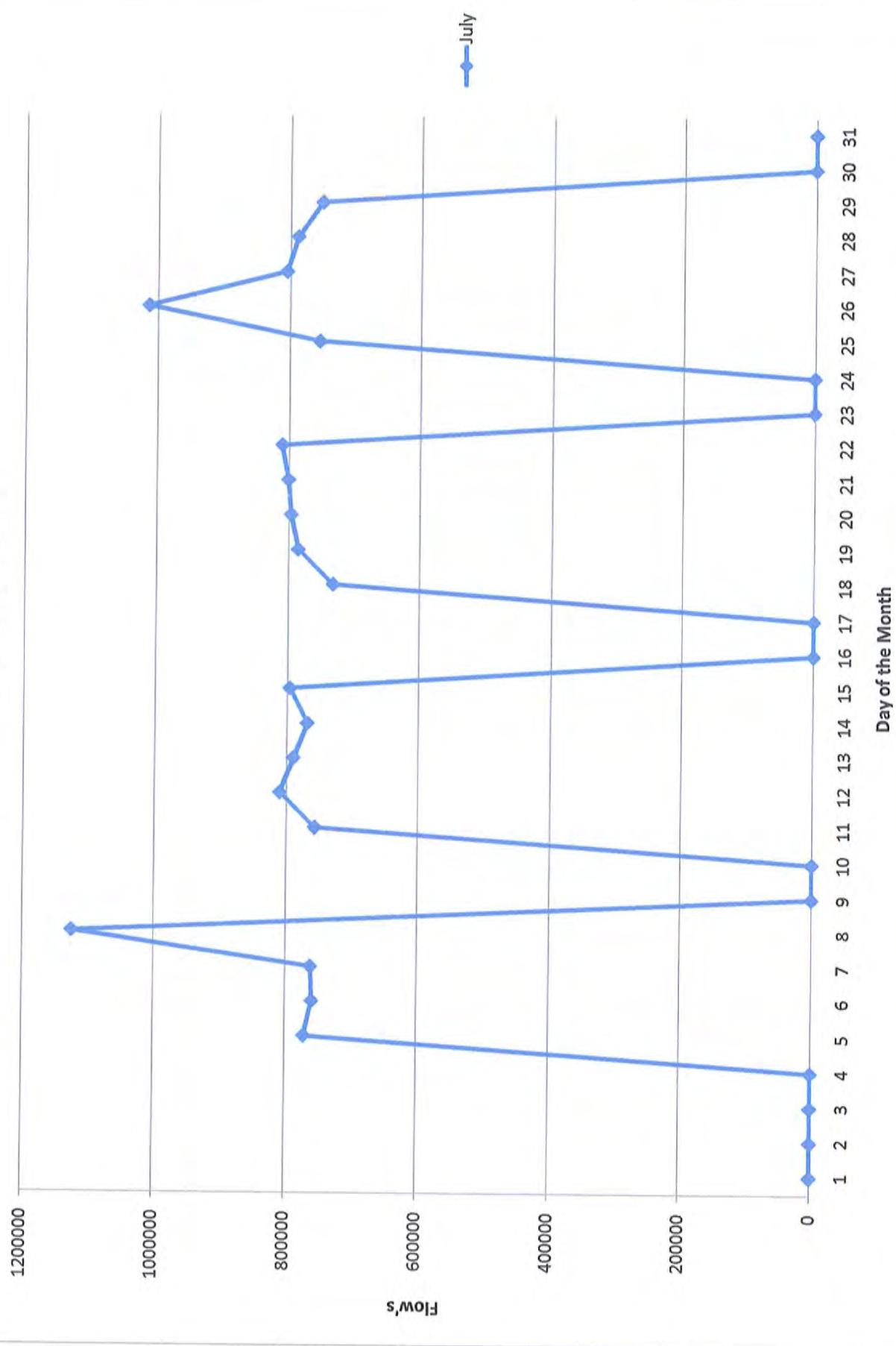
July precip. 5.11 - 2011



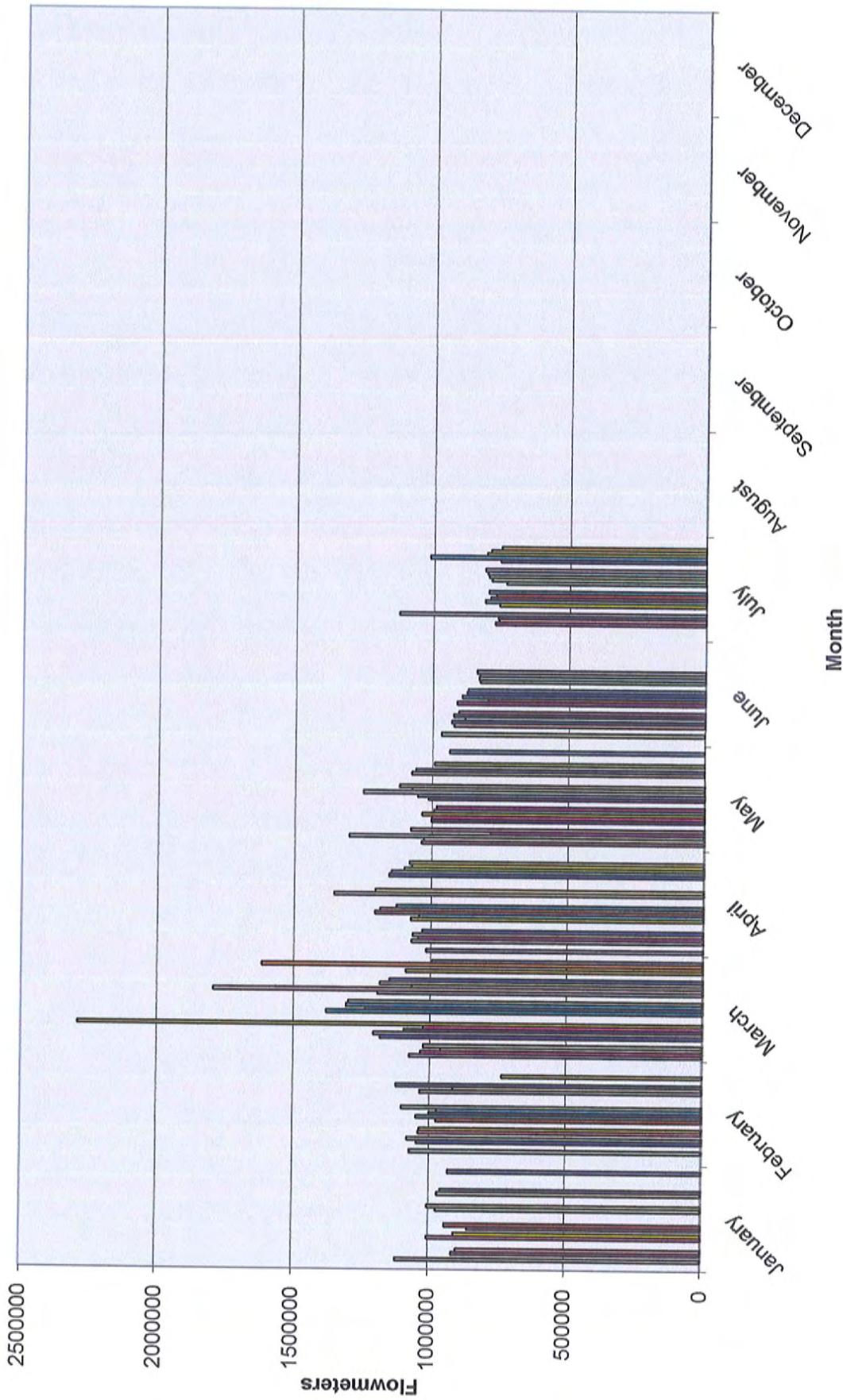
2011 Monthly Per capita
