The regular meeting of the East Goshen Township Park and Recreation Board was held on Thursday, January 7, 2010 at the Township Building. The meeting was called to order by Chairman Ann Marie Moore at 7:00 p.m. Other board members present were: Phyllis Marron, Bob Huebner, Ruth Scadding and Vicki Wooters.

1. CALL TO ORDER/PLEDGE OF ALLEGIANCE

Chairman Ann Marie Moore called the meeting to order and led the Pledge of Allegiance.

Reorganization – Ruth Scadding moved to nominate Ann Marie as Chairman for 2010. Bob seconded the motion. The motion passed.

Bob Hubner moved to nominate Phyllis as Vice Chairman for 2010. Ruth Scadding seconded the motion. The motion passed.

Bob Hubner moved to appoint Ruth Kiefer as secretary for 2010. Ruth Scadding seconded the motion. The motion passed.

2. MINUTES

Bob Huebner moved to accept the minutes from November 5, 2009. Ruth Scadding seconded the motion. Phyllis abstained. The motion passed.

Phyllis Marron moved to accept the minutes from December 3, 2009. Bob Huebner seconded the motion. The motion passed.

3. EXPENDITURES

The Board reviewed the expenditures for December 2009. They had questions about Refunds which had a -1,905 and Sports Squirt which had a -1,882. Mark reported that the Field trips expenses originally included the cost of buses which was incorrect and will be moved to the proper category.

5. STAFF REPORTS

A. In Frank's written report, he stated that he was able to get the fireworks contractor to agree to \$9,000 for a 20 minute show. Thom Clapper said the Board of Supervisors has committed to \$5,000, but the Park & Recreation Board will have to get donations to cover the rest of the expenses, i.e. police, lighting, music, etc.

B. Mark will start cutting along the stream in Applebrook next week. Mr. Jones asked if the bridge in East Goshen Park along Paoli Pike could be treated to prevent slipping when it is wet. Mark is looking into using black non-skid strips on it.

6. ITEMS TO BE DISCUSSED

A. Grant for removal of invasive and noxious weeds was discussed. Jane Fava explained that the Natural Lands Trust will administer a grant which is available through PECO. The Conservancy Board and Park & Recreation Board could co-fund the request. The application for the grant must be postmarked by January 15, 2010. Mark can mow the multi flora rose now with spraying starting in the Spring. Jane pointed out that Canada Thistle needs to be taken care of too. The work would be done by area, not by type of weed. Jane said the Conservancy Board should be able to contribute \$2,000 to \$3,000. Bob moved to

apply for the grant and use \$4,000 for removal of invasive and noxious weeds. Phyllis seconded the motion. The motion passed with 4 yes votes and one no (Vicki).

- B. Natural Lands Trust Stewardship Assessment The site walk in Applebrook was completed. The report from NLT has not been received yet.
- C. C2P2 Grants The Board received information about possible grant funding from the Dept of Conservation and Natural Resources. Applications can be submitted between January 6 and April 21, 2010. The Board decided that the two categories they would be interested in are Community Recreation and Conservation Projects and PA Recreational Trail Projects. Mark will look into getting an application.
- D. Yearly Goals The Board discussed Immediate and Long Range Goals for 2010 and Accomplishments for 2009 to prepare for the Annual meeting on Saturday January 9, 2010.

<u>Board of Supervisors</u> – Phyllis reported that PennDOT won't approve a traffic light at Paoli Pike and Line Road without turning lanes. The 2010 budget was passed with no increase. The BOS signed an agreement with the Goshen Fire Co.

Thom reported that a hydrologic study is being done on the Hershey's Mill dam. Supervisor Joe McDonough has resigned effective January 8, 2010 and is moving to South Carolina. The Natural Lands Trust will come to a future BOS meeting to present their report.


I received a call from Hank Belber who expressed a concern that allowing people to use rollerblades, bicycles and skateboards in the Applebrook Park was not in keeping with his understanding of how the Applebrook Park would be used when we purchased.

By way of background Hank Belber, was one of the principals of Applebrook Associates, who put up the funds to purchase the golf course and the land for the singe family and carriage homes, when we put the deal together to purchase the property from Pfizer.

The Board discussed this at their meeting on January 19th and they would like a recommendation from the Par & Rec Board by the Supervisors meeting on May 4th on whether or not the ordinance should be amended to prohibit these activities in Applebrook.

Your East Goshen Township Park System

East Goshen has a park system that includes recreation areas and passive open space. There are both township and neighborhood parks.

There are different activities and facilities available at the different parks. Some are for passive use only and others allow organized events. In all of the parks, please pick up your trash.

Some parks have facilities that you can reserve, with a permit. These would include pavilions and ball fields. East Goshen Park and Mill Creek have ball fields available to reserve with a permit.

East Goshen has parks and also has areas that are retention basins and wetlands. Parks include East Goshen Township Park, Applebrook Preserve, Mill Creek Park and the Reservoir. Applebrook Preserve and the Reservoir have spots suitable for fishing.

Both Applebrook and East Goshen have paved walking trails. Applebrook also permits rollerblades, bicycles and skateboards, East Goshen Park does not.

At all of the parks dogs are welcome but must be on a leash and their waste must be picked up.

East Goshen Park is the main park and with 55 acres also has a playground, tennis courts, basketball, and pavilions available for use with a permit.

ACTIVE PARK — A park that is intended, designed, equipped and designated by the Park Board for activities by individuals or groups participating in one or more of the following activities: individual athletic activity, organized athletic/sport's activities by groups or teams, whether formal or informal, group picnics, theatrical events, national holiday events and similar formal activities.

PASSIVE PARK — A park that is intended as permanent open space primarily maintained in a relatively natural and/or landscaped setting and designated by the Park Board primarily for pastoral enjoyment, but not for organized activities by individuals or groups participating in one or more of the following activities: individual athletic activity, organized athletic/sport's activities by groups, teams or individuals, whether formal or informal, group picnics, theatrical events, national holiday events and similar formal activities. Examples of permitted activities and facilities are walking trails, nonmotorized biking, running, rollerblading, picnic areas, bird watching and similar benign activities. [Amended 7-15-2003 by Ord. No. 129-H-03]

SPONSOR — The individual who vouches for and who assumes responsibility for a person or group during the period such person or group uses the park, and who shall be personally responsible for any damages to the park or costs incurred by the township as a result of such use.

§ 163-3. Rules and regulations.

The following rules and regulations are hereby established for the management and protection of all parks, playgrounds and open space owned by the Township of East Goshen, hereinafter designated the "parks," and apply to both active and passive parks.

- A. Hours of operation. All parks, whether active or passive, shall be open daily to all township residents and their accompanied guests between sunrise and sunset. No person other than authorized employees of the township shall be in any park at any time between sunset and sunrise. At sundown, all activities in the parks, with the exception of those activities under the direct supervision of the Park Board or by those persons issued validly existing permits or other written authorization by the township as hereinafter provided, shall cease; and all unauthorized persons shall promptly leave. Except as above provided, no person, other than authorized township employees, shall be in the parks between the hours of sundown and sunrise.
- B. Protection of park property. No one shall injure, deface, remove, cut or damage any of the trees, plants, shrubs, turf, buildings, structures or fixtures or any other township park property.
- C. Removal of park equipment. No one shall climb, stand upon or remove any bench, seat, table, fence, grill or recreational equipment or facility from any park or change the location thereof without permission from the Park Board.
- D. Disorderly conduct prohibited. No one shall conduct himself within any park in a boisterous, immoral or indecent manner as to annoy any other person using the park or nearby residents. Any township police officer or other law enforcement official may forthwith remove any person from any township park for such conduct.

order to do what is best for all 18,000 Township residents. Don noted that the Supervisor the Board selects will be appointed for a two-year period. Marty said that each individual Supervisor may have a different personal idea of what criteria would best suit the needs of the Township. Marty added that in the event the Board cannot come to a decision, the Township's Vacancy Board Member (former Supervisor John Chatley) would serve as a tie-breaker.

Public Comment: John Schorn, Larch Lane — Asked if the Board is obligated to select one of the candidates who applied. Don said there is no reason the Board should not be able to select a candidate from the list, unless it turns out they are all unqualified.

Public Comment: Jack Dempsey, Jamestown Way – Asked Don to elaborate on what would make a candidate "unqualified" since he stated previously that the Board has no selection criteria. The members of the Board told Mr. Dempsey that the only requirement to be appointed as a Supervisor is to have lived in East Goshen for at least one year. Don noted that the Board does not have a job description for the position of Supervisor to go by.

Public Comment: Jim McRee, Oneida Lane — Responding to Mr. Rahbari's earlier comments, Jim noted that the Board agreed during Workshop to publicly interview all the candidates, and not to select only the best candidates for interviews. Mr. McRee then reported that he finds the new "Slippery When Wet" sign posted near the bridge in the park to be too bright and out of place along a pedestrian walkway. Rick said the sign conforms to the government's new reflectivity standards.

Adjournment

There being no further business, the meeting adjourned at 8:56pm.

WORKSHOP (Resumed)

Use of Skateboards, Bicycles, Etc. in Park (Applebrook Side)

Don said that Hank Belber expressed concern that skateboards, bicycles, rollerblades, etc. are not explicitly banned from the Applebrook side of the park. Marty and Carmen said they do not think its appropriate for these items to be permitted in Applebrook. Carmen said children wanting to engage in these activities can use the West Goshen park. Thom disagreed and said the children in the Township need a place for these activities. In addition, the Township should be encouraging children to get outside and play, not discouraging it. Don said he is concerned for pedestrian safety. He recommended sending this issue to Park & Rec and have them make a recommendation to the Board. Thom noted that Park & Rec already made a recommendation to allow these activities on the Applebrook side of the park. Don said he wants Park & Rec to be told that three Supervisors have concerns about allowing these activities, and to look into this again and make another recommendation to the Board by the first week in May.

Public Comment: Howard Jones, Kennett Way – Asked if it would be possible to restrict the activities to certain hours. Carmen said he did not think it would be practical, as pedestrians use the park very heavily all throughout the day.

Marty said he thinks it would be best to eliminate a potential problem before it occurs. Carmen said he would be in favor of allowing the activities if the path were to be widened by four feet.
