Summer programs in aerobics, yoga, Pilates, zumba and clinics in soccer are ongoing as is the Youth Rec Camp. Preschool Entertainment in the park has been held every Tuesday in July. Attendance this summer is down from last year. I attribute this to the lack of a newsletter. When polling the parents in the audiences, I find that many would prefer a written notice about events.

I am still receiving calls, questions, and/or permit applications for East Goshen Park pavilions. The township park soccer/football field will not be ready for play in August due to lack of rain. Mark Miller says the best case scenario, if we get some rain, would be mid September. I informed the teams of this possibility back in March when the fields were regraded, under drained, and reseeded. I will hold a meeting of field permits applicants after the Park Commission meeting.

Summer camp has been excellent. In addition to the slate of classes in Arts and Crafts, Gym, Anything Goes, Spanish and Music along with field trips, we have also had: Police Detective, Bill Cahill gave a presentation on what it takes to be a Detective; 2 representatives from PECO came in to give the kids a program on energy consumption and conservation; and Goshen Fire Company will come to the program this Friday with their water cannon equipped fire truck to cool us off. I am always proud to show off our kids to people who give presentations at the program. Our kids are smart, well behaved, and eager to learn and have fun. The staff is wonderful and the Volunteers have been great.
