1. FARMERS MARKET - At 6pm this evening, all members of the Park and Recreation Commission met with Lisa O'Neil and Donna Levitsky, who currently run the farmers market for East Goshen. The purpose of the meeting was to hear Lisa's proposal to continue running the farmers market for next year. Lisa made it very clear that she is resigning, and does not intend to run next year's farmers market. She said she made two attempts to negotiate a figure with the Board of Supervisors and they turned her down. The last number was \$1,200 for her to run next season's farmers market. Since then, Lisa has agreed to run a farmers market next year in Malvern. Lisa was asked directly by the P&R if she would be open to further discussion about running the East Goshen Farmers market next year and she declined. She strongly feels that a farmers market in both Malvern and East Goshen in the same week would not work and that East Goshen would be the weaker of the two.

Our park softball, baseball, football/soccer fields and tennis courts have no permits pending for the fall. We have a activity in the Ira Hicks Pavilion on two dates.

Fall programs in Olympic Power Walking, and Stroller Fitness did not receive sufficient registrations to hold classes. The township fall newsletter has not been delayed due to several factors. The programs were put on the website as recreation information. The December 8th, New York City trip 54 passenger bus is filled with a small waiting list. Letters have been sent to the participants in the trip with the itinerary. The Hudson Valley trip was successful. The Captain of the Goshen Fire Police put attendance at the Pumpkin Festival at upwards of 3000 people. There wasn't a parking space or park able grass space unfilled. I congratulate the Park and Rec Commission on their hard work and team work that helped make it a very successful event. Many positive comments were received by phone and on site. I didn't get one complaint. A big thanks to Public Works Director, Mark Miller and his crew for their support and work. Another big thanks to Goshen Fire Company Captain, Jack Smith and his 5 officers for regulating the intersection of Hibberd Lane and Paoli Pike. In December, our Help a Neighbor for the Holidays has 15 volunteers from East High School, a brownie troop and cub scout troop along with a couple of families so far.

Looks like we have an excellent instructor for a Line Dancing Class during the day in January 2013-possible Mondays at 1pm. There seems to be interest in this activity with our seniors. There are some new and cool ideas for programs that can be pursued.
