## Emergency Alert System Nationwide Test (EAS)

## FCC Consumer Facts

## Background

The first nationwide test of the Emergency Alert System, or EAS, will take place at 2:00 p.m. (Eastern Standard Time) on November 9, 2011. The purpose of the test is to assess the reliability and effectiveness of the system in alerting the public.

## What exactly is the EAS?

The Emergency Alert System is a media communications-based alerting system that is designed to transmit emergency alerts and warnings to the American public at the national, Tribal, state and local levels. EAS participants broadcast alerts and warnings regarding weather threats, child abductions and other types of emergencies. EAS alerts are transmitted over television and radio broadcast, satellite television and satellite radio, cable television and wireline video services.

## When is the EAS used and when would a national EAS alert be sent?

The EAS is often used by state and local emergency managers to alert the public about emergencies and weather events. The system provides the ability to send messages regionally or nationally, though it has never been tested at these levels. A major disaster such as an earthquake or tsunami could require the use of the system to send life-saving information to the public.

## Why do we need a nationwide test?

Although local and state components of the EAS are tested on a weekly and monthly basis, there has never been an end-to-end nationwide test of the system. We need to know that the system will work as intended should public safety officials ever need to send an alert or warning to a large region of the United States. Only a complete, top-down test of the EAS can provide an appropriate diagnosis of the system's performance.

## How will the national EAS test be conducted?

The Federal Emergency Management Agency (FEMA), along with the Federal Communications Commission (FCC), will conduct the nationwide test on November 9, 2011 at 2:00 p.m. eastern standard time. The alert will be transmitted throughout the country and will be monitored by the EAS participants. After the test has been completed, the EAS participants will report back to the FCC on the results of the test.

## What will people see and hear during the test?

Although the nationwide EAS test may resemble the periodic monthly EAS tests that most consumers are familiar with, there will be some differences in what consumers may see or hear, which is one reason for conducting a nationwide EAS test. During the test, the public will hear a message indicating "this is a test". The audio message will be the same for everyone, however due to limitations of the EAS, the video test message may not be the same and may not indicate "this is a test". This is due to the use of a "live" national code - the same code that would be used in an actual emergency. Also, the background image that appears on video screens may indicate "this is a test" but in some cases there may be no image at all. FEMA and the FCC plan to reach out to organizations representing people with hearing disabilities to prepare that community for the national test. In addition, FEMA and the FCC will work with EAS participants to explore whether there are solutions to address this limitation.

## How long will the test last?

We anticipate that the test will last approximately 3 minutes.

## Why is the national test being conducted at this particular date and time?

In order to minimize disruption and confusion during the EAS test, it is being conducted on November 9 because this date is near the end of hurricane season and before the severe winter weather season begins. The 2 p.m. EST broadcast will minimize disruption during rush hours while ensuring that the test occurs during working hours across the country.

## Will the test involve mobile communications devices?

No. The test will involve only those communications service providers – broadcast radio and television, cable television, satellite radio and television and wireline video services – that participate in the EAS.

AN ORDINANCE AMENDING THE PROVISIONS OF THE PENSION PLAN FOR THE PAID FIRE COMPANY PERSONNEL OF THE GOSHEN FIRE COMPANY WHICH WAS ESTABLISHED BY THE BOARD OF SUPERVISORS OF EAST GOSHEN TOWNSHIP (THE "BOARD") ON MAY 5, 1987 IN ORDINANCE NO. 78 AND AMENDED RESOLUTION NO. 89-22 ADOPTED BY THE 1989 AND IN BOARD ON FEBRUARY 21, ORDINANCE NO. 129-K-09 ADOPTED BY THE **BOARD ON OCTOBER 6, 2009.** 

WHEREAS, on May 5, 1987, the Board enacted Ordinance No. 78 wherein it established a Pension Plan for the Paid Fire Company Personnel of the Goshen Fire Company (the "Pension Plan"); and

WHEREAS, on February 21, 1989, the Board enacted Resolution No. 89-22 to amend the vesting period for the Pension Plan; and

WHEREAS, on October 6, 2009, the Board enacted Ordinance No. 129-K-09 wherein it made certain amendments to the Pension Plan; and

WHEREAS, the Board wishes to ratify the vesting period for the Pension Plan that was made in Resolution No. 89-22 by adoption of this Ordinance.

NOW, THEREFORE, the Board of Supervisors of East Goshen Township, Chester County, Pennsylvania, does hereby enact and ordain as follows:

**SECTION 1**. Article VI of the Pension Plan, titled "Vesting and Severance of Employment", Section 6.01 shall be amended as follows:

"6.01. If a Member has completed less than five (5) Years of Service and leaves the employ of the Goshen Fire Company or ceases to be a Member whether by reason of his transfer, resignation or discharge, he shall be entitled to no benefits from this Plan. However, if the Member has completed five (5) or more Years of Service, he is eligible to receive a vested pension benefit to start at his Normal Retirement Date. The amount of the vested pension benefit shall be 1.25% of such Member's Average Applicable Compensation for each Year of Service, measured in years and completed months."

<u>SECTION 2.</u> <u>Severability</u>. If any sentence, clause, section, or part of this Ordinance is for any reason found to be unconstitutional, illegal or invalid, such unconstitutionality, illegality or invalidity shall not affect or impair any of the remaining provisions, sentences, clauses, sections, or parts hereof. It is hereby declared as the intent of the Board of Supervisors that this Ordinance would have been adopted had such unconstitutional, illegal or invalid sentence, clause, section or part thereof not been included herein.

<u>SECTION 3.</u> <u>Repealer</u>. All ordinances or parts of ordinances conflicting with any provision of this Ordinance are hereby repealed insofar as the same affects this Ordinance.

**SECTION 4. Effective Date.** This Ordinance shall become effective in five days from the date of adoption.

## Sheet Piling

Attached is an e-mail from Todd Trotman summarizing his conversation with the engineer at Everlast Seawall.

Comment – Advanced GeoServices has previously estimated that it would cost \$72,903 to \$83,978 to do the geotechnical investigation and permit a sheet piling dam above the dam. This does not include the cost for the structural design or the net flow analysis.

On 9/28/09 Everlast Seawall advised Neil DeReimer that it would cost \$150,000 to install 250 feet of 10 foot long sheet piling. The assumption was that the sheet piling would hold back 5 feet of soil. The cost for this was \$60 per square foot.

We know that the dam is about 400 feet long and 14 feet high so 10 feet sheets will not work. We also know that the sheets will have to be at least 14 feet long.

The table below depicts the sheet piling only costs based on the Everlast cost of \$60 a sq ft.

Length of dam	Length of sheet	Area in sq ft	Cost per sq ft	Cost
400'	10'	4,000	\$60	\$240,000

400'	21'	8,400	\$60	\$504,000

We do not know if the sheets must be driven 50% of their overall length in order to be structurally stable.

If we assume that we would need 28 foot long sheets, which is consistent with what Everlast advised Neil in 2009 the cost would be \$672,000 plus the geotechnical and permitting (\$72,903) which works out to \$744,903. To this we would have to add the cost for the structural design and the net flow analysis.

The above estimates do not include the cost for deadman anchors as mentioned in Todd's e-mail.

## Shot Crete Secondary Spillway

The existing spillway is 22 feet wide. In order to pass the design storm the spillway will need to be widened to 74 feet. The cost to do this is estimated to be between \$508,597 and \$520,597.

## Breach the Dam

The estimated cost to breech the dam would range between \$367,012 to \$518,012.

### Rick:

I placed a call to Carl A. Hazenberg, P.E. (Chief Engineer/International Business Director of Everlast Synthetic Products, LLC) to discuss his impressions and interest regarding the use of sheetpiling at the Hershey Mill Dam. A summary of our discussion is provided below.

- Carl's understanding of the project has changed since his initial involvement.
  - 1. Mr. Hazenberg's original understanding of the design criteria for the project was that the sheetpiling was to serve as a near surface restraint along the top of the embankment of Hershey Mill Dam and not to serve as the entire dam structure. During our discussion, he appeared to indicate that the existing trees along the top of the dam embankment would be removed to install/construct this near surface treatment.
  - 2. Mr. Hazenberg later learned that the required design criteria would be that the sheetpiling was to serve as the entire dam structure if the embankment materials in front of the sheetpiling were completely deteriorated and/or removed by scour. He indicated that this was a significant change in his understanding and may change his opinion regarding the feasibility of the use of sheetpiling for this project.
- Considering the design criteria identified in Item No. 2 above, Carl indicated that his sheetpiling system could not be designed as a freestanding structure to support the sediment/soil/water behind the dam. In order to provide the necessary restraint, the sheeting piling system would require the use of deadman anchors. The installation of deadman anchors could be complicated considering that they would have to be installed in the area where water and/or sediment is contained within the reservoir. In addition, a geotechnical investigation is required to determine the embedment length/requirements for the sheetpiling.
- Carl gave me the impression that he was not interested in taking the lead on the design of the sheetpiling system; it appeared to me that he was more interested in selling sheetpiling and working with another engineer who would perform the design. To paraphrase his words "I have many larger projects that I can concentrate on". He also informed me that he does not have his Professional Engineering License in the Commonwealth of Pennsylvania.
- Although he did not seem interested in performing the design, he did state that the feasibility of using sheetpiling for the proposed application at Hershey Mill Dam should be evaluated before moving forward with any further consideration of this option. He indicated that this evaluation should include a geotechnical investigation and an evaluation by the structural engineer who would be designing the sheetpiling.

I recommend that if East Goshen Township is seriously considering sheetpiling as an option to improve Hershey Mill Dam, the Township should engage a local Structural Engineer experienced in the design of sheetpiling to provide engineering consultation, cost estimates, and the structural design tasks associated with this option. The Structural Engineer should visit the site and be informed of the purpose of the sheetpiling and all of the required design constraints/criterion as well as the communities' interests and objectives related to this option. Because the sheetpiling will be the dam, it is Advanced GeoServices' expectation that the Structural Engineer would take the lead on this project; the design of sheetpiling is predominantly a structural

engineering task which is outside of our area of expertise. However, Advanced GeoSerivces can and is willing to provide geotechnical engineering, hydrologic/hydraulic engineering, and permitting support as requested and defined by the Structural Engineer.

Neil,

Based on our discussion earlier I wanted to outline some basic cost estimates for the Dam Rehabilitation project. If the installation was a typical cut-off wall application where sheets were driven to grade, I would estimate the installed price to be approximately \$75,000 (included material and installation) for 250I.f. of wall. If it were determined that more of a retaining wall structure were required to hold back approximately five feet of soil using 10 foot sheets, the cost for 250 I.f. would increase to approximately \$150,000 for the project (including material and installation). I hope these cost estimates are helpful. Please let me know if we can do anything else.

"The chair asks,' Are there any corrections to the minutes?' and after corrections, the chair says, 'If there are no further corrections to the minutes, they stand approved as corrected,' or if there are no corrections, 'They stand approved as read.'

I has been suggested that the Board develop a process that all of the ABC's should use.


- Continue televising portions of the Hershey Mill Development
- All sewers tributary to the Ashbridge Pump Station Margo Lane, Williams Way, Edith Road, Still Road, and the interceptor along Hunters Run Creek.
- Grand Oak/Bittersweet Development

## 3. Corrective Action #3: System Hydraulic Characterization

The sanitary sewer collection system tributary to the Ridley Creek Sewage Treatment Plant shall be modeled and hydraulically evaluated in order to determine if any physical constraints exist which would not allow for the conveyance of peak wet weather flow.

• The System Hydraulic Characterization was completed and submitted to DEP in November 2009 as required by the CO&A.

## 4. Corrective Action #4: Rehabilitation



## Previous 6 Months:

Since most of the following rehabilitation work occurred in the Chester Creek Service Area, the improvements are generally not tributary to any current temporary meters.

- Replaced numerous cleanout lids and cleanout riser pipes that had pulled out of lateral piping. (Ridley Creek and Chester Creek Service Areas)
- Replaced all manhole lids and castings in the Milltown Development and along Manley Road. (Chester Creek Service Area)
- Three manholes on Clover Lane were lined the terminal manhole to which the Hershey Mill Pump Station force main discharges and the two downstream manholes. A casting and lid was also replaced. (Chester Creek Service Area)
- Replaced defective portion of homeowner's lateral on Clover Lane that connects directly into the above-referenced terminal manhole. (Chester Creek Service Area)
- Repaired three pipes in the Milltown Development. (Chester Creek Service Area)

- Performed a total of eight spot liner point repairs on four pipes in the Marydell Development. (Chester Creek Service Area)
- Repaired a lateral with a severe leak in the Wyllpen Farms Development along Hunters Run Creek. (Chester Creek Service Area)

## Next 6 Months:

- Continue to conduct rehabilitation of sewers, manholes, and laterals as determined by ongoing investigations, including possible isolated cured-in-place pipe lining and replacement of cleanout caps and cleanout pipes that have pulled out of lateral piping.
- Maydell Farms will have approximately 50-60 manhole castings and lids replaced during paving. This rehabilitation work may occur in Spring 2012 if paving is not performed this fall.
- Repairs in Ashbridge Development if identified during televising inspections.

## 5. Corrective Action #5: Post-Rehabilitation Flow Metering

Flow metering shall take place in areas that have been rehabilitated in order to document the effectiveness of the rehabilitative work. The metering shall take place during both the fall and spring of the year.

## Previous 6 Months:

## Achom Drive

There has been a dramatic reduction of flows at Achom Drive from previous metering that was initiated at the location in Fall 2007. From October-December 2007, the average flow rate was 23 gpm. The average flow increased to 58 gpm in follow-up metering in February-April 2008. Daily instantaneous peak flows were regularly over 70 gpm in the October-December 2007 metering and over 150 gpm in the February-April 2008 metering. Infiltration was averaging 8 gpm.

In 2010 and early 2011, the Township replaced numerous damaged residential lateral caps and riser pipes in the upstream Bowtree Development. The Township also replaced all manhole lids in the Bowtree Development with lids with smaller leak-proof pick holes. The lateral and manhole lid problems had been visually observed by the Township to be significant sources of I/I.

Flows in the current metering period, which included a very wet period in August and September, are significantly decreased and much less variable than observed in 2007 and 2008, prior to rehabilitation. The average flow is now 12 gpm, and daily instantaneous peaks very rarely exceed 50 gpm. Little to no infiltration is present. There was one large inflow occurrence, which was during 6.5+ inches of precipitation during Hurricane Irene, when the flow peaked at 432 gpm, but the flow rate decreased quickly and returned to normal within 15 hours. There was only limited inflow during Tropical Storm Lee when the maximum

instantaneous flow was 106 gpm, significantly less than large storms in 2008 and January 2011 when the flows peaked at 263 gpm and 204 gpm respectively.

## Next 6 Months:

- Data from the permanent meter at Reservoir Road and Westtown Way will be reviewed to evaluate the effectiveness of the repairs in the Chester Creek Service Area.
- Data from the Ridley Creek Influent STP meter will continue to be reviewed to determine the effectiveness of repairs throughout the Ridley Creek Service Area.
- The temporary meter will remain in the New Kent location, as indicated in Corrective Action #1, to monitor any repairs that may be identified and performed in the upstream subbasin.

## 6. Corrective Action #6: House Lateral Investigation Program

The House Lateral Investigation Program ("HLIP") was implemented in conformance with the provisions of the HLIP contained in the February 28, 2008, letter from East Goshen.

## Previous 6 Months:

- Continued to replace cleanout caps at no charge to property owners in both the Ridley Creek and Chester Creek Service Areas upon request by property owners or observation by Public Works or Codes Department staff.
- Continued to repair defective laterals and cleanouts for the property owners to ensure that the work is done properly as indicated in Corrective Action #4.

## Next 6 Months:

- Continue to inspect sanitary sewer cleanouts/vents in conjunction with the televising efforts performed under Corrective Action #2.
- Continue Township policy regarding replacement of cleanouts, vent caps, and laterals.
- Continue re-occupancy inspections at the sale of property including looking for direct inflow from building sump pumps.
- Repair of defective laterals and cleanouts by the Township for property owners to ensure that the work is done properly.
