

Shipping on Mariner East

Propane

A byproduct of natural gas production, used for home heating, grills, portable stoves and automobiles. Also a key raw material for plastics. Over 95% of propane consumed in the US is produced in North America.

Ethane


A natural gas liquid that is further processed into ethylene and other byproducts to make textiles, plastics, detergents, coatings.

Butane

A natural gas liquid that is used in lighters, as a component of gasoline, and as a refrigerant in household refrigerators and freezers.




Mariner East Project: Chester County






Mariner East Project: East Goshen Township





Construction Methods – Conventional Cut




Conventional Cut Image

Safety and Engineering

- Sunoco Pipeline has been operating NGL pipelines safely for more than 50 years.
- We conduct rigorous testing of all pipes, new and existing, using the most advanced technologies available to analyze a pipeline's condition.
- Pipelines are tested with water at pressures above maximum operating pressure before being placed into service.
- Professional controllers monitor the pipeline's pressure, temperature and flow 24 hours a day, 7 days a week from a control center dedicated exclusively to safe pipeline operation, and operators can shut down the pipeline remotely.
- We patrol the pipeline route, or right-of-way, by ground and by air for any potential hazards.

The safety of Sunoco Logistics' (SXL) employees and the community is our highest priority as an organization, and we believe that no project is worth doing if it cannot be done safely.

Project Economic Impact

Mariner East is a \$3 billion private investment, capital project

- •\$1.8M in sales tax revenue in PA
- •\$100M+ in statewide annual economic impact in PA
- •30,000 jobs supported during construction
- •\$62M in total tax revenue during construction
- •300+ permanent jobs
- •\$23M in personal income tax revenue in PA
- •\$4.2B in positive economic impact to PA economy

- 2015
 - Land acquisition
 - Public open house meetings statewide
 - Public official outreach at state and local levels
 - Local municipality outreach
 - Initial construction activities commence
 - Mariner East 1 goes into full operation
- Q1 2016
 - Land preparation for construction
 - Ongoing local municipality outreach
 - Ongoing public landowner meetings
- Q2 2016
 - ME 2 full construction commences


