# Appendix B SCOPE OF WORK EAST GOSHEN TOWNSHIP STRATEGIC COMPREHENSIVE PLAN UPDATE

Date: November 14, 2014

The comprehensive plan update will be expanded to refine and complete an update to the comprehensive plan using data and mapping previously prepared by the Brandywine Conservancy (BC). The consultant under this Addendum shall be Thomas Comitta Associates (TCA). This scope shall be monitored by the Chester County Planning Commission (CCPC). The process will include considerable public participation, including in particular the affected landowners.

#### Task 1.1. Project Initiation and Comprehensive Plan Draft #1

1.1.1. TCA shall meet with the Task Force to discuss the proposed work, confirm the schedule, conduct a driving tour, and discuss observations from the driving tour. It is assumed that EGT can arrange for a bus with the School District, so that the Task Force, the Board of Supervisors, and other appointed officials can share insights and observations about existing conditions and a vision for the future.

Task deliverable: Schedule; Observations; Task Force Meeting #1

1.1.2. TCA shall review, analyze and interpret the Brandywine Conservancy (BC) materials, but "spring" from these materials to create a new and improved Rough Draft, including Appendices, but use an 11"x17" format. (Relative to the BC mapping, please see the list in Appendix A.)

TCA will review and analyze the BC Draft Report and shall create a new and improved text, and place detailed text and tables into Appendices. TCA shall utilize the Goals, Objectives, Recommendations format with photos, drawings, etc. on the right side of the page, and will outline all of the items required under Section 301 of the MPC for Comprehensive Plan contents.

Task deliverable: Rough Draft/Mock-Up of Relevant BC work products, enhanced with images on right side of 11"x17" sheets, including Appendices.

1.1.3. TCA shall meet with Township staff, and the CCPC to visualize and critique the materials retained from the BC in the Rough Draft, and the added TCA materials.

Task deliverable: Meeting and Discussion with Staff and CCPC.

#### Task 1.2. Refine the Comprehensive Plan Draft #1, and Create Comprehensive Plan Draft #2 and Draft #3

1.2.1. TCA shall utilize the work products previously prepared by the BC, and will supplement same with new and improved content as needed. TCA shall add missing information to the Task 1.1.2. Rough Draft and Appendices, including images, text, maps, and missing Sections, based on feedback from the Task 1.1.3. meeting. In so doing, TCA shall address all of the items required under Section 301 of the MPC for Comprehensive Plan contents.

Task deliverable: Revised Draft Report that will include the content requirements of Section 301 of the MPC, as follows:
