November 6, 2014

6 The regular meeting of the East Goshen Township Park and Recreation Commission was held on Thursday,
7 November 6, 2014 at the Township Building. The meeting was called to order by Vice Chairman PJ Viloski at

16 **CALL TO ORDER/PLEDGE OF ALLEGIANCE**

17 PJ led the Pledge of Allegiance.

18 PJ asked for a moment of silence to remember our troops & veterans.

19 PJ asked if anyone would be recording the meeting. There was no response.

21 **APPROVAL OF MINUTES**

22 1. PJ noted that the minutes of the October 2, 2014 meeting were approved.

24 **NEW BUSINESS**

25 1. Collette Extended Trip Proposal – Jason explained the proposal to offer extended trips (7-14 days) in
26 the U.S. and the world through the Collette travel service. The township would get a 10% of the final trip
27 cost. These trips appeal mainly to people 55+. The township would schedule a trip 6 months in advance.
28 At 7:45 the Commission had a conference call with Bruce Smith, Collette rep for our area. He mentioned
29 that Collette has been in business for many years. They have expert guides who meet the groups at the
30 airport. Joe asked for an example of a trip. Bruce commented that a good destination is the Western U.S.
31 to the national parks. Accommodations are in 4 star or better facilities. They also have National Park
32 Family tours – children have to be over 14 years old. They take about 44 people on a bus. They would still
33 go on the tour even if only 4 came from East Goshen because they have people from all over the US that
34 will fill the bus. When a tour is selected, Bruce would come and make a presentation and provide flyers
35 about the trip. The Commission agreed to pursue this.

37 **OLD BUSINESS**

38 1. Comprehensive Plan – Joe reported that the Comp Plan was to be updated but the BOS want to rewrite
39 it. The BOS has hired a new consultant and hope to start meetings in January 2015.
40 2. Open Space Plan – Jason feels that when the Open Space Plan is complete, a Master Plan for East
41 Goshen Park should be done. The Commission members will read the open space plan for the next
42 meeting.

44 **RECREATION DIRECTOR REPORT**

45 1. Harvest Festival – This event was held on Saturday Oct. 18 from 10am – 1 pm. PJ mentioned that the
46 event was awesome. There were events for kids and adults.
47 2. Tennis Courts – Jason reported that the 2 courts in the back (5 & 6) were not used this season. \$30,000
48 is available for repairs. The Commission agrees that the soft court surface should be removed. Jason will
49 prepare a survey to include in the Newsletter. Joe doesn't feel a survey will give a good result. However,
50 PJ feels it is a good option, which gives all residents information and the opportunity to respond.
51 3. Spray Park – Jason is looking into this. It could be installed near the tennis courts. There are some
52 grants. The concern is there may be too much noise.
53 4. Tot Lot – It needs lots of maintenance.

- 1 5. Tree Lighting – Friday, December 12, 2014, 5 to 6 pm. Jason mentioned there will be a 14 foot, bulb
- 2 tree that will be planted in the park. Also there will be music, Carmen will be Santa and the event will be
- 3 held in the parking lot.
- 4 6, Jason reported that program hours doubled this year.
- 5 7. Neighbor-to-neighbor day, November 15. Jason has 25 volunteers but only 1 house to help so far.
- 6 8. Jason is planning to start marketing the Summer Program in February 2015.
