35	justice with a minor in history.	Olean and Dion's House with Mark Miller	
36	2. Chris and Dolores did a walk thru the Blacksmith Shop and Plank House with Mark Miller.		
37 38	Things Mark will take care of in the BSS are: the pin in the double doors on the BSS falls out and sets off the alarm; spring on the floor vice; move the thermostat; and paint. Judy hasn't

- Misc Research Ed gave everyone a copy of the map of the Property Owners in East Goshen in 1777 that he worked on. The roads are shown in red (except Airport Road which he will remove). He will work on a map of 1817 for the celebration in 2017.
- 13 <u>Volunteer Program</u> Sue reported that several people filled out the volunteer forms and she
   14 contacted them. A date in April will be set up for training.
- Historic Properties List Judy pulled 18 files and labeled them Class 1(red labels) or Class 2

  (blue labels). When they are approved they will be scanned into the database. Chris commented
- that they took the top 10 to see if they were recognized by the federal and/or state governments
- which would make them Class 1. Class 2 is any property that was here during the Battle of the
- 19 Clouds. The properties will be put in order by TPN#. There are about 33 properties in Class 1
- and 2. The rest will be Class 3 for now and reviewed later. Judy mentioned that they will keep
- the files for the 3 properties that were removed from the list in 2014. She commended Ed for all the work he has done identifying historic properties.
- 23 Living History Day Ellen provided a list of people who will be part of this year's event on
- Saturday, June 6, 2015. The list was reviewed. The event needs to be put on the township website.

At this point, Marty Shane, chairman of the Board of Supervisors, stopped in to thank the members of the Commission for all the work they do to preserve the history of the township.

- 31 Questors Elizabeth DiTullio, President and Caroline Weisbecker, Vice President of the Local
- 32 Questors, Tredyffrin #3, were introduced. Liz explained that they study antiques and historic
- places; are national and international; and most of the members of #3 live in East Goshen. In the
- fall, they had a meeting in Historic Goshenville. She presented 25 lucets, which were used to
- 35 make cords, to the Commission. She also showed the Commission the new cover for their
- 36 booklet which has the Plank House on it. The Commission members were very grateful. Liz
- 37 mentioned that they would like to have a meeting again this fall at Historic Goshenville and
- 38 invite other Questor groups. She also said she discovered an early 1800s bible with the name
- 39 Hickman in it.
- 40 Quilting Judy reported that the quilt is ready for batting and backing.
- 41 MUSA Kathryn commented that the CCHPN is having a Spring Workshop on April 25. The
- Chairpersons of each municipality's Historic Commission will be invited. If the Chairperson
- can't attend, then the Vice Chair can come. It will be held at the Brandywine River Museum.
- 44 Some of the national officers will hold seminars about standards and guidelines, zoning, naming
- and designating historic places, etc. Chris can't attend but he will speak to Ellen.

Kathryn mentioned that the local annual dinner will be held on June 17, 2015 at the Grove United Methodist Church.
