EAST GOSHEN TOWNSHIP CONSERVANCY BOARD MEETING March 11, 2015 7:00 P.M.

The East Goshen Township Conservancy Board met for their regularly scheduled meeting on Wednesday, March 11, 2015 at the East Goshen Township Building. Board members present were: Chairman Walter Wujcik, Scott Sanders, Erich Meyer, Katharine Okie, Patti Brown, Sandra Snyder and John Scheidt. Others present were: Janet Emanuel, Township Supervisor.

CALL TO ORDER

Walter called the meeting to order at 7:00pm.

PLEDGE OF ALLEGIANCE

Walter led the Pledge of Allegiance and a moment of silence to remember our troops.

APPROVAL OF MINUTES

Walter noted that the minutes of the February 11, 2015 meeting were approved as corrected.

NEW BUSINESS

1. Wooded Lot - The Commission members reviewed the memo from Mark Gordon and the draft ordinance. Scott is concerned about "viable". Who determines viability? He mentioned that West Chester Borough has a check list for viability including balance, interior decay, structural integrity, die back, etc. Sandy suggested that viability should be determined by independent certified arborists for the Township and the developer. Scott explained that non-invasive plants/trees multiply faster than native and he doesn't think that term should be used. There was also a question about "troublesome trees". Erich checked the PA website which shows more definitions. Walter will send an email to Mark.
