Board members present were: Chairman Walter 9 Wujcik, Erich Meyer, Katharine Okie, Sandra Snyder, and John Scheidt. Others present were: Janet Emanuel, 10 Supervisor. 11 12 CALL TO ORDER 13 Walter called the meeting to order at 7:00pm. 14 PLEDGE OF ALLEGIANCE 15 16 Walter led the Pledge of Allegiance and a moment of silence to remember our troops. 17 18 APPROVAL OF MINUTES 19 Walter noted that the minutes of the July 8, 2015 meeting were approved as corrected. 20 **NEW BUSINESS** 21 22 1. 1641 Manley Road – According to Rick Smith's memo, there will be 21 trees available for planting as a result of the number of trees that were removed for this project. The Board members decided that 23 the trees will be planted along East Boot Road and they will walk the site on Saturday, September 12 to 24 mark the places with flags. Also, they will walk Clymer's Woods to check the YMCA trees and the 25 26 2011 Conservancy Board understory planting. Walter will send a memo to Rick Smith. 27 28 2. The CB will recommend evergreens and shrubs for the dumpster screening plants. Sandy made a motion to approve the land 35 development plan as presented, conditional upon the inclusion of evergreens/shrubs from the 36 Township's approved tree list with the exception of White Pine trees. Erich seconded the motion. The 37 motion passed unanimously. Dear Commission Members:

At their meeting on August 12, 2014 the Conservancy Board unanimously approved the following motion:

Mr. Chairman, I move that we recommend that the Planning Commission accept the Landscape screening proposed on the Goshen Village plans for the new Dunkin Donuts location proposed with the following conditions:

- 1. Eastern white pines shall not be used as a landscape screening species for this project.
- 2. Arborvitae is acceptable for the drive thru screening so long as a deer resistant variety such as the Green Giant is used.
- 3. The evergreen screening for the garbage dumpster enclosure shall be consistent with the Township Tree Resolution and not include species identified as invasive plants in the east Goshen Township code. These evergreen plantings shall be diversified.
