This letter is being sent to inform you of three new online resources dealing with Natural Resources and Protected Open Space in Chester County.

The Chester County Natural Heritage Inventory

In September 2015 the Planning Commission received the final draft of the *Chester County Natural Heritage Inventory*. The *Inventory* was completed by staff of the Western Pennsylvania Conservancy following two years of research and field work. This effort was funded by the Pennsylvania Department of Conservation and Natural Resources as part of Pennsylvania Natural Heritage Program. This new inventory replaces the now outdated *2010 Natural Areas Inventory*.

The Chester County Natural Heritage Inventory 2015 presents extensive mapping and descriptions of the locations of rare plants and animals called "sensitive species." These species include a variety of organisms that have been specially designated by state or federal agencies. The Inventory is useful to landowners who wish to know if sensitive species exist or are likely to exist on their property.

The new inventory is 606 pages long, making it rather unwieldy to send through the mail. Instead, the Planning Commission has posted it on line at

http://www.landscapes2.org/psd/Natural/inventories.cfm in two formats. A 55-page inventory summary can be viewed or downloaded as a pdf, or the entire document can be viewed or downloaded. Mapping showing the sensitive species sites can be viewed at a web page managed by the Pennsylvania Natural Heritage Program located here: http://www.naturalheritage.state.pa.us/ under "County Inventory Interactive Map." If you are working on a large scale project that requires GIS mapping of sensitive species as delineated in the inventory, please contact Jake Michael at jmichael@chesco.org or 610-344-6503.

Natural Resource Protection Model Standards

In 2015, the Planning Commission partnered with the Brandywine Conservancy to develop a set of natural resource protection standards. These standards were based on effective zoning ordinance regulations that were adopted within several municipalities within the Brandywine Creek watershed. Additional modifications and notes were then added so the standards could be adapted for use by other municipalities. The natural resource protection standards present a template for addressing the

minimum protection needed for natural resources under ideal conditions. These standards can be viewed or downloaded by going to the Planning Commission's Natural Resources Web Page http://www.landscapes2.org/psd/NatResources.cfm and clicking on "Natural Resource Protection Tools," or by visiting the Brandywine Conservancy's website at http://www.brandywinegreenway.org/files.php.

Updating the Protected Open Space Tracking (POST) System

In 2002, following the adoption of *Linking Landscapes*, the Chester County Planning Commission (CCPC) began to inventory protected open spaces on an annual basis. In recent years, this inventory has been conducted using POST, which is a database managed by the Planning Commission. This database is linked to the County's tax assessment database for land parcels. In 2016, the computer program used by the County to view both the POST and the assessment database will be updated. To accommodate this change, the POST database format will also be changed.

As part of this transition, the Planning Commission will update its Chester County Protected Open Space Information Center web page

(http://www.landscapes2.org/ccpc/openspace/OpenSpaceInfo.cfm). These new changes will make it easier for outside organizations like yours to view and download spreadsheets and maps of protected open space in Chester County. This web site will also include a new section that can be used to submit new information about the parcels your organization protects. During the coming months, you will be contacted about the update to POST, and notified when it is made available for use on the Planning Commission's web page.

As you know The Township has received a SD Plan for 930 N. Chester Rd. This 4 acre parcel is proposed to be subdivided into two lots. The applicant is seeking your recommendation for approval for the plan. The applicant is seeking a waiver from the requirement to submit a Landscape Plan. The concern is that while the location of the house is depicted on the plan, the actual footprint may change based on the desires of the builder or new owner. In the past applicant who have been granted a waiver from the LS Plan have listed the species to be planted on the final plan and submitted a LS plan at a later date

It is the opinion of the Staff and the Planning Commission that the configuration of the landscape plantings around the home is not as critical as the varieties and number of plants proposed.
