15 Chairman, Thomas Kilburn called the meeting to order. The Committee began the meeting with the

22 Rogers Vaughn Report on Town Center

23 Rogers Vaughn met with Senya Isayeff to have a discussion regarding the Town Center. He said that  
24 people need to see pictures (visualization) of the Town Center Project. The Township plans to install a  
25 walking corridor and clean up the area along Paoli Pike and install lighting and put in better signage.  
26 Trees will also be planted in the corridor. They would like to meet with the owner of Goshen Village  
27 Shopping Center and show him the pictures of improvements that are to be made. A walking trail will  
28 be installed along Paoli Pike and this should improve the area along Paoli Pike and this would help the  
29 business establishments.

31 Brad Giresi Paoli Pike Trail & Towne Center Presentation

32 Brad Giresi reported that a goal for the Planning Commission is to have Paoli Pike a walkable connective  
33 artery. This would include improvements with the Town Center which would include better lighting be  
34 installed and trees planted. He stated that there are grant opportunities for Planning Stages. Brad said  
35 that the Planning Commission would like to continue to use McMahon Associates for the planning  
36 stages. Workshop sessions would be held to go over signage, lighting, walking and bike trail plans.
