7 Chairman, Thomas Kilburn, Vice Chairman, Rogers Vaughn and member Luann Petrellis were present.

10 Call to Order

11 Chairman, Thomas Kilburn called the meeting to order. The Committee began the meeting with the  
12 Pledge of Allegiance and there was a moment of Silence for our military troops.

14 Approval of Minutes

15 Chairman, Tom Kilburn presented the motion that the 2016 March Minutes be approved. Rogers  
16 Vaughn seconded the motion and the 2016 March Minutes were approved by the Futurist Committee.

18 Goshen Village Town Center Project

19 Rogers Vaughn spoke with Senya Isayeff regarding the Futurist Committee's recommendations for the  
20 Goshen Village Shopping Center. He stated that visuals of the proposed plans be presented to the owner  
21 of the Shopping Center. This would include improved lighting, proper signage, and new plantings in the  
22 area. This area is going to have a new trail that will be installed by 2018. He said that investors and  
23 residents would see a vast improvement in the area. The Committee would like to give a proposal for  
24 the May 3, 2016 to Board of Supervisors Meeting to fund graphic visualization of potential changes to  
25 the Goshen Village Shopping Center. Brad Giresi suggested applying for a grant and that project would  
26 fall into a Trail/Street scape project. The cost for a trail/street Scape project would be five to 10  
27 thousand dollars. Brad Giresi told the Commission that this project would come under the  
28 Comprehensive Plan to lay out the Paoli Pike Trail Plan and have coordinate signage for that area.

30 Position on the Futurist Committee

31 Thomas Kilburn spoke with Senya Isayeff and Adam Knox and they were favorable for Brad Giresi serving  
32 on the Futurist Committee.

34 Meeting with West Chester University Economic Department

35 The Futurist Committee will be meeting with representatives from the West Chester University  
36 Economics Department on April 27, at 10 a.m. to discuss having a data base for a measurement project  
37 on the sales of homes in various developments in East Goshen Township.

39 Update on Projects in the Township

40 Mr. Kilburn updated the Board that the Township received grant money for a million dollars for the Trail.  
41 The tot lot work in East Goshen Township Park is continuing. West Chester University is look for  
42 additional classroom space and Mr. Kilburn asked the Board if they know of any office space that would  
43 be available.
