Re: Comparison of 70/30 v. 60/40 asset allocation

Date: October 10, 2016

At the May 24, 2016, Pension Committee meeting I was asked to compare the difference in returns between a portfolio invested 60/40 in equities/fixed income and one invested 70/30 over a five year time horizon.

If you had invested \$100 in the Township's Defined Contribution Plan (which is invested 60/40) on January 1, 2012, you would have had \$154.37 as of September 30, 2016, a return of 54.37%. By contrast, if you had invested \$100 in the Township's frozen Defined Benefit Plan (which is invested 70/30) over this same period of time, you would have had \$156.72 as of September 30, 2016, a return of 56.72%, or 2.35% more than the 60/40 allocation.

Great meeting today.

Because we're not meeting again until late October and we're likely to forget about it by then, I wanted to update folks on the DC plan statement issue that came up. I spoke with Jim Kennedy at Anderson. Basically, the statements are generated by an Excel macro that could be screwed up if he were to change everything around. That said, the three main data point that we talked about:

- % return annually over past 5 years
- Individualized balance as of 12/31 for the past 5 years
- Whether the employee is part of the DB plan and, if so, their monthly payments at age 65

we already have at our finger tips, so we could easily generate a 2nd page to the statement in-house. This would require an hour or so of my or Tia's time on formatting and data entry in February or March of 2017. In future years, it would only require 5-10 minutes. So this is an easy fix.



Portfolio Value (millions)









Portfolio Value (millions)













Portfolio Value (thousands)




