The meeting was called to order by Chairman Joe Zulli at 7 8 7:00 pm. 9 Commission members present were: Christine Taraborelli 10 Ed Covle 11 Deborah Snyder 12 Peter Knupp 13 Dan Leicht - New member 14 Others present were: 15 Jason Lang, Director of Recreation 16 Jon Altshul, Township CFO 17 18 Carmen Battavio, Township Supervisor 19 20 CALL TO ORDER/PLEDGE OF ALLEGIANCE Joe led the Pledge of Allegiance. 21 22 Joe asked for a moment of silence to remember our troops & veterans. Joe asked if anyone would be recording the meeting. There was no response. 23 24 25 APPROVAL OF MINUTES 1. The minutes of the September 1, 2016 meeting were approved as amended. 26 27 28 **NEW BUSINESS** 29 None 30 31 **OLD BUSINESS** 1. Applebrook Park Restroom - Jon reported that he and Rick Smith met with the Finance Committee to 32 discuss restrooms for Applebrook Park. The Finance Committee feels there is no way to get accurate data 33 regarding the need for this. They want to install a portable restroom with a fence around it and a meter on the door 34 which would count the times the restroom was used. The cost for this is about \$4,000. It will be installed next 35 36 spring and will be there for spring summer and fall. Ed pointed out that a sign should be put on it so people know they can use it. Carmen suggested that members from Park & Rec, Conservancy Board, Historic Commission and 37 Jason should meet at the park to select 2 locations for the BOS to consider for this restroom. 38 2. Tennis Courts – Jon reported that the 3 front tennis courts are used frequently. Of the \$30,000 in the 39 40 budget, \$20,000 will be used to resurface the front courts and \$10,000 will be used to finish the back court. 3. Community Day – The budget for this event was \$35,000. The cost will be about \$29,000. The 41 fireworks were about \$9,000. 42 4. Paoli Pike Trail – Jason encouraged commission members to attend the BOS meeting on October 18. 43 Jon put together a detailed spreadsheet showing all of the improvements to be made in the township over the next 44

improvements.
5. Corridor Committee - Ed attended this meeting on September 12. It will include Paoli Pike from
Boot road to Rt. 352 and will work on making connections from the surrounding neighborhoods. The next meeting
is October 24 and will be a meeting for the public. Carmen mentioned that the BOS wants to include residents

6. <u>East Goshen Park Playground</u> – Jason reported that the estimated cost is \$715,000. They applied for 2 grants – 1 for \$300,000 and 1 for \$250,000. They should know by November. In January they will start the process of selecting a planner and equipment company.

7. 2017 Budget – Jason reviewed the proposed budget for 2017 which includes a 3% increase. The commission members approved it.

NEW BUSINESS

1. MyREC – Jason explained that the township wanted a way for people to sign up for programs on line. They first used AMS who runs the accounting program for the township. After 6 months they hired MyRec and the program was done in 2 weeks. Residents can sign their family up online and pay for programs online. It also matches events to the proper age groups. People can still mail in or bring in registrations too. Now Jason can enter these registrations so the data will be current. Cost of programs will increase by \$5.00 to pay for this.

RECREATION DIRECTOR REPORT

- 1. <u>Pumpkin Fest</u> This will be held next Saturday October 15, raindate Sunday October 16. The Goshen Fire Company will direct the traffic. Jason still needs volunteers.
- 2. <u>Young Women's Leadership meeting</u> will be held on Monday November 7. Jason has 3 speakers. There is room for 75. He has 40 signed up.
- 3. End of Year Summer Report Summer Camp The ½ day camp had a .5% decline. The full day camp had an increase of 36%. Next year Jason plans to expand the full day camp to 5 weeks and 7 am to 5 pm. The maximum is 30 kids. In 2018 the elementary school will be unavailable due to renovations.
- Star Wars was a hit! There were 746 participants in fee based summer programs, which generated \$7,500 in revenue. The total participants in other summer programs was 8,700. He took a photo of a monarch butterfly in the Butterfly Garden this week.
- 4. <u>Stones</u> Philly Stones League This is a course similar to Bocci that the Kinka family has developed. They have a course in New York and in Fairmount Park. Two members live in East Goshen. They use green spaces that aren't normally used. In East Goshen Park a temporary course was set up near the new path to the tennis courts. This is for 30-45 year old residents. November 5 will be a trial event.
- 5. NRPA Gold Medal Application Jason explained that this is a national award and Pennsylvania has never received it. East Goshen would be in the under 30,000 population category. He reviewed the lengthy application and asked the Commission members to come with ideas next month. Next spring they will announce the finalists and Jason would like East Goshen to be a finalist.

PARK MAINTENANCE REPORT

Mark may start on the tennis court this year. Fencing and railings have been delivered. They are getting the park ready for the Pumpkin Fest.

ANY OTHER MATTER

1. Carmen mentioned that at the BOS meeting the 5 members took a poll of what is a priority – park, trail or dams. He pointed out to them that East Goshen Park has been here a long time and needs to be upgraded. They all agreed that the park is the priority.
