In 9 attendance were: Chairman Sandy Snyder, Erich Meyer, Andy Tyler, Walter Wujcik 10 and Janet Emanuel, Township Supervisor. 11 12 Call to Order 13 Sandy called the meeting to order at 7:00 p.m. 14 15 Pledge of Allegiance & Moment of Silence 16 Sandy led those present in the Pledge of Allegiance and then asked for a moment of 17 silence to remember those who serve in our military and our first responders. 18 19 20 The minutes of the October 12, 2016 meeting were approved as corrected. 21 22 **New Business** 23 Fall Planting Proposal - Erich presented a proposal for the fall planting showing 24 prices which include labor for planting by a landscaper. After discussion, Walter 25 moved to plant 16 trees (2 Tulip Poplar \$260 ea; 8 Kawasan Cherry \$280 ea; and 6 26 River Birch \$260 ea.) to be split between East Boot Road and Clymers Woods for a 27 total cost of \$4,320. Erich seconded the motion. After further discussion, Erich 28 amended the motion to include 2 Hemlocks \$280 each for a total cost of \$4,840. 29 Andy seconded the motion to amend. The motion passed unanimously. 30 The Board members will meet on Saturday November 12, 2016 at 9:00 am at the 31 Plank House to stake the areas for the planting. Sandy sent a request to Mark Miller 32 to have the south side of East Boot Road mowed for the planting. 33 34 **Old Business** 35 <u>Clymers Woods</u> – Andy and Patti went to Clymers Woods and took pictures of the 36 area. There are several dead trees that should be removed. 37 38 ANY OTHER MATTER 39 1. Erich reported that there is a beaver dam in the creek going into the reservoir. Rick Smith asked the Board members to take a look at it. 40 41 2. At the December meeting the Board will review the 2016 goals and set goals for 42 2017 in preparation for the ABC meeting in January. 43 44 45 46
