**Smart 911** - Smart911 is a new service in Chester County that allows you to create a Safety Profile at [www.smart911.com](http://www.smart911.com) that includes details you want the 9-1-1 center and public safety response teams to know about your household in an emergency. When you dial 9-1-1, from a phone associated with your Safety Profile that information automatically displays to the 9-1-1 call taker allowing them to send responders based on up-to-date location and emergency information. With your Safety Profile, responders can arrive aware of many details they would not otherwise know. Fire crews can arrive knowing exactly how many people live in your home and where the bedrooms are located. EMS personnel can know family members’ allergies or specific medical conditions. And police can access a photo of a missing family member in seconds rather than minutes or hours, helping the search start faster.

Re: Sunoco Citations

The Township has issued seven citations to Sunoco for violations of the Township Noise Ordinance. The court hearing on these citations is scheduled for January 10<sup>th</sup> at 2:00 pm.

The attorney for Sunoco requested a meeting to see if an “amicable resolution” could be reached with respect to the citations. A meeting with representatives from the Township and Sunoco and the respective attorneys was scheduled for January 4<sup>th</sup>. Any “amicable resolution” would require formal approval by the Board at a public meeting.

Unfortunately, recent developments with the Sunoco project resulted in the cancelation of the January 4<sup>th</sup> meeting and Sunoco has requested a continuance for the court hearing.

We advised Sunoco that the Board would have to approve any continuance at a public meeting.

The attorneys are attempting to come up with new dates for a meeting with Sunoco and the court hearing in the event the Board wants to agree to a continuance and see if an “amicable resolution” can be reached.
