In attendance were: 9 Chairman Erich Meyer, Sandy Snyder, Walter Wujcik, Patti Brown, and Scott Sanders. 10 Others in attendance: Mike Lynch, Township Supervisor. 11 12 Call to Order 13 Erich called the meeting to order at 7:00 p.m. 14 15 Pledge of Allegiance & Moment of Silence 16 Erich led those present in the Pledge of Allegiance and then asked for a moment of silence to 17 remember those who serve in our military and our first responders. 18 19 **Minutes** 20 The minutes of the December 13, 2017 meeting were approved. 21 22 **Zoning Hearing Board Notices** 23 Erich acknowledged receipt of the notices for 1665 E. Boot Road and the Malvern Institute. 24 25 **New Business** 26 1. Keep East Goshen Beautiful - The Board members agreed to have this event on Saturday, 27 April 21, 2018. April 22nd is Earth Day. Erich will notify Township staff so it can be put on 28 the Township calendar and the electronic board. Sandy suggested editing last year's flyer 29 and putting it in the next Newsletter. 30 2. Spring Planting – Several locations were discussed. Erich reviewed the type of trees that 31 were planted in November along E. Boot Road. The Board members were very happy with 32 the trees from Sam Brown Nursery. On Saturday March 17, 2018 the Board members will 33 walk the area along E. Boot Road to check the trees and see what needs to be done. Mark 34 Miller will be asked to make a PA 1 call for Clymers Woods so the Board can continue to 35 work there. 36 3. Pond Study - Mike mentioned that this study should be done by the end of January. Rick Smith will ask Toth Brothers to prioritize the Ponds. The Board of Supervisors plans to set 37 up 3 committees for residents from the 3 areas, Hershey Mill Estates, Bow Tree and 38 39 Marydell/Pin Oaks. They also want input from the Conservancy Board. Rain Gardens were 40 discussed. Scott suggested using a pond that is accessible and put signs up that describe 41 what is being done and why. Mike suggested that a representative from Toth Brothers 42 attend a CB meeting. Sandy suggested adding the Pond Study as an agenda item. 43 44 **Old Business** 45 Serpentine Rock - Sandy spoke with Jason Lang about this project. The CB will take the 46 lead on this project. Need to contact Mark Miller about doing a burn. 47



GRANT OPPORTUNITY DEADLINE EXTENDED TO MARCH 31, 2018

Over the years, numerous municipalities, regional recreational authorities and nonprofits in southeastern Pennsylvania have undertaken a variety of open space projects. Recognizing the importance of these initiatives to preserve open land, PECO is partnering with Natural Lands to provide grants to assist in these efforts. Eligible applicants include municipalities and regional recreational authorities within PECO's service territory (Bucks, Chester, Delaware, Montgomery, Philadelphia, and York). Within the City of Philadelphia, incorporated nonprofit neighborhood organizations are also eligible.

Through PECO Green Region, PECO makes grants in amounts up to \$10,000. As the enclosed brochure outlines, the grants can be used with other funding sources to cover expenses such as consulting fees, trail construction, land acquisition, habitat improvement, and the cost of creating and implementing an open space plan. Since Green Region's inception in 2004, we have awarded nearly \$1.9 million across the region for a wide range of open space projects.

A committee made up of county, conservation, and PECO representatives reviews proposals and awards grants each year. The new postmark deadline for submitting funding requests is March 31, 2018.

If you have an eligible project and weren't able to submit an application in time, we hope you'll do so now. If you have a project that still isn't quite ready, please keep in mind that the next grant round will open in September 2018 with applications due by the end of the year. We hope that PECO Green Region funds will make a real difference as you work to preserve and protect farmland, watersheds, parks, and trails for this and future generations.

n recent years, many townships and municipalities in southeastern Pennsylvania have approved open space referenda to preserve and protect farmland, parks and trails, and watersheds.

PECO is committed to assisting southeastern Pennsylvania's municipalities, recreational authorities, and nonprofits (within the City of Philadelphia) with ongoing efforts to preserve, protect, and improve open space.







hrough its Green Region program initiated in 2004, PECO has awarded 246 grants, totaling \$1.9 million, to support open space and environmental projects throughout its service area. The grants have saved more than 420 acres of open space, supported more than 100 upgrades to local parks, built or improved more than 15.5 miles of trails, and helped protect endangered species.

Green Region grants are available in amounts up to \$10,000. The grants can be used with other funding sources to cover a wide variety of planning and direct expenses associated with developing and implementing open space programs, including consulting fees, surveys, environmental assessments, habitat improvement, and capital improvements for passive recreation.



Green Region review committee made up of county, conservation, and PECO representatives consider all funding proposals and make grant awards.
