MOTION OF EAST GOSHEN TOWNSHIP TO INTERVENE OUT OF TIME

Pursuant to Rules 212 and 214 of the Federal Energy Regulatory Commission's (Commission) Rules of Practice and Procedure, 18 C.F.R. §§ 385.212 and 214 (2007), East Goshen Township (EGT) files this Motion to Intervene Out of Time, in the above referenced proceeding.

On January 11, 2018, Adelphia Gateway LLC (Adelphia) filed its Application under Section 7 of the Natural Gas Act, 15 U.S. C. § 717(f), and Section 157 of the Commission's Regulations, 18 C.F.R. § 157.1 *et seq.*, for its proposed pipeline project, at FERC Docket No. CP18-46-000. Adelphia seeks, *inter alia*, to 1) acquire, own and operate the existing pipeline system and related facilities in the Commonwealth of Pennsylvania that are currently operated by Interstate Energy Company LLC (IEC), 2) construct, own and operate certain compression facilities and pipeline facilities in Commonwealth of Pennsylvania and 3) construct, install, own and operate certain other appurtenant facilities (Project).

II. INTEREST OF THE PETITIONER

In support of its Motion, EGT states that it is a township located in Chester County, Pennsylvania and comprised of 10 square miles, with a population of 18,026 at the time of the 2010 census. IEC's pipeline system currently runs through East Goshen Township and a mainline valve site currently exists at Paoli Pike. EGT seeks to intervene because it has a responsibility to plan for and participate in the protection of its assets and resources as well as the obligation to protect the public health, safety and welfare of its residents. EGT will be directly affected by the outcome of this proceeding. EGT's intervention in this proceeding is in the public interest.


