NEW BUSINESS

- 1. Reorganization for 2019 Chris nominated Dan for Chairman; Chris nominated Debbie as Vice-Chairman; and Dan nominated Peter for Secretary. The vote was unanimous.
- Jason thanked Chris for her 2 years as Chairman and for all of her help with the new playground.
- 2. Chalk in the Park Jason introduced Daniel Rumsey, 446 Barker Dr. Daniel is a member of the National Honor Society at East High School and has to complete 20 hours of volunteer work. He has helped with Keep East Goshen Beautiful Day. He is a chalk artist and would like to spread Art in the Park and include kids. - 3. Goals for 2019 Jason reviewed the goals he listed for 2019. They are from the Comprehensive Plan #8.6 Increase pedestrian circulation and 9.3 Maintain and Upgrade East Goshen Park. From the Park & Recreation Open Space Plan, 1.5A Nature Programming; 1.6A Art in the Park; and 4.4A Formal Volunteer Program. The commission members discussed and gave some suggestions. Jason will present the Goals at the Annual ABC Meeting on Saturday January 12, 2019 at 8:00 am.
- 4. Food Truck and Music Festival This event will be held on August 24, 2019. Jason explained that he would like to have a "Beer Garden" this year. He spoke to several townships and found that most of them have a fenced in area where people must drink and a uniformed policeman. He reviewed the maps with the proposed layouts. He sent out the applications to the food trucks, which have to be back to him by February 1st. The Commission approved this. Jason will present it for approval to the Board of Supervisors.
- 5. Friends of East Goshen Jason explained what this group does. They only have 2 members and need 3 more. They are looking for volunteers.
