HISTORICAL COMMISSION MEETING
February 13, 2019

The East Goshen Township Historical Commission held a regularly scheduled meeting on Wednesday, February 13, 2019 at 7:00 p.m. at the Township Building. In attendance were: Chairman Ted Roberts, Chuck Proctor, Ed Lendrat, Mary Urbine, Kelly Bidegary, Kathleen Lynch, new member Lazarus Zarogiannis and Mark Gordon (Township Zoning Officer).

Call to Order – Ted called the meeting to order.

Old Business

1. **Sullivan House** – Chuck met with the Hershey Mill Board. In the past, they thought there would be restrictions if the Sullivan House was on the list of historic assets. After discussion with Chuck, they agreed to add it to the list. Chuck also took 2 of the ornaments and they were excited about it and want to be on the second ornament. They will help market it too. Chuck wants to meet with the Sullivan House Board at their meeting in April. Ted and Mark will go with him.

2. **Mission Statement** – Ted likes to keep things simple. He suggested the following: The Historical Commission’s mission is to protect, preserve and promote the history of East Goshen Township. This will be discussed at the March Meeting.
