Mission Statement - Ted proposed a mission statement. After some discussion the 21 Commission members approved the following: To preserve, protect and promote the 22 historical aspects of East Goshen Township. 23 24 2. Sullivan House - Chuck mentioned that he has a meeting with Ed McFalls scheduled for 25 April 2nd at 10:00 am to discuss the Sullivan House. He already met with the Hershey Mill 26 Board and they agreed to add the Sullivan House to our historic asset list. Ghost Walk - Ted feels this will be a good event in the fall. They can work with Park & 31 Recreation. They can have story tellers, games for the children, etc. Laz will talk with Jason 32 Lang about it. 33 34 4. Newsletter Schedule - Ted led discussion about the newsletter.
