30 Commission pertaining to zoning classification on Paoli Pike which would be overlay or district  
31 zoning. The Planning Commission currently is working on parking standards and 15 feet setbacks.

34 Tom Kilburn reported that the pathway project at Applebrook will get started sometime this summer.

36 **Streetscape**

37 Tom Kilburn reported that Jon Altshul has been working on finances for the streetscape on Paoli Pike.
