Michelle Truitt who is a 11 candidate for the Board of Supervisors position attended the meeting. 12 13 Approval of May 16, 2019 Minutes 14 Tom Kilburn presented the motion that the May 16, 2019 minutes be approved. Rod Vaughn seconded the motion and the minutes were approved by the Futurist Committee. 15 16 17 **Overview of the Futurist Committee** 18 Tom welcomed Michelle Truitt to the Futurist Committee meeting. Mr. Kilburn and Mr. Vaughn gave a 19 history of what the objectives the Futurist Committee plans to pursue. The Futurist Committee is 20 promoting the idea of having a Town Center along the area of Paoli Pike between Boot Road and Route 21 352. They hope to improve the streetscape area along the road when the trail is installed. They hope to 22 have lights installed and banners at sections on Paoli Pike. The Committee would like to see 23 neighborhood trails installed after the main trail is complete This would include trails from Bow Tree, 24 Marydell and Reservoir Road areas. The Committee is interested in improving the area in the Shopping 25 Center and along Paoli Pike and Route 352 to have a town center when the properties go on the market. They would like to see a couple of restaurants be included in the Town Center. An idea that was added 26 27 to improve the area was to have commercial and residential such as townhomes and apartments. 28 Letters have been sent to ABC members informing them of this project. Brad Giresi who is also the 29 Planning Commission Chairman told Mrs. Truitt about the proposed zoning changes along this area; if 30 they would like to have it as a district or have a zoning overlay. Mrs. Truitt was very receptive to what 31 the Committee members discussed with her. She said that the Futurist Committee was very 32 informative. 33 34 Streetscape Project 35 Board of Supervisors Chairwoman, Janet Emanuel suggested that the streetscape work be done after 36 the trail has been installed. 37 38 39 40
