**Present**

The following members were present at the June 18, 2019 Futurist Committee Meeting and they were Chairman, Tom Kilburn, Vice Chairman, Rod Vaughn and member Brad Giresi. Michelle Truitt who is a candidate for the Board of Supervisors position attended the meeting.

**Approval of May 16, 2019 Minutes**

Tom Kilburn presented the motion that the May 16, 2019 minutes be approved. Rod Vaughn seconded the motion and the minutes were approved by the Futurist Committee.

**Overview of the Futurist Committee**

Tom welcomed Michelle Truitt to the Futurist Committee meeting. Mr. Kilburn and Mr. Vaughn gave a history of what the objectives the Futurist Committee plans to pursue. The Futurist Committee is promoting the idea of having a Town Center along the area of Paoli Pike between Boot Road and Route 352. They hope to improve the streetscape area along the road when the trail is installed. They hope to have lights installed and banners at sections on Paoli Pike. The Committee would like to see neighborhood trails installed after the main trail is complete This would include trails from Bow Tree, Marydell and Reservoir Road areas. The Committee is interested in improving the area in the Shopping Center and along Paoli Pike and Route 352 to have a town center when the properties go on the market. They would like to see a couple of restaurants be included in the Town Center. An idea that was added to improve the area was to have commercial and residential such as townhomes and apartments. Letters have been sent to ABC members informing them of this project. Brad Giresi who is also the Planning Commission Chairman told Mrs. Truitt about the proposed zoning changes along this area; if they would like to have it as a district or have a zoning overlay. Mrs. Truitt was very receptive to what the Committee members discussed with her. She said that the Futurist Committee was very informative.

**Streetscape Project**

Board of Supervisors Chairwoman, Janet Emanuel suggested that the streetscape work be done after the trail has been installed.
