ReadyChesco - Chester County offers an emergency notification system called ReadyChesco, which notifies residents about public safety emergencies in the area via text, email and cell phone call. Signing up is a great way to keep you and your loved ones safe when disaster strikes. Visit www.readychesco.org to sign up today!

Smart 911 – Smart 911 is a new service in Chester County that allows you to create a Safety Profile at www.smart911.com that includes details you want the 9-1-1 center and public safety response teams to know about your household in an emergency. When you dial 9-1-1, from a phone associated with your Safety Profile that information automatically displays to the 9-1-1 call taker allowing them to send responders based on up-to-date location and emergency information. With your Safety Profile, responders can arrive aware of many details they would not otherwise know. Fire crews can arrive knowing exactly how many people live in your home and where the bedrooms are located. EMS personnel can know family members' allergies or specific medical conditions. And police can access a photo of a missing family member in seconds rather than minutes or hours, helping the search start faster.

Dear Property Owner:

On December 19, 2017, the Board of Supervisors adopted the *Paoli Pike Corridor Master Plan*. The vision of this plan is "to make Paoli Pike a destination," and this vision is supported by the following four interrelated goals:

- Connect people to the Paoli Pike Trail and other places along the corridor to support alternative modes
 of transportation and expand opportunities for recreation
- Calm traffic along the Paoli Pike Corridor to create a safe and comfortable environment for walking, biking, and driving
- Enhance Goshenville to support commerce and promote compact, mixed-use, walkable development with appropriate amenities in the area generally bounded by Paoli Pike, Boot Road, and North Chester Road
- Activate the corridor through programs and community events to encourage people to walk, bike, eat, shop, and play along Paoli Pike

One of the cornerstones of the goal to "enhance Goshenville" is the revision of the Zoning Ordinance and Subdivision Ordinance. The, Board of Supervisors tasked the Township Planning Commission with developing ordinances to accomplish this goal. They have completed their task and the Board of Supervisors will hold a public informational meeting to present the proposed ordinances and solicit comments from Township residents.

The proposed ordinances affect a number of properties, so pursuant to Township policy, property owners within 1,000 feet of these properties are being notified of this meeting.

The Board of Supervisors will hold an informational meeting on Tuesday, October 22, 2019, at 7:00 PM to discuss this proposal.

Township meetings are held at the Township Building and are open to the public. The Paoli Pike Master Corridor Plan and the proposed ordinances are posted on the Township website and are available for review during normal business hours at the Township building.

Dear East Goshen Board of Supervisors,

As we continue to look to the future, our committee has spent the last several years researching and evaluating the steps that communities similar to ours need to take to prepare for the next 10-20 years. Our goal has been to determine which areas are leveraging to the future of East Goshen.

East Goshen is fortunate to have numerous assets that position us favorably for the future when compared to our neighboring communities:

- We have attractive neighborhoods offering varied housing types.
- We are well situated geographically with a vibrant business park.
- We have an amazing recreational park and programs that provide many active opportunities for residents of all ages.
- We will soon have a pedestrian and bike cross-township paved trail that will tie many of the above mentioned areas together.

What East Goshen lacks and what would set us apart from many other communities in our area is an attractive and vibrant Town Center-a place that would provide a strong sense of identity and a place for people to gather. In addition this Town Center would add value to the investment in our homes as East Goshen becomes a more vibrant community. It is important that the township add amenities so that we can compete with neighboring communities that attract new home buyers because they can offer new homes.

The Paoli Pike Master Plan, which was developed by a varied cross section of township volunteers, provides us a vision of what this Town Center could look like. A Town Center would include small shops, restaurants, specialty food stores and micro-businesses, just to name a few. It would be an attractive area that would include green spaces and public plazas. This area would be an extension of our beautiful park and provide an added centerpiece for community events and gatherings. It could offer a new level of personal interaction in the heart of our community. In addition, the vision for a Town Center lays out plans to add street trees, landscaping and lighting that would be as appealing as in our neighborhoods, bringing beauty to our center and differentiating East Goshen from our neighboring communities.

The first step in the implementation of the Town Center plan is to provide a framework for posible redevelopment as properties come on the market. The proposed Traditional Neighborhood Development Districts plan(TND) provides these guidelines. The Planning Committee has spent over a year

considering many options and have incorporated feedback provided from interested residents. Now is the time to adopt the proposed TND plan to insure that the Paoli Pike Cooridor is developed in a responsible manner and will add value to all resident properties in the future.

Thank you for your consideration and especially for your ongoing committment to responsible governance of East Goshen.
