On December 20, 2019, the Federal Energy Regulatory Commission (“Commission”) issued an order in Docket Nos. CP18-46-000 and -001, authorizing Adelphia Gateway, LLC (“Adelphia”) to acquire, construct, and operate certain pipeline facilities and for related authorizations (“Certificate Order”).<sup>1</sup> The Certificate Order provides Adelphia the authority, among other authorizations, to acquire and operate certain facilities by means of a purchase of Interstate Energy Company LLC’s membership interests (the “Acquisition”).<sup>2</sup> Pursuant to Ordering Paragraph (B)(2) of the Certificate Order and Section 157.20(c)(2) of the Commission’s regulations,<sup>3</sup> Adelphia hereby notifies the Commission that on January 13, 2020, Adelphia completed the Acquisition. Immediately upon completing the Acquisition, Adelphia began authorized service on the Adelphia Zone North facilities.
