#### **NEW BUSINESS**

- 1. <u>Eagle Scout Project</u> Rian Gionfriddo presented his proposal to install Bocce courts in East Goshen Park. He is a member of Troop 93. He spoke about the sizes of the courts and materials that would be used. The estimated cost is \$5,500.00. Jason suggested that they be located neat the Veterans Pavilion. The Commission approved this project.
- 2. <u>Phyllis Marron</u> Ruth Scadding, past chairman of the Park & Recreation Commission, was present and spoke about Phyllis and her devotion to the parks. Her family, in lieu of flowers, is asking for donations to go to a project in the park. Donations should be made through the Friends of East Goshen.
- 3. <u>Ice Skating</u> A memo from Jon Altshul regarding ice skating on the ponds was reviewed. After the dredging, the Marydell Pond is now 8 feet deep and has an aerator in it which operates all the time. A resolution was provided to prohibit ice skating and similar activities on Township ponds. Ed made a motion to establish a rule expressly prohibiting ice skating or similar activities on Township-owned ponds and further, that we recommend the Board of Supervisors adopt a resolution affirming this new rule. Anne Marie seconded the motion. The motion passed unanimously.
- 4. <u>2020 Community Day and Food Truck Festival</u> Jason mentioned that the date for Community Day will be Saturday June 27, 2020 (rain date June 28). The Food Truck Festival will be held on Saturday August 29, 2020 (rain date August 30). The Commission members agreed that 2 beer vendors are needed and larger speakers.
