Re: EV Charging Stations

Date: July 16, 2020

Note: While the Board of Supervisors has the final say about whether or not to purchase EV charging stations, as a first step, staff seeks guidance from SAC on recommendations to the BOS. Any guidance that you provide will be communicated to the BOS for consideration at its 8/4/20 meeting.

In response to the Township's Clean Energy Transition Resolution and the subsequent discussion at the Long-Range Budget Planning Session on June 10, we received price quotes from National E Solutions for Chargepoint Electric Vehicle Charging Stations at the Township Building and the Park, as summarized below. These prices are for a station with two plugs that would fit all EV makes and models, plus electrical upgrades necessary to accommodate the stations. The prices are offered through Sourcewell, a national purchasing cooperative similar to COSTARS, and therefore don't require multiple price quotes. National E Solutions has worked on the Chargepoint EV stations at Uwchlan Township, West Goshen Township and West Chester Borough.

By comparison, Lenni quoted us a gross (pre-rebate) price of \$35,000-\$39,000 for this project at the Township Building last year. Importantly, the \$4,500 per plug rebate is expected to decrease by the end of the summer.

Included in the price is a 3-year warranty and service contract and a credit card reader.

Analysis of Fees

If the Board is interested in installing EV stations, it will need to determine what to charge for an EV charge. Note that in order to facilitate the transactions, Chargepoint takes a 10% commission off of all funds collected.

<u>Unfortunately, it does not appear that there would be a payback period for an electric vehicle charging station.</u>

According to our sales rep, a "typical" electric vehicle requires about 15 KwH per charge over three hours. Moreover, for perspective, in February (pre-shutdown), West Chester Borough's stations had 183 total charges, or about 550 hours of use. Meanwhile, Uwchlan Township (which is much more geographically isolated than Borough Hall, but also closer to the PA Turnpike) had a maximum of 18 charges per month pre-COVID, or approximately 54 hours per month. According to our sales rep, the rule of thumb is that public charging stations get 100 hours of use per month.

Uwchlan Township only charges for the cost of electricity (about \$0.10-\$0.12 per KwH, including generation, distribution and misc fees), while West Chester Borough charges a flat \$0.50 per hour. Therefore a "typical" charge would cost about \$1.65 at Uwchlan and \$1.50 at West Chester. Therefore, West Chester might expect about \$250 in revenues per month (after the 10% Chargepoint Commission), against about \$300 in electricity costs, while Uwchlan might expect about \$24 month in revenues.

The table below summarizes the net benefit or cost of an EV charging station assuming that we charged \$0.50/KwH, \$1.00/KwH or \$1.50/KwH, which is the highest that we've been advised to charge and have 100 hours of use per month. Note that these charges are very cost sensitive. They are publicized on the Chargepoint app, so if a driver has an option of paying \$0.50 cents per hour in West Chester versus, say, \$1.50 per hour in East Goshen, demand in East Goshen will fall sharply. Therefore, the assumptions about monthly usage in the table below should be viewed with some skepticism.

It is also important to note that the main users of EV charging stations are likely to be non-residents who need a recharge on the road between, say, New York City and Washington DC. Theoretically, Township residents would only use the station in the event that they need a faster charge than their home-based charging station could provide.

Included in the net price is a 3-year service contract for \$2,064. Therefore, at any price point we will never fully recoup our costs.

Next Steps for SAC

Township staff requests guidance from SAC about next steps including the station location, what fee to levy, and any other information that might assist the BOS in making a decision on this matter.

To Whom it May Concern:

The above referenced project has been reviewed by the Chester County Conservation District and found to be **adequate**.

The final approved Erosion and Sedimentation Pollution Control (E&SPC) plan must be available at the site of the earthmoving activity during construction until the site is permanently stabilized.

The District has reviewed this plan solely to determine whether it is adequate to satisfy the requirements of Chapter 102, Erosion and Sedimentation Control Rules and Regulations.

Should any measures proposed in this plan prove incapable of adequately removing sediment from on-site flows prior to discharge or prior to stabilization of the disturbed areas, or if accelerated erosion is caused downstream or downslope from the site, additional measures must be implemented by the developer to eliminate any and all such problems.

The Chester County Conservation District requires notification of at least 72 hours prior to the commencement of on-site earthmoving activities and will conduct periodic site inspections to determine compliance with Chapter 102 regulations.



Any changes, revisions, or modifications to the approved plans will require resubmission to the Chester County Conservation District for review and approval prior to the beginning of construction.

As we enter the second half of 2020, it is time to begin thinking about the Township's budget for 2021.

To that end, if your ABC has its own budget, attached please find an Excel worksheet with individual tabs for each of your ABCs showing a blank column for the 2020 budget request.

I would be grateful if you could provide me with:

- 1) 2021 budget requests for each line item
- 2) A <u>justification</u> for your 2021 budget request.

Needless to say, 2021 promises to be an exceptionally difficult year for all state and local governments nationwide. The COVID pandemic is having a substantially negative impact on a number of Township revenue streams. Moreover, as you know, the Township cut the ABC budgets in 2020, and we are still staring at an operating deficit of nearly \$500,000 this year, and 2021 could be even worse. Accordingly, the Board of Supervisors will be forced to make a number of stark choices in establishing its budget for next year, which is likely to affect all of our lines of business.

Therefore, my annual reminder about "needs" versus "wants" is even more important now. Remember your group's mission, goals and objectives. Then ask yourselves, what do you <u>need</u> in order to realize your objectives and what do you merely <u>want?</u> Expenditures that don't meet the "need" threshold are unlikely to receive BOS approval, especially for next year.

Note that the Township has many "ABC-related" expenditures. For example, the Township needs to maintain the Blacksmith Shop/Plank House. The Township also incurs legal costs related to the pipeline and consulting costs related to planning work, etc. These line items are separate from your ABC budget.

Please don't hesitate to contact me by phone or email over the summer.

As we plan to have preliminary budget materials prepared for discussions with the Board in early autumn, please return this completed worksheet to me by no later than Friday, September 25th. I will follow up with you if I have any questions.
