10 **Call to Order & Pledge of Allegiance**

11 Tom called the meeting to order at 7:00 pm and led the Pledge of Allegiance.

12 **Moment of Silence**

13 Tom called for a moment of silence for all first responders and especially the military.

14 **Approval of Minutes**

15 Brian made a motion to approve the minutes from August 20, 2020. Jeff seconded. The minutes  
16 were unanimously approved.

17 **Chairman's Report**

18 Tom confirmed that the next meeting is scheduled for October 15, 2020 @ 7:00 pm. Tom requested  
19 that members inform him of conflicts for future meetings.

21 **Old Business**

22 Tom reported that an ad hoc Business Park Task Force is under discussion to include members of  
23 the Planning Commission and the Futurist Committee.

25 Tom stated that he would work with Susan D'Amore to email out the Futurist's long-term vision  
26 statement for the Township to all ABC members to get their input.

28 Brian indicated that he was almost ready to begin surveying Business Park representatives about  
29 their concerns. There was agreement that Susan D'Amore could assist with mailing the survey, as  
30 needed.

32 Brandon and Jeff discussed the community survey, and how it could be done on Survey Monkey.  
33 They agreed to draft a memo for the next meeting to tee the matter up for the Board of Supervisors.

35 **New Business**

36 Members of the Futurist Committee were generally supportive of the idea of free public art  
37 installations along the trail, but agreed that the matter was best considered by the Parks and  
38 Recreation Commission.

40 **Public Comment**

41 Ms. Morley raised concerns about how input from the ABC members would be received about the  
42 Futurist's long-term vision statement for the Township. She also expressed concerns about the  
43 design methodology for the community survey.
