Because of the restrictions due to COVID-19, the meeting was held via Zoom virtual 7 conferencing. The meeting was called to order by Chairman Dan Leicht at 7:00 pm. 8 9 Commission members present are highlighted: **Daniel Leicht, Chairman** 10 Deborah Snyder, Vice Chairman 11 **Edward Covle** 12 **Ann Marie Fletcher-Moore** 13 Peter Knupp 14 Christine Taraborelli 15 Kishor Thakarar 16 Eric Tobin 17 Joseph Zulli 18 Others present were: 19 Jason Lang, Director of Recreation 20 John Hertzog, Supervisor 21 22 CALL TO ORDER/PLEDGE OF ALLEGIANCE 23 Dan led the Pledge of Allegiance. 24 Dan asked for a moment of silence to remember our military and veterans, police and first responders & 25 Kishor Thakarar and his family. 26 Dan asked if anyone would be recording the meeting. There was no response 27 28 APPROVAL OF MINUTES 29 1. The minutes of the September 3, 2020 meeting were approved. 30 31 **CHAIRMAN'S REPORT** 32 Dan commented that the East Goshen Park has been very busy every day. 33 34 35 **NEW BUSINESS** None 36 37 38 **OLD BUSINESS** Paoli Pike Trail Rules and Regulations – Jason reviewed the written rules and regulations he presented to the 39 Board of Supervisors. The BOS suggested that it be titled Trail Use Guidance and Etiquette instead of Rules and 40 Regulations. Joe questioned item B in the prohibited items. Is the Paoli Pike Trail 24/7 and the East 41 Goshen/Applebrook trails closed from Sunset to Sunrise? He and Jason will work on the wording for this item. 42 When the BOS approves them Jason will put them on the web site and social media. Jason reported that 43 construction should be done by Halloween. Then there will be various inspections. So, some time in November a 44 ribbon cutting could be held for this part and next Spring a grand opening for the entire trail. Joe brought up the 45 fact that the East Goshen Park trails are not maintained in the winter. Jason commented that as part of the grants 46 the Township will be responsible for maintaining the Paoli Pike Trail in the winter. 47 2. Review park facilities, programming and events status – Jason reported that he has been to the East Goshen Park 48 every day between 4 and 6 p.m. There are legos, story walks, flag football, baseball, walkers, dance recitals, fitness 49 and mental health groups. He noticed that people are being very respectful and keeping the required distance. 50 The Yard Sale had to be moved from Saturday to Sunday because of rain. There were 10 vendors in the park. 51 Peter reported that there were lots of cars stopping at his house. The map was great. 52 Applebrook Golf – Jason usually has about 60 people for this event. This year he sold out at 100 last week! 53 54 The Butterfly Garden – Jason wants to acknowledge the volunteers from Depuy-Synthes, a Johnson & Johnson

company. He may do a ribbon cutting at the garden.

- The Pumpkin Festival is canceled for this year. He will put out a notice. 1
- Halloween Jason mentioned that the BOS asked him to write a statement to encourage people but not make any 2 3 definite statement about dates and times.
- 3. Amphitheater Band Shell Jason measured the space at 55 ft wide by 35 ft deep. He got in touch with Kevin 4
- 5 Umbreit who helped design the playground. Jason provided 5 different designs and the costs for each. The Board
- members liked the Camden, Brandywine and Litchfield models the best. Providing shade at sunset and acoustics 6 7
 - were discussed. Jason feels he can get grant funding the same way he did for the playground.

- f. Neighbor to Neighbor Day will be held in November. They do the same 4-5 yards each year and the owners 19 are very grateful. 20
- g. Christmas Tree Lighting and Holiday Celebration Jason feels at this point that we can have this event. They 21
- will not be able to have the children sit on Santa's lap so he thinks he will have him come to the park on a firetruck 22
- and give out candy. The dance groups are interested in participating. 23

- a. Nancy Daversa, the Township Poet Laurate Jason wants to recognize her for all she did especially with the 25 escape room events. This is her last year in this position. 26
- b. Aarushi Jain Volunteered and has been helping with the planning of the Teen events for the past 4 years. The 27 Board members agreed that she should be the "Volunteer of the Year". 28
