Re: Partial Notice to Proceed with Construction for Phase I Construction Activities and Variance Approval

Dear Ms. Richman:

I grant Adelphia Gateway, LLC's (Adelphia) request for a partial notice to proceed filed on September 9, 2020. This approval is for commencement of construction of Adelphia's Phase 1 Project components, which include the following:

- Quakertown Compressor and Meter Station;
- Marcus Hook Compressor Station;
- Tilghman Lateral from Milepost 0.0 0.4, including ATWS-TL-01.1, ATWS-TL-01.2, ATWS-TL-02, and ATWS-TL-03a;
- Transco Meter Station;
- Skippack Tap Valve;
- New Mainline Valves 1 and 2; and
- Seven new blowdown assembly valves.

We also approve Adelphia's variance requests VAR-004, VAR-005, and VAR-006 filed on June 12, 2020, and variance requests VAR-007 and VAR-008 filed on September 8, 2020, as supplemented.<sup>1</sup>
