**NEW BUSINESS**

1. Paoli Pike Trail Fill – Jason explained that the dirt that was removed for the Paoli Pike Trail was stored in the parking lot at the Millcreek ballfield off Goshen Parkway. Some of the dirt will be used in Applebrook near the Chamber of Commerce. Jason mentioned that Pump Tracks are becoming popular. He described it as a dirt path with slight bumps for bikers to use. Malvern has one in their Master Plan. It is a family activity and any age can use it. The Township crew could do the work. However, Jason would want a professional to design it. It is typically ¼ acre. It could not be put in East Goshen Park. Applebrook can be considered. If it is kept in Millcreek, he would definitely want a designer to look at the area and determine if both the ballfield and the pump track would fit. It will take a few years. Also, when he spoke to Malvern their timeframe was 2-5 years. He may offer the dirt to them and in return, East Goshen residents would be allowed to use the Malvern pump track.

2. Acknowledge NRPA Gold Medal Finalist Award- Jason reviewed the virtual meeting where they gave these awards. They showed the videos that each municipality submitted. East Goshen is again the only finalist from PA. The plaque will be hung in the Township Building. They were given a banner which will be great to display at Township events. The Commission members all thanked Jason for all he has done for East Goshen and the residents.

**OLD BUSINESS**

1. Paoli Pike Trail Rules and Regulations – Jason commented that there will be 2 more weeks of inspections and then the trail will be open to the public. A full scale ribbon cutting will be done later. Jason made a video showing the do's and don't's and rules of the trail. He will also make a short video of the trail which will be available to the public.

2 However, with this beautiful weather we are having right now the park and playground are still very busy.  
3 3. Christmas Tree Lighting – This event is planned for Friday December 4, 2020. The dancers want to be involved  
4 on the stage. Carmen Battavio will be Santa and will arrive on a fire truck. The truck will park near the exit  
5 playing music so the kids can see Santa as their cars leave the park. Jason wants to live stream the event if possible.
