## From The Chairman...

Dear Friends, Neighbors and Fellow Residents:

On behalf of the Board of Supervisors and Township staff, I would like to wish you all a very happy holiday season! I hope that you are all able to spend time with your family and friends over the next few weeks while social distancing and taking steps to stay safe.

We had a virtual ribbon cutting to celebrate the formal opening of the segment of the **Paoli Pike Trail** that runs from Reservoir Road to Line Road. Our Township Staff reports that in addition to those that utilize the portion of the trail in Applebrook Park, they have also seen people utilizing the section between Reservoir Road and the Park. I would expect that usage will increase once spring rolls around. In addition, it is worth repeating again that the Board would like to extend its gratitude to

PennDOT, the Delaware Valley Regional Planning Commission, Chester County and the Pennsylvania Department of Conservation and Natural Resources for their funding of this project. Lastly, the Township would like to thank Communications Test Design, Inc. (CTDI) for their gifting of right of way easements along the trail. CTDI was founded in 1975 by Jerry Parsons, his father Don, and brother Dick, in the family's garage right here in East Goshen Township. The company now has nearly 14,000 employees in over 90 facilities worldwide, but still headquarters in East Goshen Township.

In November, the contractor began working at the Hershey Mill Dam. The contractor will breach the dam by year's end, and once that occurs, the potential for a failure of the dam is eliminated. While we did not have a groundbreaking for this project, we will be having some type of opening event once the park improvements have been completed in 2021.

### Letter From The Chairman...continued from cover

In mid-December, the Board approved the 2021 Budget, which lays out the normal revenues and expenses for the Township and the 2021-2025 Capital Improvement Plan, which lays out all the planned capital projects and funding sources over the next five years. The 2021 Budget was especially challenging this year given the impact COVID-19 had on our revenues for 2020 and the potential impact it could have on our revenues for 2021.

And, as you may have noticed, the Sunoco Mariner 2 and 2x project is winding down. The last remaining section of the pipeline to be installed is the section between Bow Tree Drive and Saints Simon and Jude Church in Westtown. Sunoco advises that they plan to pull back this section of pipe in mid-February and, once that is accomplished, the Bow Tree Drive work area will be restored. I believe most of our residents will be glad once the construction is over.

Speaking of Sunoco, in October the Board was made aware of a whistleblower complaint about a subsidence on the west side of North Chester Road, just south of Anne Drive. The whistleblower alleges that the subsidence was related to or caused by the Sunoco's drilling activities. As of this date, the PA Public Utility Commission and PennDOT are looking into the subsidence, and information about this matter is being posted on the website as it becomes available.

On the land use side, it should come as no surprise that COVID-19, has resulted in a significant increase in the number of people working from home. While this is good from some perspectives such as less traffic, it raises questions about the future of office buildings. Take for example a company that has 100 employees traditionally needing a building of sufficient size to provide office space for each employee. However, if many employees can work from home, that company can get by with a much smaller building. This is significant since the 1980's saw the development of many corporate parks for offices. Take a drive through these corporate parks today, and you see a lot fewer cars and a lot more for sale or rent signs. Since our corporate parks make up 10% of our land area and a significant percentage of our tax revenues, the Board has created a Business Park Task Force to look into the impact this phenomenon will have on our corporate parks and make a recommendation to the Board on how to address this issue. The Board has

### **Sewer/Refuse Discount Program**

In addition to state and federal programs that offer financial assistance to senior citizens and those with lower incomes, East Goshen Township offers a 5% discount on utility bills to residents who meet certain criteria. To be eligible for this discount, a resident must meet the requirements for any of the following programs and complete an East Goshen Township sewer and refuse discount program application by December 31, 2020:

- *Senior Citizen Property Tax or Rent Rebate Act (file a PA1000 with the State)*
- *Pharmaceutical Assistance Contract or the Elderly Act (PACE)*
- *Federal Food Stamp Act of 1977, as amended through 2030*
- *Women's, Infants and Children's Nutrition Improvement Act*
- *Aid to Families with Dependent Children*
- *Public Assistance Law*

**The Township may request proof of eligibility and the resident must agree to comply upon request.**

Residents already enrolled in this program must re-apply each year. Applications to enroll are available by contacting Chris Boylan at the Township 610-692-7171.

## WEGO Says “Goodbye” to One of Their Finest

After 33 years of working at the Westtown-East Goshen Regional Police Department, Detective / Lieutenant William Cahill will be retiring in January 2021. WEGO Police Department sat down with him to reflect on his extensive career and insight as an essential member of the department.

When did you know you wanted to go into law enforcement?

*As a senior at East High School, I met a couple officers at the West Goshen Township Police Department and became friends with them.*



Can you give a brief timeline of your career progression?

*In 1986, I attended the police academy at the Delaware County Police and was first hired by Avondale Borough Police. In 1987, I started at WEGO PD in the Patrol Division and started Detective work in 1990. In 2000, I was promoted to Detective/Corporal, in 2002 Detective/Sergeant, and in 2012 I was promoted to Detective/Lieutenant.*

Who would you say was your biggest influence in your career?

*In high school I met (then) Detective Michael O’Brien at West Goshen Police and he influenced me to consider attending the police academy. I was fortunate to do well in the academy and to be hired by WEGO PD. Mike was hired by the FBI as a Special Agent, and I continued at the local law enforcement level. After Mike retired from the FBI, I was assigned to the Federal Bureau of Investigation as a Task Force Officer in 2017.*

What has this field taught you the most?

*To not rush to judgment and to keep an open mind.*

How do you feel about retiring?

*It’s a strange feeling thinking that what you have done for 33 years will come to an end. I will miss working for one of the best law enforcement agencies in the US.*

What was your proudest accomplishment(s)?

*In 1987, we pulled a trapped motorist from his burning vehicle after we failed several times to get inside the car. In 1991, we responded to an accident involving a child*

*who was struck by a vehicle on Hummingbird Lane. Mike O’Brien and I arrived quickly and worked with EMS. The victim survived and we have been friends since. In 2000, I*

*investigated a very violent armed robbery of the Genuardi’s in East Goshen. Several employees were held inside the store by armed, masked criminals. With the assistance of several agencies, we identified and arrested the individuals who committed the crime. The most violent offender was able to elude law enforcement for 14 years and with the assistance of the FBI, we were able to apprehend William “Chew” Lewis in Fayetteville, North Carolina. Lewis was returned to Chester County and a jury convicted him 15 years after the crime occurred.*

What was your scariest moment?

*The scariest moment for me was 9/11/2001 when three members of WEGO PD traveled to New York City to assist with the terrorist attack. We were on the downed towers assisting with search attempts. It was dark. There were fires in different openings and the beams were slick from the fire department spraying water. It was the darkest day of my career.*

Can you describe how you have coped with being on as many cases as you have been on?



*I think I have coped by having activities outside of law enforcement. For several years, I worked with different NASCAR teams that allowed me to travel and work with great people. Spending*

*time with my family was a big part of my successful career and surviving difficult investigations and arrests. Police work can be stressful and you have to have a mechanism to clear your mind.*

Do you have a mantra you live by?

*“Performance Not Promise.”*

What will you do after you retire?

*I am hoping to remain in law enforcement and work as a detective for a local department or agency. I'm also considering entering the corporate security world.*

Is there anything else you would like to say to the community?

*In closing, I would like to thank the residents and business owners in Westtown, East Goshen and Thornbury Townships for the support given to the police department. We are lucky to live in a great part of the United States. This career has given me the opportunity to work with true professionals at the local, state and federal level. The law enforcement network is powerful because of the cooperation amongst agencies. I would also like to thank the elected officials who have trusted me over the years to protect our citizens.*

## Planned Ridley Creek Sewer Treatment Plant Upgrade

The Ridley Creek Sewer Treatment Plant (RCSTP) is East Goshen Township's sewer treatment plant. It was upgraded in 2008 to an average capacity of 750,000 gallons/day and a maximum peak capacity of 3,000,000 gallons/day, with a typical effluent of 300,000-400,000 gallons/day. With a full-time staff and oversight by the EG Public Works Department and the EG Municipal Authority (EGMA), it is important to maintain safe and efficient plant operations. This is a highly regulated environment and industry, and all of the components of the plant are continually monitored to maintain its effectiveness in meeting discharge limits set by the Pennsylvania Department of Environmental Protection and the United States Environmental Protection Agency.

As part of the normal operations of the RCSTP, caustic soda (strongly basic sodium hydroxide) is added to the sequencing batch reactors (SBRs) as part of the wastewater treatment. These SBRs are a major part of the process to remove ammonia and phosphorus, adjust pH, biologically aerate the wastewater, and eventually discharge the final effluent. Currently, large bags of caustic soda are manually carried up many steps and transferred into the top of the large SBRs, into the liquid suspension. This step is lacking in some safety considerations and does not allow a closer titration of the caustic soda needed at any time. Therefore, the EGMA is replacing the current caustic soda operation with a safer, more efficient caustic soda storage and feed configuration.

The new storage and chemical feed configuration will include a double-walled storage tank of 3000 gallons and four chemical feed pumps to convey the caustic soda solution (25% sodium hydroxide) directly into the separate SBRs at the plant. Providing the solution of caustic soda in a hands-off manner will be a safer alternative to the current process and also brings a cost savings to this component of plant operations. Construction of the storage tank, pumps and piping is not a simple matter and requires site location, structural, mechanical and electrical considerations. The EG Public Works Department will perform the construction with the EGMA Engineer, Pennoni Associates, assisting with the design and permitting of the project.



The total costs for the project are estimated at \$190,000. However, the EGMA has obtained a large \$152,980 grant from the Pennsylvania Department of Community and Economic Development to offset much of these costs. In summary, the EGMA will be able to upgrade the RCSTP plant in a more safe and efficient manner, and at a 80% discount with grant award. This new construction will commence in the spring of 2021.

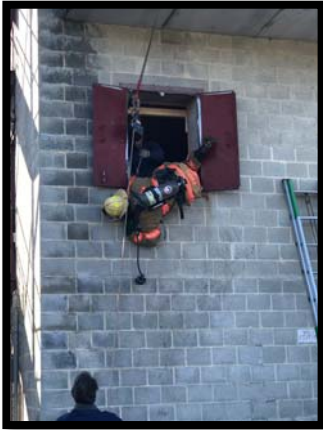

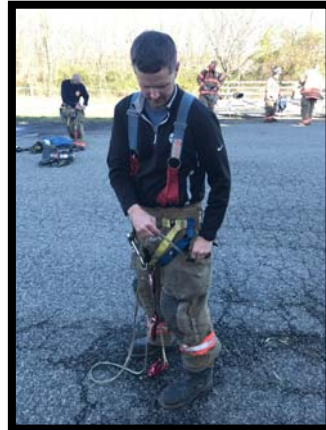
## GOSHEN FIRE COMPANY KEEPING US SAFE

We never stop training. Goshen recently purchased new “bailout kits” containing rope, hooks and a descender device that are compact enough to be carried in a firefighter’s pocket. In the event that a firefighter needs to make a rapid exit from a building window due to deteriorating conditions, this kit enables them to do so safely and quickly.

It has been another busy year for Goshen Fire Company. As of the end of November 2020, we responded to over 600 fire calls. These range from the most serious, like house fires, auto accidents and odor investigations to less serious such as false fire alarms. In your home, it is important that you use caution in the kitchen, and make sure that your alarm system is clean, serviced and in good working order. A false fire alarm could mean that we are delayed in responding to a serious incident.

Our ambulance crews responded to over 3,300 calls through November, averaging ten runs per day, making Goshen one of the busiest ambulance companies in Chester County. Our Fire Police Division has responded over 300 times this year, keeping first responders and you safe at fire scenes and auto accidents.

Last year we changed things up a bit; instead of driving Santa around on a fire truck, we invited you to an open house at Station 54 to get a photo with Santa. Due to pandemic restrictions, we can't have a party this year, so we will be bringing Santa to you on a fire truck. Watch our website and our Facebook page for dates and neighborhood locations. We will try to reach everyone, but in case we can't, we wish you a safe and happy holiday season.

Unfortunately, we have had to cancel all public events, including hall rentals, our Goshen Country Fair, breakfasts, flower sales and our annual fall Fire Prevention Open House. ## Always Looking Into The Future

At this time last year, a pandemic was certainly not on our radar of the important issues which would face East Goshen Township. We hope you and your loved ones are staying healthy during this stressful period. Despite the pandemic, however, there is still much happening in our community. We hope you are pleased with the way the Paoli Pike Trail is taking shape. The current phase of the Trail has taken more than five years to complete. Township staff are now seeking regional grants to complete the trail all the way to the YMCA and East High School.

Large projects like the Trail take time to plan, fund and implement. We are so fortunate to have leaders and volunteers with forethought who recognize this and who are willing to offer their time and expertise to advance Township amenities such as the Trail. These amenities make East Goshen Township more attractive to potential home buyers and increase the value of our homes.

Your Futurist Committee continues to seek means to make the Township even more desirable. The Paoli Pike Trail now connects some of East Goshen's key areas such as East Goshen Park, Goshenville Historic District, East Goshen Elementary School, Goshen Village Shopping Center, and East Goshen Business Park with a walking and biking artery. The Futurist Committee believes this area could be further improved with some proactive steps that would prevent haphazard and nonuniform development along our main corridor that could end up looking like

Route 30. The Planning Commission has recommended an Overlay Zoning District to address possible private redevelopment for the area between Boot Road and Route 352. This proposal could allow options such as outdoor dining and gathering spaces, specialty retail, and space for events such as art and craft exhibits.

Added street trees and landscaping could be as appealing as those we have in our neighborhoods, bringing beauty to this area. Efficient lighting would add a warm evening glow differentiating East Goshen Township from other communities along Paoli Pike. With careful planning we can maintain the bucolic setting of our township while embracing sustainable architectural innovation.

Amidst coping with a pandemic, it is exciting to think about the possibility of a future time when we can meet with our friends and neighbors in a village like area for a bite to eat, a cup of coffee, or just to meet in an attractive outdoor space.

## Your Sustainability Advisory Committee has been hard at work!

During COVID-19 quarantine, we have hosted seven online seminars with local and regional experts for your enjoyment and education. The first six are available to view on the [East Goshen Township Website](#). These include helpful information on green energy conversion, especially solar roof panels, purchase of electric and hybrid vehicles and charging capability, composting, and recycling suggestions.

The most recent seminar hosted by East Goshen's own gardening celebrity, Phillip Watson, includes a [10 minute video](#) of Phillip's garden with narration. We will have additional seasonal slides and videos narrated by Phillip in 2021. You won't want to miss these!

On October 19, your East Goshen SAC hosted [a webinar](#) moderated by Patti Lynn, Chester County's Recycling Coordinator. Patti explained what happens to your recyclables once they leave your curbside. She provided a pictorial overview of Chester County facility and explained all the unique materials accepted there for recycling – like scrap metal, Styrofoam blocks and fluorescent tubes. For

Some attendee questions she addressed:

Can hardback books be recycled?

*Remove the hard cover, then yes, they can.*

Do you put the lid back on a bottle before recycling?

*Not if the top is a different material - then just recycle the bottle. If the top is too small to recycle separately, as often happens, these need to be put in trash for now.*

Can pizza boxes be recycled?

*Not if they are greasy. Rip the top off, since that is usually grease-free, and recycle it.*

Should I bag my recyclables?

*No – recyclables need to be loose so they can go through the sorter.*

Can plastic shopping bags, bread bags, dry cleaning bags be recycled?

*Currently they can't be placed in your EGT recycling bin, BUT save them as most supermarkets have a container collecting all types of plastic bags, not just the ones they provide.*

Some general rules everyone can remember:

*Materials should be bigger than a credit card so they can be sorted properly. The recyclables must be rinsed out – relatively clean. Everything in the recycling bin should be loose, dry and empty. Cardboard and paper especially cannot be recycled if they are wet.*

We are working on a number of additional subjects for virtual seminars in 2021 as well. Please send us your suggestions for topics that interest you! Also, how many residents would welcome an opportunity to participate in community gardens, perhaps one for adults and one for children, with workshops helping you to successfully plant fruits and veggies. Who might be interested in community composting, exclusive of food waste? Let us know!

## EGT Park: Bedrock Therapy During a Period of Absolute Uncertainty



As you read this, the calendar year will be coming to a close, and I think all of us will be happy to see “2021” flash on our tv screens come New Year’s Eve. It has been a tough year and I hope everyone has weathered the pandemic as best as possible.



As a Parks and Recreation Director, what have I learned during 2020? You love your parks! Wow, simply wow. The parks are not just where you go to exercise or attend an egg hunt; your parks are so much more than that. Early in the pandemic, the park trails remained open with the rest of the park closed, and it was amazing to see how the trails helped keep the community

together. The act of walking, dog walking, getting fresh air and waving hi at a neighbor from a distance were bedrock therapies during a period of absolute uncertainty. The trails were always there, dawn to dusk, free to the public, accessible to all, our best asset. As COVID-19 restrictions relaxed over the summer months, park amenities like the playground and sports fields opened for use. I don’t have hard data on park attendance over these months, but parking was scarce all day, every day. East Goshen Park became our coffee shop, movie theater by smartphone, a “let’s sit on the boulders and chat” hang out spot, and the only place our kids could safely meet and socialize. I am proud that we were the only municipal camp program that remained open this summer. I have an amazing camp staff that almost to a person started their EGT Camp experience first as a camper. What does that produce? Buy in. Genuinely caring about the camp experience for every kid that hops out of a car. I would also be remiss not to thank our creative Public Works

Department, who helped us incorporate upgraded safety measures for camp.

Seeing how our park’s trails were used so frequently this year makes me especially happy to announce that the Paoli Pike Trail from Line Road to Reservoir Road is now open – go out and enjoy it! Efforts by elected officials, Township staff, planners, and above all, residents, have made the project such an overwhelming success! According to NRPA (National Recreation and Park Association) data, projects such as this receive on average 19.4% grant funding, and we are above 50%! The Paoli Pike Trail will positively affect our community in several ways. It will practically connect the land uses along Paoli Pike. No more watching high school students walk down Paoli Pike on their way to school. Picture extended Friday lunches where people from the Goshen Corporate Park walk over and support our local businesses like Patermo’s Pizza and the Oriental Pearl. It will encourage healthy lifestyles: envision leaving your house and walking to the YMCA for a quick swim with the kids! Just like the trails in the park this year, it will always be there, ready for you! But similar to owning a Porsche, sometimes you need to get off the mundane highway, take it to the racetrack, and open it up! The Paoli Pike Trail will be our Porsche, and I plan to open it up in 2021! I am envisioning events with artists lining the trail, Walk with a Doc programs, the yard sales coming home to the Township Building, First Fridays with music, and more! Spring isn’t here yet, but the Paoli Pike Trail is! It will be maintained throughout the winter, so I encourage everyone to bundle up and get moving!

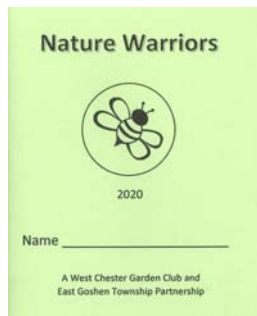

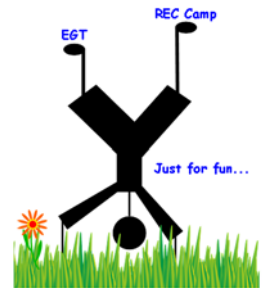

# Winter Weather and Snow Removal

## Pre-storm Preparedness Checklist:

- ✓ No on-street parking to allow efficient and safe plowing/salting
- ✓ Clear snow from any fire hydrants on or near your property
- ✓ Keep a safe distance from all plow trucks
- ✓ Avoid all unnecessary travel
- ✓ Have a 7-day supply of all medications
- ✓ Have 1 gallon of water per person per day on hand
- ✓ Have a 3-day supply of non-perishable food
- ✓ Have baby supplies, diapers, formula, etc.
- ✓ Flashlights and batteries
- ✓ Radio – battery operated
- ✓ Blankets
- ✓ Full tank of propane for grill
- ✓ Have your gas tank filled
- ✓ Have your pets inside; make sure they have a 7- day supply of food
- ✓ Have dry wood in a garage or covered for the fireplace or wood stove

## Snow Removal:

- \* We put a layer of brine on the road before the snow event starts; this prevents snow from bonding to the pavement and creating ice.
- \* Then we put a layer of salt down on the roads when the snow event starts.
- \* Once the snow starts to accumulate the plows begin to make one pass in and out of every street until the snow stops.
- \* When the snow stops we begin to clear the streets by pushing the snow to the curb.
- \* When clearing your driveway do not deposit the snow into the roadway; this can cause hazardous conditions for other motorists.
- \* Cul-de-sacs and storm drains are the final areas to be cleaned up after a storm.



## Important Information on Snow Removal

- \* Do not park on the street during a snow event.
- \* When shoveling your driveway leave the last six feet of your driveway un-shoveled until the plowing has ceased. This un-shoveled part will allow the snow being pushed by the plow to remain on the plow and not pushed into your driveway.
- \* The Township does not plow residential driveways.
- \* If an ambulance has been called to an address in the Township, we will help bring in the emergency vehicle.
- \* Please bear in mind that we cannot be everywhere at once. We will plow all roads in order of traffic priority, first the main roads then the secondary roads.
- \* Our snow plow drivers are asked to take precautions to avoid striking mailboxes with their plows, but snow can be extremely heavy and a cold brittle mail box can come down easily.



## Mailboxes:

- \* Expensive/ornate mailboxes should be replaced with a basic mailbox for the winter months
- \* Mailboxes should be located so the face of the box is 6 – 8 inches from the edge of the curb. This is according to USPS guidelines. We suggest putting them as far as 15 inches back from the road edge.
- \* Is your mailbox sturdy? Plastic mailboxes tend to become brittle from the sun's UV rays. Make sure the door on the mailbox is closed tightly. If the door is missing or open, the mailbox is sure to "fold" on impact of the snow.
- \* The East Goshen Township Board of Supervisors has passed a resolution that states that the Township will reimburse a resident \$25.00 for replacement or repair of a mailbox damaged during snow removal operation, provided the resident has advised the Township of said damages within one week of the snow removal operation. The Township does not repair any mailboxes.



## Medication Collection Box Now Available in Township Build-

A permanent medication collection box has been added to the East Goshen Township Building lobby. This convenient location is available to residents between the hours of 8:00 a.m. - 5:00 p.m., Monday through Friday. This box is in addition to the one located at the Westtown - East Goshen Regional Police Station at 1041 Wilmington Pike.

Medication collection boxes offer residents the opportunity to safely and anonymously dispose of unwanted and expired drugs and medications.
