The Hicks farm has a historic house on it. The Bed & Breakfast next to Goshen Elementary School has been sold to a family. The historic house at the Hershey Mill Dam is being rehabbed by a young couple with their first baby. Mark walked through the house with the owner. It is looking good. Putting old pictures

1 of the historic areas was discussed. Putting a kiosk at the area, or using QR codes so people can see
