



On the topic of the pipeline activity, we are expecting Sunoco's construction work on the Mariner pipelines to be complete this year. The segment between Bow Tree and Saints Simon and Jude in Westtown is the only segment under active boring activity in the Township. We have been advised by Sunoco that the pull back of the pipe for this segment is expected to occur this spring. Restoration of the Bow Tree and the other work areas in the Township should be well underway by summer. The Township and the Pipeline Task Force continue to monitor Sunoco's activity.

In exciting news, you probably noticed that the Hershey's Mill Dam project is moving forward. The dam was effectively breached in December, which fully addressed the Department of Environmental Protection's concern. When completed in September, the Hershey's Mill Dam Park will include a meandering waterway shaped by boulders, internal walking paths, meadows of native plantings and will truly be East Goshen Township's "postcard park"! We are also pleased to see the old mill being reclaimed adding to the charm and preservation of the historic character of that little corner of East Goshen.

Speaking of our parks, the Parks and Recreation Department is hard at work planning an exciting slate of activities this year. Staff is monitoring state COVID-19 protocols, but is confident that many of our standard community-wide events will be held in 2021 with modifications. Community Day will be on August 28 and we cannot wait to see the night sky lit up with the best fireworks display in Chester County! Our ever popular food truck festival will be moved to October 16 and will be themed as an Oktoberfest.

As we look at our current sustainability objectives, our Sustainability Advisory Committee realized that our recycling program may need a tweak. This spring, the Township will be purchasing a limited number of larger, lidded and wheeled recycling cans as a pilot program. Larger lidded cans may decrease our "kickback" rate for dirty recycling materials, saving the Township refuse expenses while also enabling residents to recycle larger quantities more efficiently.

This year will also mark transition for the Township as two staff members retire after many years of dutiful service. Gary Althouse, Building Inspector,

Payments can be placed in the drop box at the front of the building. If you would like a receipt, you must enclose a self-addressed stamped envelope with your payment or provide an email address.

As a reminder, in order to be eligible for the 2% discount on real estate tax bills, payment must be received by March 31, 2021.

Wastewater Collection System Capital Improvements

The East Goshen Municipal Authority (EGMA) wastewater collection system is a major asset comprised of approximately 64 miles of sanitary sewers and 4 pumping stations (PS) to convey wastewater to the Ridley Creek Sewage Treatment Plant (RCSTP) and the West Goshen Sewer Authority (WGSA) plant. Two pumping stations are located within the Township and discharge to the RCSTP – the Hershey Mill PS and the Hunt Country PS. The other two pump stations discharge into the WGSA conveyance system – the Ashbridge PS and the Barkway PS. A significant amount of flow, approximately 700,00 gallons per day (gpd), from the Township is conveyed to the WGSA plant via a large PS located on Westtown Way in West Goshen Township.

The East Goshen Township Public Works Department (PWD), directed by Mark Miller, provides the day-to-day operation and maintenance (O&M) of the system for the EGMA. You may have seen them installing temporary flow meters within the system to try to identify areas with extraneous flows. The data from this work then provides the basis for inspection. Inspection consists of systematically cleaning and televising the sewer system pipes in your neighborhood over the last few years. This preventative maintenance program identifies defects in the public sewer system as well as homeowner lateral connections. These issues may include broken sewer pipes, open pipe joints, and manhole defects. Structural defects are addressed through minor repairs, pipe replacement or pipe lining. Addressing these issues also removes these extraneous flows, known as Inflow & Infiltration (I&I), from ground water or streams that should not be conveyed to an STP for treatment. In 2020, the PWD completed approximately 20 miles of cleaning and televising, resulting in 16 significant repairs that removed 100,000 gpd of I & I..

Collection system improvements in 2021 will consist of: replacement of and repairs to the Hershey Mill Estates Trunk Sewer; construction of a permanent flow meter at Hibberd Lane near the Bellingham Retirement Community; and improvements to the Hunt Country PS.

The Hershey Mill Estates Trunk Sewer issue arose in December 2020 when a resident noted a sewer backup. This trunk sewer is 2,700 feet of 8-inch pipe from Tanglewood Drive to Greenhill Road that follows a stream valley. This sewer services Hershey Mill Estates, Fairway Village and Lockwood Chase residences. The pipes were immediately cleaned and televised. Identified problems in a significant portion of the sewer were structural issues of settlement and collapse, which resulted in clogging and backups. Permitting of the replacement started in January 2021 followed by environmental surveys and field surveys of the existing infrastructure in February 2021 by the EGMA Engineer, Pennoni Associates. Design, permitting and construction bid documents will be prepared with replacement construction planned to start by Fall 2021. PWD has kept Hershey Mill

Estates residents informed through an on-going outreach since the work will be adjacent to the backyards of many residents.

Improvements to the Hunt Country PS include: installation of a sewage grinder to protect the pumps from debris, a flow meter, and a bypass pump connection for emergencies.

Any questions regarding EGMA infrastructure or O&M can be directed to the members of the Municipal Authority. All are welcome at the monthly meetings on the second Monday of the month at 7:00 PM. Meetings are currently conducted through Zoom with residents able to phone into the meetings.

WEGO promotes Jonathan C. Stafford to Lieutenant

Recently, The Westtown East Goshen Regional Police Department promoted Jonathan C. Stafford to Lieutenant of our Criminal Investigation Division/Traffic Safety Unit. Here is an interview upon his promotion.

Can you give a brief timeline of your career progression?

I've served WEGO PD since 1999. I was promoted to full time in 2003 and served in the patrol division. In 2013, I was promoted to detective and worked in the Criminal Investigation Division. In 2016, I was promoted to Sergeant and worked in the Patrol Division again. This year, I was promoted to Lieutenant and I supervise the Criminal Investigation Division and Traffic Safety Unit. I am also the liaison with the Chester County Municipal Drug Task Force and the West Chester Emergency Response Team.

Where did you go to college?

I graduated from Immaculata University in 2002 with a Bachelor of Arts in Management. In 2008 I received my law degree from Temple University and I am a member of the bar in both PA and NJ. My legal education and experience helps me bring a greater understanding of legal issues in all aspects of police work.

What made you decide to pursue this industry?

I liked the idea of a job that gives you the opportunity to help the community while, at the same time, not being stuck behind a desk. Every day brings new challenges and is fast paced.

When did you initially get involved with a local fire department and how has your role there evolved?

I spent the past 27 years with the Good Will Fire Company, one of three stations that make up the West Chester Fire Department. I started as a junior fireman when I was 17 and worked my way up through the ranks. I served as Chief of the Department from 2018-2020.

What does your work-life balance look like as a husband and father?

It takes effort to find that balance. The nature of police work and, especially shift work, means missed holidays, birthdays, sporting events, etc. But my wife and kids do a great job of making things work and have been very understanding through the years.

What measures work best to promote a collaborative relationship between police departments and the communities they serve?

The best way to bring people together is through meaningful communication and education. Our citizen's police academy was one example of an opportunity to educate the public and help them understand the challenges faced by law enforcement. The entertainment industry portrays many unrealistic scenarios involving law enforcement. Without communication and education, perception becomes reality, and the public has unrealistic expectations that cannot be met.

What do you hope to accomplish as a Lieutenant in the department?

CID and TSU are two successful and well respected units, not only within the department, but also in the greater law enforcement community. I look forward to helping the officers progress and advance in their careers and to continue to enhance our ability to provide the best service to our community.

What are some long-term goals you have within law enforcement?

I continue to seek opportunities for professional development through training and education to help me succeed in my new role and allow me to assist those I serve. One thing about Law Enforcement is you never know what tomorrow will bring!



Pennsylvania's "Move Over" law updates take effect April 27



In 2020, Goshen Fire Company responded to 87 motor vehicle accidents with ambulances and fire apparatus. This number was down from 155 in 2019 with many people not travelling due to the pandemic. Many of these responses were on high speed multi lane roadways.

Nationally, 2 first responders are struck by vehicles every day! In 2020, 46 responders were killed nationwide, with 2 in Pennsylvania. (source: ResponderSafety.com)

On April 27, 2021, Pennsylvania's updated "Move Over" Law becomes effective with significant penalties. The law requires drivers approaching an emergency response area who are unable to safely merge into a lane further away from the response area, to slow to at least 20 mph less than the posted speed limit. An emergency response area is where an emergency vehicle has its lights flashing, or where road crews or emergency responders have lighted flares, posted signs, or

try to warn travelers.

So, what does this mean? If you are driving on a multilane road and there is an incident on the shoulder, you should MOVE OVER into a lane that allows a "buffer lane" between you and the incident. If you are unable to do this safely, you need to SLOW DOWN to a speed that is 20 MPH less than the posted speed. Penalties are steep...2 points, plus \$500 for the first offense, \$1000 for the second and \$2000 for the third plus a 90 day license suspension. Police officers will be aggressively enforcing this law.




A Message from State Senator John Kane

Healthy Yards, Healthy Creeks

Even though you may not live close to a creek, you live in a creek watershed. What you spray or spread on your lawn affects the quality of the creek's water and the plants and wildlife that depend on it. Rains commonly wash lawn care chemicals into streams and creeks and pollute them, particularly if these products are not properly used. Many synthetic pesticides (insect and weed killers) broadcast over lawns affect the soil as well. They harm the micro-organisms that give soil life, creating nutrients for plants and texture to improve the soil's ability to absorb and retain water. Pesticides applied to shrubs also may poison the food chain, harming beneficial insects, such as ladybugs, and the birds which feed on them.

Here are some tips for a thicker, healthier, more environmentally friendly lawn:

- ✓ Mow lawns high (at 3 inch height) to reduce the opportunity for weed seed germination.
- ✓ Healthy lawns need about 4 pounds of nitrogen per square foot over the growing season- more than that creates excessive, unhealthy growth and unnecessary runoff. By leaving mulched grass clippings on the lawn, you reduce this need by 25%.
- ✓ Check that you or your lawn care service are not exceeding this net requirement.
- ✓ Select a slow-acting (or slow release) fertilizer with a high percentage of Water Insoluble Nitrogen (WIN), and without any broadleaf weed killer listed on the label. Since WIN breaks down gradually in soil, rather than quickly dissolving in water, it is less likely to wash into creek waters.
- ✓ Hand pull or spot spray emerging weeds with products specific for that problem.
- ✓ To be sure you are giving your yard the nutrients it needs and not providing too much fertilizer, test your soil. Contact your local Penn State Extension office to order a soil test kit for only \$9 (Chester County 610 696 3500). Delaware County 610 696 3500.

Your **Sustainability Advisory Committee** has been hard at work!

Looking forward to springtime! Your <u>Sustainability</u> <u>Advisory Committee</u> is here to help you plan for a green and healthy spring.

We have four webinars currently in the planning stage. Two of these have definite dates already. The first of these is on March 31 at 7 PM. This will be led by Patti Lynne, Chester County's Recycling Coordinator. She has a new presentation titled "How Do I Get Rid Of.....?" This seminar will include valuable information on how to recycle hazardous waste and e-waste.

This seminar is a follow-up to the one she gave last year, so we suggest viewing that <u>presentation</u> in advance of attending this one on March 31. You can register for this free seminar through email by writing us at <u>sac@eastgoshen.org</u>.

We also have a seminar scheduled for Monday, April 12 at 7 PM. This will be led by Lauren McGrath from Willistown Conservancy Trust. Lauren will cover the importance of reducing our collective dependence on pesticides and fertilizers, with suggestions for chemical-free alternatives. She will explain how vital it is to protect our streams and waterways, as well as our pets, wildlife, and fish, who drink and dwell within them. We will also hear suggestions about converting at least part of our green lawns into natural meadows, and fruit and vegetable gardens.

Our new Gardener Laureate, <u>Phillip Watson</u>, will soon be offering a webinar as well. In addition, he will begin a monthly blog to help us better plan for beautiful landscapes and plantings from a sustainable perspective.

On the recycling front, we have ordered <u>3 special</u> <u>bins that will enable you to place plastic film</u> such as bread wrappers, used (and clean) baggies, newspaper plastic sleeves, cereal box liners, and a variety of

plastic bags that cannot be presently placed in your individual Township recycling bins. We will let you know where these will be located.

In addition, we are hoping to make a small number of new recycling bins with lids available to residents in a pilot program. With lids preventing rain and snow from soiling contents, we can eventually recycle more plastic film items in our recycling bins themselves.

Recycling is always important. However, it is considered the last stage of a truly sustainable lifestyle. The primary goal is to keep our purchases in line with what is essential. The secondary goal is to reguse as many items as possible that we already have, and to re-purpose them when we cannot reuse them in their original form. We can also look for ways to share and exchange items with intrinsic value that we no longer need. And finally to recycle everything that is left!

A number of communities in Chester County and across our nation have achieved recognition as official <u>Tree Cities</u>. We hope to join them this year! Sustainability Advisory Committee

Mariner East 101: What You Should Know

Pipelines marked with a yellow marker transport highly flammable materials.

A fire or explosion can result if a spark comes in contact with the product. A spark can come from electronics such as phones, doorbells, computers, a light switch, a furnace, a water heater, a car as well as many other things.

The material transported through these pipelines is under higher pressure than natural gas lines and at a low temperature so it stays a liquid in the pipe, but will convert to gas if exposed to air.



As the low temperature liquid escapes through a leak, it turns into a gas and can cause moisture in the air to condense and form fog. (Dry ice used in Halloween displays work the same way.)

If the pipe has a small leak, the high pressure may cause it to make a hissing sound.

Some products in other pipelines have a fragrance added so you can smell a leak. Mariner East is not odorized like natural gas lines.

The low temperatures can cause frostbite and frozen vegetation may turn black.

It is dangerous to breathe in the product when it is in the form of a gas.

Because a gas leak will stay low to the ground, small children and pets are more likely to breathe in the gas.

If you think you are seeing or hearing a leak, move away and call 911 from a safe place.

ALWAYS call 811 before you dig so pipes or wires in the ground are not damaged when you plant a tree or install a fence or mailbox post or do other digging on your property.




