Walter mentioned that there will be no meeting in July. The August 11th meeting will be 33 via Zoom. John mentioned that the BOS is having 1 zoom meeting and 1 in person meeting 34 each month starting in June. The CB decided to go to in person in September. 35 36 Old Business 37 1. Clymer's Woods – Walter commented that he, Erich, Sandy and Eunice met at Clymers 38 Woods. Two trees were marked with pink ribbon to be removed. They put some mulch on 39 trees that needed it. The mulch is needed to keep the weed whackers from hitting the tree 40 bark. They also noticed that the wire fence at the bridge which supports the under growth 41 needs to be pushed back into place. Mark will let Mark Miller know. 42 2. Fall Planting – Walter had three suggestions: 43 a. Replace the two dead trees in Clymers Woods. Dogwoods were suggested. 44 b. Hibberd La. to the creek along the walking trail. This would be about 10 trees. 45 They would want 2 - 3 different types of trees. The budget has \$3,000, 00 for this. c. Help with Marydell pond restoration. Mark mentioned that Marydell already has 46 a plan which will be implemented when the materials are received. Mark Miller has this 47 48 planned for fall. 49 3. Tree City USA application - Walter mentioned that he spoke with Christie from the 50 Sustainability Committee. She suggested setting up a sub-committee for this. However, 51 Walter went on the website for the Tree City USA and found these requirements:

Date: July 7, 2021

As we enter the second half of 2021, it is time to begin thinking about the Township's budget for 2022.

To that end, attached please find an Excel worksheet with individual tabs for each of your ABCs budgets showing:

- 2021 Annual Budget
- 2021 year-to-date actual expenditures through June
- 2021 Projection (which in total matches 2021 Annual Budget)
- A blank column for the 2022 annual budget request
- Justification section for comments as to 'why' this amount, if it causes 2022 to be greater than the 2021 Annual Budget; feel free to re-adjust line items, we're more concerned with the total

I would be grateful if you could provide me with (for your ABC only):

- 1) 2022 budget requests for each line item
- 2) A justification for your 2022 budget request for any line item for which you are requesting more budget authority in 2022 than you received in 2021.

Note that the Township has many "ABC-related" expenditures. For example, the Township needs to maintain the Blacksmith Shop/Plank House. The Township also incurs legal costs related to the pipeline and consulting costs related to planning work, etc. These line items are separate from your ABC budget; however, to the extent that your ABC intends to make upcoming recommendations to the Board of Supervisors that could result in the expenditure of Township funds beyond current levels, please let me know as soon as possible!

As always, 2022 will be a tight budget year. Preliminary forecasts suggest that the Township will need to continue to deplete its general fund balance in order to achieve a balanced budget. Thus, all Township departments and ABC groups will be under pressure to identify cost savings.

When developing your budget request, remember your group's mission, goals and objectives. Then ask yourselves, what do you need in order to realize your objectives and what do you merely want? Expenditures that don't meet the "need" threshold are unlikely to receive BOS approval.

Please don't hesitate to contact me by phone or email over the summer.

As we plan to have preliminary budget materials prepared for discussions with the Board in September workshops, please return this completed worksheet to me by no later than Friday, August 27th. I will follow up with you if I have any questions.
