 - a. C. Supple discussed the fall SAC newsletter article. Suggestions from SAC will be made in time for submission. C. Supple discussed SAC's table at Community Day. Starts at 4pm, K. Happ is going to set up the table. Material will cover what you can, can't recycle. Topic of a single use plastic bag survey was discussed to better understand residential interest in associated ordinance modifications. SAC will collect emails and raffle off free bags.

8. Old Business
 - a. Update on success of Trex recycle bins for plastic bags and film - Mary K.
 - a. M. Krueger reported that the recycling bins in the park have been an overwhelming success. However, it is not sustainable if only two people are monitoring. May need to discontinue if unable to recruit more collection volunteers. Can pivot to an educational campaign for nearby bag recycling locations.
 - b. Update on seminars - Christi (Willistown Conservation; Dr. Vile on health problems caused by plastic pollution)
 - a. C. Supple reported that planning is underway for:
 - i. Early October seminar (fall native plantings)
 - ii. Health issues caused by plastics
 - iii. birding
 - c. Update on Survey for residents for Sustainable Storefronts project - Jason
 - d. Further discussion on Energy Expo project – Kipp
 - a. K. Happ discussed a 2022 Energy Expo in the Township Bldg. Would utilize the entire upstairs and include breakout sessions. T. Kilburn remarked that maybe calling it a sustainability expo would fit better. A \$500 budget was proposed to pay for the expo.

 - a. C. Supple discussed creating enough content so SAC could post daily on Twitter. J. Lang noted that a minimum of five social media hits per platform are recommended, and so the Township could easily send one SAC tweet per day.
