21	<u>Call to Order</u>
22	Mary called the meeting to order at 7:00 pm.

24	<u>Pledge of Allegiance and Moment of Silence</u>
25	Mary led the Pledge of Allegiance. She asked for a moment of silence for our military, all COVID
26	patients and others trying to get the vaccine shots.

28	<u>Minutes</u>
29	The minutes of the April 8, 2021 meeting were approved.
30	
31	<u>New Business</u>
32	<u> 1. Goshen Monthly Meeting request for Historical Marker -</u> Mark introduced Mr. John Embick,
33	attorney for the Goshen Meeting. They are requesting a bench and historical marker.
34	Mr. Embick mentioned that the Quakers have been here for over 300 years. He is an environmental
35	attorney in West Chester and is volunteering for the Friends. They want a marker to give people
36	information about the Quakers and the Friends Meeting House. He provided a map to show where
37	they would like to put the sign and bench, on the southeast side of the intersection of Paoli Pike and
38	N. Chester Road (Rte. 352)along the Paoli Pike Trail. Also, they would like input from the
39	Commission about the wording on the sign. He spoke about the historical events that happened in
40 41	this area. He lives in Westtown but uses the Paoli Pike Trail and East Goshen Park. He provided
41 42	pictures of the area where they would like to place the bench and sign. The school was established in 1950. They would like a wooden bench with a dedication plaque.
43	John Hertzog asked about the sign ordinance. Mark explained that they don't need a permit for this
43 44	type of sign, only approval by the Board of Supervisors. He mentioned the other signs in this
45	historic area which are made of fiberboard and last about 20 years. Mary commented that a
46	wooden bench won't last long. John Embick commented that they prefer wood and understand it
47	will have to be replaced. The placement of the bench and type of sign were discussed.
48	Ted made a motion that the Goshen Monthly Meeting develop the design and finalize a location for
49	the sign and bench and return to the Historical Commission for final review and recommendation
50	to the Board of Supervisors. Kelly seconded the motion. The motion passed unanimously.

- 15 <u>Malvern Institute</u> Mark explained that under the Historic Preservation Ordinance any Land
- 16 Development plan within 200 feet of a historical resource needs to have a Historical Resource
- 17 Impact Study (HRIS) done. Malvern Institute is requesting a waiver from this requirement. This is
- 18 a class 2 building and had modification done in the past. In1982 the addition was done, and they
- 19 want to put a second story on the addition. He reviewed the plans with the Commission members.
- 20 Kelly disagrees with the request for a waiver. Kelly made a motion that the Historical Commission
- 21 recommend denial of the waiver request for the Malvern Institute Land Development application.
- Mary seconded the motion. The motion passed unanimously.

- 26 2. Mark reported that in this last storm from Hurricane Ida, Mark Miller and the Public Works staff
