6. Chairman's Report

C. Supple discussed the Ready 100 proposal that would be in conjunction with PECO, schools, the Township and additional community stakeholders. A. Lenthe added that this would require a Memo from the Board of Supervisors and an energy plan must be done. B. Hutchison asked if it made sense to go through the process if the Board of Supervisors wouldn't ultimately vote to move forward with it. K. Happ remarked that being able to show the Board a study that directly shows that without these changes, weather patterns will get worse over time.

- A. Trex bin project: update on bench work available in house through Mark Miller
 - a. J. Lang showed SAC members the bench that had just come in. It will be a welcome addition to the park, located somewhere with high foot traffic. M. Krueger mentioned that we should have a sign on it about the recycling campaign. J. Lang will talk to Public Works about making a sign in house.
